SECOND READING OF CONSENT CALENDAR ITEMS

SB 179 revise provisions related to the South Dakota Science and Technology Authority. (Introduced)
SB 188 add a provision regarding the use of a designated refrigerant. (Introduced)
SB 103 create a pilot program in the Unified Judicial System for risk and lethality assessments for certain persons accused of assault or protection order violations. (Introduced)
SB 180 address requirements for the execution of a living will. (Introduced)
HB 1041 provide an exception to the definition of drug paraphernalia. (Introduced)
HB 1101 ensure the proper labeling of American Indian arts and crafts. (Introduced)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

SB 90 (Deferred from 20th LD) provide certain definitions related to the crime of rape. (Introduced)
SB 91 (Deferred from 21st LD) revise certain provisions regarding the crime of rape and provide a penalty therefor. (Senate Judiciary Engrossed) (PJPCE)
SB 142 (Deferred from 21st LD) prohibit certain persons from using the title veterinary technician. (Senate Agriculture and Natural Resources Engrossed)
SB 143 (Deferred from 21st LD) raise the revenue threshold for a required audit of a water development district. (Introduced)
SB 144 (Deferred from 21st LD) provide access to abandoned cemeteries to descendants of the decedents interred therein. (Introduced)

- SB 76 (Deferred from 21st LD) provide for licensure by endorsement for certain licensed professionals and occupations. (Introduced)
- SB 175 (Deferred from 21st LD) modify practice criteria for physician assistants. (Introduced)
- SJR 502 (Deferred from 21st LD) Proposing and submitting to the voters at the next general election amendments to the Constitution of the State of South Dakota revising and establishing certain constitutional provisions regarding the lieutenant governor and the presiding officers of the Senate and House of Representatives. (Introduced)
- SB 139 revise residency requirements for the purposes of voter registration. (Senate State Affairs Engrossed)
- SB 160 establish post-election audits. (Senate State Affairs Engrossed) (Fiscal Note)
- SB 207 provide a penalty for the expenditure of public funds to influence the outcome of an election. (Senate State Affairs Engrossed)
- SB 200 (Removed from Consent) authorize participation in contracts by certain board members and employees of water districts. (Introduced)
- SB 19 make an appropriation for the payment of extraordinary litigation expenses and to declare an emergency. (Introduced)
