6 13-3-51.2. No elementary school or secondary school-student shall be required to
 7 submit to may administer a survey, analysis, or evaluation-that reveals information
 8 concerning without the prior written consent of the parent, or without the prior consent of
 9 the student if the student is an adult or emancipated minor, if the survey, analysis, or
 10 evaluation:

- 12 (2) Collects any information concerning:
- 13 (a) Political affiliations or beliefs of the student or the student's parent;
- 14 (2)(b) Mental or psychological problems or aspects of the student or the student's

 - (3)(c) Sex behavior or attitudes of the student or the student's family;
- 17 (4)(d) Illegal, anti-social, self-incriminating, or demeaning behavior;
- 18 (5)(e) Critical appraisals of other individuals with whom respondents have close

- 20 (6)(f) Legally recognized privileged or analogous relationships, such as those of

- 22 (7)(g) Religious practices, affiliations, or beliefs of the student or student's parent;
