On page 1, line 12, of the Senate Engrossed bill, after "misdemeanor." delete "Section 2. That chapter 36-12 be amended with a NEW SECTION:"

On page 1, line 13, of the Senate Engrossed bill, after "SECTION:" delete "Prior to July 1, 2025, a person who is not registered as a veterinary technician by the State Board of

Veterinary Medical Examiners may not assume or use the title veterinary technician unless the person:

- (1) Has successfully completed a veterinary technician course of study approved by the board; and
- (2) Submits a notarized document to the board from the person's employing veterinarian certifying that the person:
 - (a) Has at least five years of practical experience working under the supervision of the veterinarian; and
 - (b) Has agreed to become registered as a veterinary technician under chapter 36-12 by July 1, 2025.

A veterinarian may advertise or otherwise represent an employee as a veterinary technician who satisfies the requirements of this section."

On page 2, line 1, of the Senate Engrossed bill, after "2. " insert "If a person does not otherwise meet the qualifications to be a registered veterinary technician, as set forth by the State Board of Veterinary Medical Examiners on July 1, 2023, the board may register the person as a veterinary technician if the person's employing veterinarian applies to the board in accordance with § 36-12-21. 3 no later than June 30, 2027. A person registered under this section is subject to the annual renewal requirements in § 36-12-21. 5."
