SECOND READING OF CONSENT CALENDAR ITEMS

- SB 159 revise provisions regarding vehicle warranty claims. (Senate Commerce and Energy Engrossed)
SB 151 clarify information related to students that is not subject to survey, analysis, or evaluation without consent. (Senate Education Engrossed)
HB 1046 to provide free tuition at Board of Technical Education institutions for children or spouses of members of the South Dakota National Guard disabled or deceased in the line of duty. (Introduced)
HB 1210 modify the use of conservation district special revenue fund monies and to provide an appropriation therefor. (House Engrossed)
HB 1145 revise the order of precedence for the right to control the disposition of the remains of a deceased person. (Introduced)
HB 1184 revise provisions related to the One-Call Notification Board. (Introduced)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 201 provide treatment for the ingestion of controlled substances. (Senate Health and Human Services Engrossed)

- SB 205 reduce the penalty for unlawful possession of a cannabis product and provide exceptions. (Senate Health and Human Services Engrossed)
- SB 168 authorize a board of a school district to adopt policies regarding students who are registered sex offenders, and to declare an emergency. (Senate Education Engrossed)
- SB 152 provide increased funding for the water and environment fund. (Senate Agriculture and Natural Resources Engrossed)
- SB 89 increase the daily maximum award for the alternative care program administered by the Unified Judicial System. (Introduced)
- SB 149 create the Medicaid expansion fund and to transfer monies received as a result of expanding Medicaid eligibility. (Introduced)
- SB 118 expand eligibility for certain teachers who receive reduced tuition at Board of Regents institutions. (Senate Appropriations Engrossed)
- SB 191 (Deferred from 26th LD) establish the task force to address the welfare of Indian children in South Dakota. (Introduced)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1029 revise certain provisions regarding the county zoning and appeals process. (Introduced)
- HB 1109 modify the occupation tax for business improvement districts. (Introduced)
- HB 1042 (Deferred from 26th LD) update additional charges allowed for mailing decals and plates and to declare an emergency. (House Transportation Engrossed)
- HB 1090 (Deferred from 26th LD) modify protections for agricultural operations from nuisance claims. (House Agriculture and Natural Resources Engrossed)
- HB 1121 (Removed from Consent) expand the definition of a pesticide dealer. (Introduced)
