MOTIONS AND RESOLUTIONS

Senate Page Resolution 4

- SB 139 (Concur in House Amendments) revise residency requirements for the purposes of voter registration. (House Engrossed)
- SB 146 (Concur in House Amendments) limit parole for violent offenders. (House Judiciary Engrossed) (PJPCE)
- SB 4 (Concur in House Amendments) modify a court's authority to commit a habitual juvenile offender to the Department of Corrections. (House Judiciary Engrossed)

CONSIDERATION OF REPORTS OF COMMITTEES (AMENDED BILLS)

HB 1106, HB 1137, HB 1174 (Consent Calendar)

SECOND READING OF CONSENT CALENDAR ITEMS

- HB 1053 prohibit the issuance of a written certification to a pregnant woman or breastfeeding mother for purposes of medical cannabis use. (House Engrossed)
- HB 1059 establish a community paramedic endorsement. (House Health and Human Services Engrossed)
- HB 1220 provide that a female who undergoes an unlawful abortion may not be held criminally liable. (House Judiciary Engrossed)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1065 increase the maximum amount of dollars payable by the state to erect the headstone of a deceased veteran. (Introduced) (Fiscal Note)
- HB 1226 regulate industrial hemp-derived delta-8 and delta-10 tetrahydrocannabinol products, and other hemp-derived psychoactive compounds, and to declare an emergency. (House State Affairs Engrossed) (Fiscal Note)
- HB 1176 (Deferred from 32nd LD) revise certain provisions regarding on-sale alcoholic beverage licenses for use at municipality-owned facilities. (Senate Local Government Engrossed)

- HB 1167 annually adjust the rate for community-based providers to one hundred percent of methodology. (Introduced)

- HB 1094 make an appropriation to increase the success of South Dakota and to declare an emergency. (Introduced)
- HB 1141 provide property tax relief for owner-occupied single-family dwellings. (Senate State Affairs Engrossed)
- HB 1142 improve education outcomes and college affordability. (Introduced)
- HB 1144 bolster the workforce of South Dakota. (Introduced)
