### MOTIONS AND RESOLUTIONS

- SB 1 (Consideration of House Amendments) modify debilitating medical conditions for medical cannabis use. (House Health and Human Services Engrossed)
- SB 91 (Consideration of House Amendments) revise certain provisions regarding the crime of rape and provide a penalty therefor. (House Engrossed) (PJPCE)
- SB 105 (Consideration of House Amendments) require updated cost report information for certain community-based health and human services providers. (House Appropriations Engrossed)
- SB 113 (Consideration of House Amendments) establish and modify provisions related to initiated petitions. (House State Affairs Engrossed)
- SB 118 (Consideration of House Amendments) expand eligibility for certain teachers who receive reduced tuition at Board of Regents institutions. (House Engrossed)
- SB 134 (Consideration of House Amendments) revise membership of the Medical Marijuana Oversight Committee. (House Health and Human Services Engrossed)
- SB 149 (Consideration of House Amendments) create the Medicaid expansion fund and to transfer monies received as a result of expanding Medicaid eligibility. (House Appropriations Engrossed)
- SB 156 (Consideration of House Amendments) make an appropriation of American Rescue Plan Act monies for eligible water projects and to declare an emergency. (House Engrossed)
- SB 174 (Consideration of House Amendments) prohibit the enactment or implementation of an ordinance, resolution, or policy that prohibits the use of an energy utility service. (House Commerce and Energy Engrossed)
- SB 16 (Consideration of House Amendments) make an appropriation to rehabilitate the rail line from the city of Milbank to the city of Sisseton and to declare an emergency. (House Engrossed)
- SB 104 (Consideration of House Amendments) reduce certain gross receipts tax rates and a use tax rate, and to repeal a conditional reduction of certain gross receipts tax rates. (House Engrossed)
