AMENDMENT 1045B FOR THE INTRODUCED BILL

# An Act to revise provisions relating to the possession, manufacture, and distribution of child pornography.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

# 4 Section 1. That § 22-24A-3 be REPEALED:

#### 5 A person is guilty of possessing, manufacturing, or distributing child pornography 6 if the person: 7 (1) Creates any visual depiction of a minor engaging in a prohibited sexual act, or in 8 the simulation of such an act; 9 Causes or knowingly permits the creation of any visual depiction of a minor (2)10 engaged in a prohibited sexual act, or in the simulation of such an act; or 11 (3) Knowingly possesses, distributes, or otherwise disseminates any visual depiction 12 of a minor engaging in a prohibited sexual act, or in the simulation of such an act. 13 Consent to performing these proscribed acts by a minor or a minor's parent, 14 quardian, or custodian, or mistake as to the minor's age is not a defense to a charge of 15 violating this section. 16 A violation of this section is a Class 4 felony. If a person is convicted of a second 17 or subsequent violation of this section within fifteen years of the prior conviction, the 18 violation is a Class 3 felony. 19 The court shall order an assessment pursuant to § 22-22-1.3 of any person 20 convicted of violating this section. Section 2. That chapter 22-24A be amended with a NEW SECTION: 21 22 A person is quilty of manufacturing child pornography if the person: 23 (1)Creates any visual depiction of a minor engaging in a prohibited sexual act, or in 24 the simulation of such an act; or

subsequent violation of this section within fifteen years of a prior conviction is a Cla	
elony, and the court may not sentence the person to a term of imprisonment of less	than
seven and one-half five years. The court may not suspend this sentence.

ction 6. That chapter 22-24A be amended with a NEW SECTION:	

<u>Consent to performing the proscribed acts by a minor or a minor's parent,</u>
<u>guardian, or custodian, or mistake as to the minor's age is not a defense to a charge of</u>
<u>violating sections 2 to 4, inclusive, of this Act.</u>

### 4 Section 7. That § 22-6-11 be AMENDED:

5 **22-6-11.** The sentencing court shall sentence an offender convicted of a Class 5 6 or Class 6 felony, except those convicted under §§ 22-11A-2.1, 22-14-15, 22-18-1, 22-7 18-1.05, 22-18-26, 22-18-29, 22-19A-1, 22-19A-2, 22-19A-3, 22-19A-7, 22-19A-16, 22-8 22A-2, 22-22A-4, 22-24A-3, 22-22-24.3, subdivision 22-23-2(2), 22-24-1.2, 22-24B-2, 9 22-24B-12, 22-24B-12.1, 22-24B-23, 22-30A-46, 22-42-7, subdivision 24-2-14(1), 32-10 34-5, and any person ineligible for probation under § 23A-27-12, to a term of probation. 11 If the offender is under the supervision of the Department of Corrections, the court-shall 12 must order a fully suspended state incarceration sentence pursuant to § 23A-27-18.4. The 13 sentencing court may impose a sentence other than probation or a fully suspended state 14 incarceration sentence if the court finds aggravating circumstances exist that pose a significant risk to the public and require a departure from presumptive probation under 15 16 this section. If a departure is made, the judge shall must state on the record at the time 17 of sentencing the aggravating circumstances and the same shall be stated on the record at the time of sentencing and in the dispositional order. Neither this section nor its 18 application may be the basis for establishing a constitutionally protected liberty, property, 19 20 or due process interest.

## 21 Section 8. That § 22-24-1.2 be AMENDED:

22-24-1.2. A person commits the crime of indecent exposure if, with the intent to 22 23 arouse or gratify the sexual desire of any person, the person exposes his or her genitals 24 in a public place, or in the view of a public place, under circumstances in which that person 25 knows that person's conduct is likely to annoy, offend, or alarm another person. A violation 26 of this section is a Class 1 misdemeanor. However, if such the person has been previously 27 convicted of a felony violation of § 22-22-1, 22-22-7, or 22-24A-3 sections 2 to 4, 28 inclusive, of this Act, that person is quilty of a Class 6 felony. Any person convicted of a 29 third or subsequent violation of this section is quilty of a Class 6 felony.

## 30 Section 9. That § 22-24A-20 be AMENDED:

20	(9)	Promotion of prostitution of a minor as set forth in subdivision 22-23-2(2);			
21	(10)	Criminal pedophilia as previously set forth in § 22-22-30.1;			
22	(11)	Felony indecent exposure as previously set forth in former § 22-24-1 or felony			
23		indecent exposure as set forth in § 22-24-1.2;			
24	(12)	Solicitation of a minor as set forth in § 22-24A-5;			
25	(13)	Felony indecent exposure as set forth in § 22-24-1.3;			
26	(14)	Bestiality as set forth in § 22-22-42;			
27	(15)	An attempt, conspiracy, or solicitation to commit any of the crimes listed in this

29	(16)	Any crime, court martial offense, or tribal offense committed in a place other than			
30		this state that constitutes a sex crime under this section if committed in this state;			
31	(17)	Any federal crime, court martial offense, or tribal offense that constitutes a sex

4		(b) Any sexual contact by a psychotherapist as set forth in § 22-22-28; or
5		(c) Any sexual penetration by a psychotherapist as set forth in § 22-22-29;
6	(20)	Intentional exposure to HIV infection as set forth in subdivision (1) of § 22-18-31;
7	(21)	First degree human trafficking as set forth in § 22-49-2 if the victim is a minor;
8	(22)	Second degree human trafficking as set forth in § 22-49-3 involving the
9		prostitution of a minor;
10	(23)	Felony use or dissemination of visual recording or photographic device without
11		consent and with intent to self-gratify, harass, or embarrass as set forth in § 22-
12		21-4;
13	(24)	Manufacturing or distributing a child-like sex doll as set forth in § 22-24A-1.1; or
14	(25)	Felony conviction of purchasing or possessing a child-like sex doll as set forth in
15		§ 22-24A-3.1.
