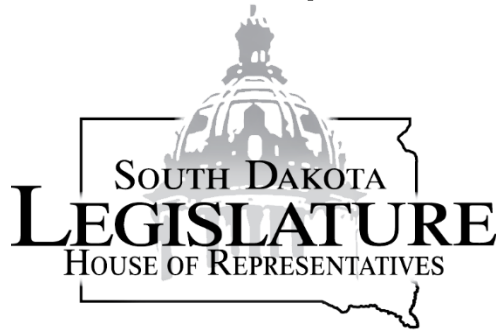

SECOND READING OF CONSENT CALENDAR ITEMS

- HB 1026 clarify the requirement for the construction or expansion of a municipal campground or tourist accommodation facility.
(House Local Government Engrossed)
- HB 1027 modify substances listed on the controlled substances schedule and to declare an emergency. (House Health and Human Services Engrossed)
- HB 1020 revise the method by which completion of a required suicide awareness and prevention training is verified. (Introduced)
- HB 1003 update a reference to the Internal Revenue Code for purposes of higher education savings plans. (Introduced)
- HB 1011 revise the membership of the South Dakota Capitol Complex Restoration and Beautification Commission. (Introduced)
- HB 1058 modify agency reporting requirements on licensure, certification, job placements, and the labor market. (Introduced)
- HB 1004 update the official code of laws. (Introduced)
- HB 1005 revise the manner of citing the Administrative Rules of South Dakota.
(Introduced)
- HB 1006 increase the amount of time permitted the Interim Rules Review Committee to review final permanent rulemaking materials. (Introduced)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1033 (Removed from Consent Calendar) address the administration of State Conservation Commission functions by the Department of Agriculture and Natural Resources. (Introduced)
- HB 1031 (Removed from Consent Calendar) update the development and implementation of conservation district standards. (Introduced)
- HB 1018 (Deferred from 4th LD) revise certain references to the Internal Revenue Code. (Introduced)
- HB 1019 (Deferred from 4th LD) clarify language regarding sales and use tax in certain statutes. (Introduced)
- HB 1015 (Deferred from 4th LD) adopt the social work licensure compact. (Introduced)
- HB 1050 (Deferred from 4th LD) update references to certain federal motor carrier regulations. (Introduced)
- HB 1035 extend the period of renewal for an enhanced permit to carry a concealed pistol. (Introduced)
- HB 1041 modify the definition of public infrastructure to allow a federally recognized Indian tribe to be eligible for housing infrastructure grants and loans and to declare an emergency. (Introduced)
- HB 1055 raise the appraisal value of surplus property that may be sold by a political subdivision without notice. (Introduced)
- HB 1034 require hydrogen pipelines to be permitted by the Public Utilities Commission. (Introduced)
- HB 1059 revise certain provisions regarding insurance holding companies. (Introduced)
- HB 1024 require that an application for a medical marijuana registry identification card include a notice and acknowledgement of federal law regarding firearms and the unlawful use of a controlled substance. (Introduced)
- HB 1036 require that a dispensary post notice of the federal law regarding possession of a firearm and the use of marijuana and to provide a civil penalty. (Introduced)
