1 **An Act to provide special motor vehicle license plates for advanced life support**
 2 **personnel and emergency medical technicians.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1. That § 32-5-113 be AMENDED:**

5 **32-5-113.** Any owner of a motor vehicle, who is a resident of this state, who is a
 6 firefighter, an advanced life support personnel, or emergency medical technician licensed
 7 pursuant to chapter 36-4B, and who has complied with ~~all of the laws of this state law~~ in
 8 relation to the registration of a motor vehicle, may receive plates bearing a special number
 9 and design, and designating the person as a firefighter, advanced life support personnel,
 10 or emergency medical technician. The distinctive number plates shall for a firefighter must
 11 be designed by the fire marshal and. The distinctive number plates for advanced life
 12 support personnel and emergency medical technicians must be designed by the secretary
 13 of health. The number plates are subject to the approval of the Department of Revenue.
 14 The special plates ~~shall~~ must be displayed as set forth in § 32-5-98.

15 **Section 2. That § 32-5-114 be AMENDED:**

16 **32-5-114.** In addition to the noncommercial license ~~plates~~ plate fees, a firefighter,
 17 advanced life support personnel, or emergency medical technician receiving the special
 18 license plates shall pay an additional fee of ten dollars for the initial issuance of the special
 19 license plates. The special license plate fee collected under this section ~~shall~~ must be
 20 placed in the license plate special revenue fund, as provided under § 32-5-67.

21 **Section 3. That § 32-5-116 be AMENDED:**

22 **32-5-116.** Any firefighter, advanced life support personnel, or emergency medical
 23 technician ~~desiring special license plates authorized by § 32-5-113 for use during the next~~
 24 year shall make application may apply to the department for special license plates

1 authorized under § 32-5-113 for use during the next year by specifying the number of
2 vehicles to be licensed, to the Department of Revenue specifying the number of vehicles
3 to be licensed, the firefighter's name name of the firefighter, advanced life support
4 personnel, or emergency medical technician, and the county of residence to the
5 Department of Revenue. The department shall notify the manufacturer of the number of
6 special number plates required in sufficient time that the plates may be produced and sent
7 to the department.

8 **Section 4. That § 32-5-118 be AMENDED:**

9 **32-5-118.** Each firefighter ~~shall,~~ advanced life support personnel, or emergency
10 medical technician must apply to the county treasurer of the county of the firefighter's or
11 advanced life support personnel's residence for the issuance of special number plates for
12 the motor vehicles owned by the firefighter, advanced life support personnel, or
13 emergency medical technician. The firefighter, advanced life support personnel, or
14 emergency medical technician, in order to receive the special plates, ~~shall have paid~~ must
15 pay the registration fee for the plates.

16 **Section 5. That § 32-5-119 be AMENDED:**

17 **32-5-119.** A failure on the part of a firefighter, advanced life support personnel,
18 or emergency medical technician to make application to the Department of Revenue for
19 ~~such~~ the special number plates as provided in § 32-5-116 will result in ~~such member~~ the
20 applicant being required to accept regular number plates for ~~his~~ the applicant's motor
21 vehicle.

22 **Section 6. That § 32-5-120 be AMENDED:**

23 **32-5-120.** If ~~any~~ a firefighter, advanced life support personnel, or emergency
24 medical technician is discharged, ~~separated,~~ or retires, the firefighter ~~shall,~~ advanced life
25 support personnel, or emergency medical technician must surrender the special number
26 plates identifying ~~him or her~~ the person as a firefighter, advanced life support personnel,
27 or emergency medical technician. The special plates ~~shall~~ must be surrendered to the
28 secretary ~~of revenue,~~ who shall make the necessary changes in the registration file. The
29 firefighter, advanced life support personnel, or emergency medical technician shall then
30 obtain regular number plates.

31 **Section 7. That § 32-5-121 be AMENDED:**

1 **32-5-121.** If at any time a motor vehicle subject to the special number plates
2 issued for the firefighter ~~shall be, advanced life support personnel, or emergency medical~~
3 technician is sold, conveyed, or otherwise transferred by the firefighter or an advanced
4 life support personnel to whom the special number plates have been issued, the firefighter
5 ~~shall, advanced life support personnel, or emergency medical technician must~~ notify the
6 ~~Department of Revenue department.~~ The ~~Department of Revenue department~~ shall
7 process a new registration indicating that the special plates issued to the motor vehicle to
8 ~~which the special plates are to~~ must be transferred. The secretary shall make the
9 necessary changes in the file. The department shall notify the applicant of any corrections
10 ~~which~~ that need to be made.

11 **Section 8. That § 32-5-122 be AMENDED:**

12 **32-5-122.** All statutes of this state relating to the registration of motor vehicles,
13 ~~and~~ the titling and licensing of motor vehicles; ~~the~~ fees for registering, titling, and
14 licensing of motor vehicles; ~~and~~ the retention of plates from year to year ~~shall be~~ are
15 applicable to ~~firefighters~~ any firefighter, advanced life support personnel, or emergency
16 medical technician and the special plates issued in conformity with § 32-5-113.
