AMENDMENT 1182A FOR THE INTRODUCED BILL

1 An Act to revise provisions pertaining to the observation of the conduct of an 2 election.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 12-1-3 be AMENDED:

- 5 **12-1-3.** Terms used in this title mean:
 6 (1) <u>"Ballot question," any initiated measure, initiated constitutional amendment, or</u>
 7 referred law submitted to voters at an election;
 - 8 (2)—"Ballot question committee,"-a person or entity that raises, collects, or disburses
 9 contributions as a proponent or opponent for the placement on the ballot of one or
 10 more ballot questions or for the adoption or defeat of one or more ballot questions
 11 at an election as defined by § 12-27-1;
 - 12 (3)(2) "Candidate," a person whose name is on the ballot or who is entitled to be on the
 ballot to be voted upon for nomination or election at any election;
 - 14 (2)(4)(3) "Election," any election held under the laws of this state;
 - (3)(5)(4) "Election officials," state and local officials charged with the duty of conducting
 elections and the canvass of returns;
 - 17 (4)(6)(5) "Elector," a person qualified to register as a voter, whether or not the person
 18 is registered;
 - (5)(7)(6) "Electronic pollbook," an electronic system containing both the registration list
 and pollbook;
 - 21 (6)(8)(7) "General election," the vote required to be taken in each voting precinct of the
 22 state on the first Tuesday after the first Monday in November of each even 23 numbered year;
 - 24 (7)(9)(8) "Paid circulator," any person who receives money or anything of value for
 25 collecting signatures for a petition;

(21)(24)(23) "Voter," a person duly registered to vote or one who is performing the
 act of voting;

3 (22)(25)(24) "Independent (IND)" or "no party affiliation (NPA)," any currently
4 registered voter who writes independent, I, Ind, no party affiliation, no party, no
5 choice, nonpartisan, or line crossed off in the choice of party field on the voter
6 registration form and any individual who is not currently registered to vote who
7 leaves the choice of party field blank on the voter registration form;

8 (23)(26)(25) "Independent candidate," notwithstanding the definition of independent
 9 as stated in this chapter, any registered voter regardless of party affiliation who
 10 declares to be an independent candidate for public office pursuant to this chapter;
 11 (24)(27)(26) "Other," any voter who writes a political party not recognized in South
 12 Dakota in the choice of party field on the voter registration form.

13 Section 2. That § 12-18-9 be AMENDED:

14 12-18-9. Any person, except a candidate who is on the ballot being voted on at 15 that polling place, may be present at any polling place for the purpose of observing the 16 voting process. Any person may be present to observe the counting process. A candidate 17 who is on the ballot being voted on at a polling place may only be present to cast the 18 candidate's vote during voting hours. A number of poll watchers shall be permitted for 19 each candidate at a primary election or political party and independent candidate at a 20 general election pursuant to § 12-18-8.1. Each polling place shall be arranged in a manner 21 that permits each poll watcher to be positioned in a location where the poll watcher can 22 plainly see and hear what is done within the polling place.

At a primary, general, or special election, anyAny candidate, party, or ballot question committee may have poll watchers present at a polling place for the purpose of observing the voting and counting process. A candidate who is on the ballot being voted on may not serve as a poll watcher and may only be present at a polling place to cast the candidate's vote during voting hours.

A poll watcher present at a polling place shall remain in a designated observation area at all times while acting as a poll watcher. The observation area must be less than six feet away from, but may not be closer than three feet to, the table at which voters announce their name and address to be issued a ballot. The observation area must also permit any poll watcher to see and hear all public aspects of the voting process Each polling place must be arranged in a manner that permits each poll watcher to be positioned in a location where the poll watcher can plainly see and hear what is done within the

1	polling place. Members of the public may observe the voting and counting process at any
2	polling location in a manner that does not interfere with the duties o the poll workers or
3	poll watchers.
4	A violation of this section by either a poll watcher or a poll worker is a Class 2
5	misdemeanor.
