# Senate Bill 165

SENATE ENGROSSED

Introduced by: Senator Maher

#### 1 An Act to create the South Dakota-Ireland Trade Commission.

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

#### 3 Section 1. That a NEW SECTION be added to title 1:

- The South Dakota-Ireland Trade Commission is created to:
- 5 (1) Advance bilateral trade and investment between this state and Ireland;
- 6 (2) Initiate joint action on issues of mutual interest to this state and Ireland;
- 7 (3) Promote business and academic exchanges between this state and Ireland;
- 8 (4) Encourage mutual economic support between this state and Ireland;
- 9 (5) Encourage mutual investment in the infrastructure of this state and Ireland; and
- 10 (6) Address any other issues deemed to be of mutual benefit to this state and Ireland.

#### 11 Section 2. That a NEW SECTION be added to title 1:

12		The South Dakota-Ireland Trade Commission consists of:
13	<u>(1)</u>	Two members of the Senate, appointed by the president pro tempore of the
14		<u>Senate;</u>
15	<u>(2)</u>	Two members of the House of Representatives, appointed by the speaker of the
16		House;
17	<u>(3)</u>	A representative of a private sector association headquartered in this state and
18		focused on the promotion of international trade, appointed by the Executive Board
19		of the Legislative Research Council; and
20	<u>(4)</u>	The secretary of the Department of Agriculture and Natural Resources, or the
21		secretary's designee.
22		Each appointed member shall serve for a term of two years and may be reappointed
23	<u>withou</u>	t limit. If a position becomes vacant, the position must be filled, for the duration of
24	<u>the ter</u>	m, in the same manner as the original appointment.

- 2 <u>The Department of Agriculture and Natural Resources shall provide administrative</u>
  3 <u>services to the South Dakota-Ireland Trade Commission.</u>
  - At the initial meeting of the commission and annually thereafter, the members shall

- 5 <u>select one from among the four appointed legislators to serve as the chair. The commission</u>
- 6 <u>shall meet at least quarterly, at the call of the chair.</u>

## 7 Section 4. That a NEW SECTION be added to title 1:

- 8 There is established in the state treasury the South Dakota-Ireland trade fund. The
- 9 Department of Agriculture and Natural Resources shall administer the fund. The purpose
- 10 of the fund is to defray the administrative expenses of the commission and support the
- 11 <u>commission's efforts to carry out its purposes, as set forth in section 1 of this Act.</u>
- 12 <u>The fund consists of all moneys raised by or on behalf of the commission, together</u> 13 <u>with any gifts, grants, or other donations. Interest on moneys credited to the fund must</u> 14 remain in the fund.
- 15 <u>The South Dakota-Ireland trade fund is continuously appropriated to the South</u>
  16 <u>Dakota-Ireland Trade Commission.</u>

## 17 Section 5. That a NEW SECTION be added to title 1:

- Each member of the South Dakota-Ireland Trade Commission is entitled to receive
  reimbursement for necessary expenses, as provided for in § 4-7-10.4, from moneys in
  the South Dakota-Ireland trade fund, if the member is performing duties directed by the
  commission.
- 22 Section 6. That a NEW SECTION be added to title 1:
- On or before November first of each year, the South Dakota-Ireland Trade
  Commission shall provide a report to the Executive Board of the Legislative Research
- 25 <u>Council. The report must include:</u>
- 26 (1) A description of the commission's work;
- 27 (2) A description of benefits to the state and to sectors involved in international trade,
  28 attributable to the commission's efforts;
- 29 (3) Recommendations for legislative action that would support trade between this state
  30 and Ireland; and
- 31 (4) A summary of anticipated commission activities in the ensuing year.
