- (4) Department of Human Services.

Affirmative understanding of the notice by the participant is not required.

The emergency termination notice must contain the reason for terminating services to the participant, information on the availability of other similar services in the community, and the contact information of the participant's case manager and the Department of Human Services." and insert "

If the provider determines that a participant is a danger to self or others, or the participant has engaged in behavior that repeatedly interferes with the rights, health, or safety of others, the provider may terminate services provided to the participant under the CHOICES waiver program on the noticed date of termination, regardless of whether an appeal is filed under section 4 of this Act. If a participant has a residential lease agreement with a provider, the noticed date of termination may not be sooner than the termination or expiration of the agreement.

In order to terminate services in accordance with this section, the provider must forward the notice required by section 2 of this Act and include:

- (1) A statement indicating that the provider is terminating services to the participant because:
- (a) The participant is a danger to self or others; or
- (b) The participant has engaged in behavior that repeatedly interferes with the rights, health, or safety of others;
- (2) A statement indicating that, if an appeal is filed, the provider may terminate services on the noticed termination date; and
- (3) Documentation of the participant's behavior and action taken by the provider to address the behaviors that led to the issuance of the termination notice.
