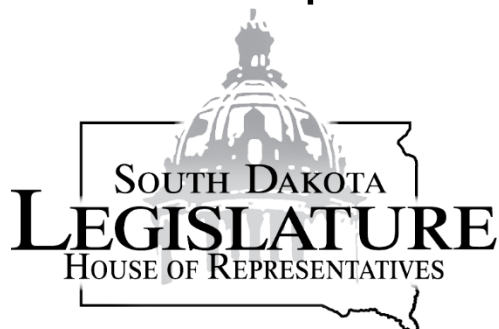

CONSIDERATION OF REPORTS OF COMMITTEES (AMENDED BILLS)

HB 1048, HB 1232, HB 1257

DO NOT PASS: HB 1199

SECOND READING OF CONSENT CALENDAR ITEMS

HB 1211 repeal the Midwestern Regional Higher Education Compact. (Introduced)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1140 (Deferred from 24th LD) (Removed from Consent Calendar) improve the efficiency and administration of state government. (Introduced)
- HB 1141 (Deferred from 24th LD) (Removed from Consent Calendar) improve public safety in South Dakota. (Introduced)
- HB 1142 (Deferred from 24th LD) (Removed from Consent Calendar) improve education and to provide for the workforce of South Dakota. (Introduced)
- HB 1143 (Deferred from 24th LD) (Removed from Consent Calendar) improve agriculture in South Dakota. (Introduced)
- HB 1202 establish procedures for the termination of services by a provider through the CHOICES waiver program. (House Health and Human Services Engrossed)
- HB 1255 establish a property tax exemption for religious societies, and to modify the application requirements for certain property tax exemptions. (House Taxation Engrossed)
- HB 1244 provide a process to withdraw a signature from a petition for an initiated measure, constitutional amendment, or a referendum on a law in certain situations and to declare an emergency. (Introduced)
- HB 1240 permit a homeowner's association, development, or incorporated community to modify a restrictive covenant. (Introduced)

- HB 1098 provide free birth certificates to persons experiencing homelessness.

- HB 1131 waive certain fees for nondriver identification cards for individuals who are
homeless. (House Health and Human Services Engrossed) (Fiscal Note)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 94 (Deferred from 24th LD) amend provisions pertaining to the partners in
education tax credit program. (Senate Commerce and Energy Engrossed)
- SB 112 (Deferred from 24th LD) establish a non-resident title fee. (Introduced)
- SB 152 (Deferred from 24th LD) establish maximum fees for legal publications and to
remove related rule-making authority from the Bureau of Administration.
(Introduced)
- SB 172 (Deferred from 24th LD) allow a person to temporarily take responsibility of a
feral cat or dog for the purpose of spaying or neutering the animal.
(Senate Local Government Engrossed)
