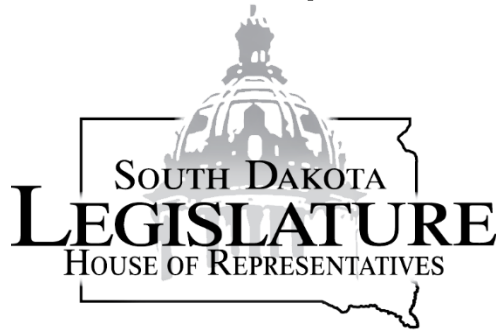

MOTIONS AND RESOLUTIONS

HB 1091 (Consideration of Senate Amendments) enact the Interstate Insurance Product Regulation Compact. (Senate Engrossed)

CONSIDERATION OF REPORTS OF COMMITTEES (AMENDED BILLS)

HB 1039, HB 1060, SB 10, SB 43

WITHOUT RECOMMENDATION: HB 1219

SECOND READING OF CONSENT CALENDAR ITEMS

HB 1233 amend requirements for a cosmetology apprenticeship. (Introduced)
SB 11 prohibit a practitioner from referring a patient to a medical cannabis clinic with which the practitioner or an immediate family member has a financial relationship and to provide a penalty therefor. (Senate Health and Human Services Engrossed)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

HB 1211 (Removed from Consent Calendar) repeal the Midwestern Regional Higher Education Compact. (Introduced)
HB 1202 (Deferred from 25th LD) establish procedures for the termination of services by a provider through the CHOICES waiver program. (House Health and Human Services Engrossed)
HB 1255 (Deferred from 25th LD) establish a property tax exemption for religious societies, and to modify the application requirements for certain property tax exemptions. (House Taxation Engrossed)
HB 1244 (Deferred from 25th LD) provide a process to withdraw a signature from a petition for an initiated measure, constitutional amendment, or a referendum on a law in certain situations and to declare an emergency. (Introduced)
HB 1240 (Deferred from 25th LD) permit a homeowner's association, development, or incorporated community to modify a restrictive covenant. (Introduced)

- HB 1098 (Deferred from 25th LD) provide free birth certificates to persons experiencing homelessness. (House Health and Human Services Engrossed) (Fiscal Note)
- HB 1131 (Deferred from 25th LD) waive certain fees for nondriver identification cards for individuals who are homeless.
(House Health and Human Services Engrossed) (Fiscal Note)
- HB 1048 revise the requirements pertaining to average teacher compensation and to establish a minimum teacher salary. (House Education Engrossed)
- HB 1232 create the Indian Child Welfare Advisory Council.
(House State Affairs Engrossed)
- HB 1257 require age verification by websites containing material harmful to minors.
(House Judiciary Engrossed)
- HB 1213 create the Dr. Nicholas W. Drummond Center for Civic Engagement at Black Hills State University. (Introduced)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 94 (Deferred from 25th LD) (Removed from Consent Calendar) amend provisions pertaining to the partners in education tax credit program.
(Senate Commerce and Energy Engrossed)
- SB 112 (Deferred from 25th LD) establish a non-resident title fee. (Introduced)
- SB 152 (Deferred from 25th LD) establish maximum fees for legal publications and to remove related rule-making authority from the Bureau of Administration.
(Introduced)
- SB 172 (Deferred from 25th LD) allow a person to temporarily take responsibility of a feral cat or dog for the purpose of spaying or neutering the animal.
(Senate Local Government Engrossed)
- SB 42 modify provisions related to medical cannabis.
(Senate Health and Human Services Engrossed)
