Senate Bill 58

1 **An Act to revise provisions regarding money transmission.**

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 **Section 1. That chapter 51A-17 be amended with a NEW SECTION:**

4 Terms used in this Act mean:

5 (1) "Acting in concert," persons knowingly acting together with a common goal of
6 jointly acquiring control of a licensee whether or not pursuant to an express
7 agreement;

8 (2) "Authorized delegate," a person a licensee designates to engage in money
9 transmission on behalf of the licensee;

10 (3) "Average daily money transmission liability," the amount of the licensee's
11 outstanding money transmission obligations in this state at the end of each day in
12 a given period of time, added together, and divided by the total number of days in
13 the given period of time. For purposes of calculating average daily money
14 transmission liability under this Act for any licensee required to do so, the given
15 period of time is the quarters ending March thirty-first, June thirtieth, September
16 thirtieth, and December thirty-first;

17 (4) "Bank Secrecy Act," the Bank Secrecy Act, 31 U.S.C. § 5311, et seq. and its
18 implementing regulations (January 1, 2024);

19 (5) "Closed loop stored value," stored value that is redeemable by the issuer only for
20 goods or services provided by the issuer or its affiliate or franchisees of the issuer
21 or its affiliate, except to the extent required by applicable law to be redeemable in
22 cash for its cash value;

23 (6) "Control:"

24 (a) The power to vote, directly or indirectly, at least twenty-five percent of the
25 outstanding voting shares or voting interests of a licensee or person in
26 control of a licensee; the power to elect or appoint a majority of key

1 individuals or executive officers, managers, directors, trustees; other
2 persons exercising managerial authority of a person in control of a licensee;
3 or the power to exercise, directly or indirectly, a controlling influence over
4 the management or policies of a licensee or person in control of a licensee;

5 (b) A person is presumed to exercise a controlling influence when the person
6 holds the power to vote, directly or indirectly, at least ten percent of the
7 outstanding voting shares or voting interests of a licensee or person in
8 control of a licensee. A person presumed to exercise a controlling influence
9 as defined by this section can rebut the presumption of control if the person
10 is a passive investor;

11 (c) For purposes of determining the percentage of a person controlled by any
12 other person, the person's interest shall be aggregated with the interest of
13 any other immediate family member, including the person's spouse,
14 parents, children, siblings, mothers- and fathers-in-law, sons- and
15 daughters-in-law, brothers- and sisters-in-law, and any other person who
16 shares the person's home;

17 (7) "Eligible rating," a credit rating of any of the three highest rating categories
18 provided by an eligible rating service, whereby each category may include rating
19 category modifiers, such as "plus" or "minus" for S&P or the equivalent for any
20 other eligible rating service. Long-term credit ratings are deemed eligible if the
21 rating is equal to A- or higher by S&P or the equivalent from any other eligible
22 rating service. Short-term credit ratings are deemed eligible if the rating is equal
23 to or higher than A-2 or SP-2 by S&P or the equivalent from any other eligible
24 rating service. In the event that ratings differ among eligible rating services, the
25 highest rating shall apply when determining whether a security bears an eligible
26 rating;

27 (8) "Eligible rating service," any nationally recognized statistical rating organization as
28 defined by the U.S. Securities and Exchange Commission, and any other
29 organization designated by the director by rule or order;

30 (9) "Federally insured depository financial institution," a bank, credit union, savings
31 and loan association, trust company, savings association, savings bank, industrial
32 bank, or industrial loan company organized under the laws of the United States or
33 any state of the United States, when the bank, credit union, savings and loan
34 association, trust company, savings association, savings bank, industrial bank, or
35 industrial loan company has federally insured deposits;

1 (10) "In this state," at a physical location within this state for a transaction requested
2 in person. For a transaction requested electronically or by phone, the provider of
3 money transmission may determine if the person requesting the transaction is "in
4 this state" by relying on other information provided by the person regarding the
5 location of the individual's residential address or a business entity's principal place
6 of business or other physical address location and any records associated with the
7 person that the provider of money transmission may have that indicate the
8 location, including but not limited to an address associated with an account;

9 (11) "Individual," a natural person;

10 (12) "Key individual," any individual ultimately responsible for establishing or directing
11 policies and procedures of the licensee, such as an executive officer, manager,
12 director, or trustee;

13 (13) "Licensee," a person licensed under this Act;

14 (14) "Material litigation," litigation that, according to United States generally accepted
15 accounting principles, is significant to a person's financial health and would be
16 required to be disclosed in the person's annual audited financial statements, report
17 to shareholders, or similar records;

18 (15) "Money," a medium of exchange that is authorized or adopted by the United States
19 or a foreign government. The term includes a monetary unit of account established
20 by an intergovernmental organization or by agreement between two or more
21 governments. Money does not include any central bank digital currency;

22 (16) "Monetary value," a medium of exchange, whether or not redeemable in money;

23 (17) "Money transmission," any of the following:

24 (a) Selling or issuing payment instruments to a person located in this state;

25 (b) Selling or issuing stored value to a person located in this state; or

26 (c) Receiving money for transmission from a person located in this state.

27 The term includes payroll processing services. The term does not include the
28 provision solely of online or telecommunications services or network access;

29 (18) "MSB accredited state," a state agency that is accredited by the Conference of
30 State Bank Supervisors and Money Transmitter Regulators Association for money
31 transmission licensing and supervision;

32 (19) "Multistate licensing process," any agreement entered into by and among state
33 regulators relating to coordinated processing of applications for money
34 transmission licenses, applications for the acquisition of control of a licensee,

- 1 control determinations, or notice and information requirements for a change of key
2 individuals;
- 3 (20) "NMLS," the Nationwide Multistate Licensing System and Registry developed by the
4 Conference of State Bank Supervisors and the American Association of Residential
5 Mortgage Regulators and owned and operated by the State Regulatory Registry,
6 LLC, or any successor or affiliated entity, for the licensing and registration of
7 persons in financial services industries;
- 8 (21) "Outstanding money transmission obligations," must be established and
9 extinguished in accordance with applicable state law and:
- 10 (a) Any payment instrument or stored value issued or sold by the licensee to a
11 person located in the United States or reported as sold by an authorized
12 delegate of the licensee to a person that is located in the United States that
13 has not yet been paid or refunded by or for the licensee, or escheated in
14 accordance with applicable abandoned property laws; or
- 15 (b) Any money received for transmission by the licensee or an authorized
16 delegate in the United States from a person located in the United States
17 that has not been received by the payee or refunded to the sender, or
18 escheated in accordance with applicable abandoned property laws;
- 19 (c) For purposes of this section, "in the United States" shall include, to the
20 extent applicable, a person in any state, territory, or possession of the
21 United States; the District of Columbia; the Commonwealth of Puerto Rico;
22 or a U.S. military installation that is located in a foreign country;
- 23 (22) "Passive investor," a person that:
- 24 (a) Does not have the power to elect a majority of key individuals or executive
25 officers, managers, directors, trustees, or other persons exercising
26 managerial authority of a person in control of a licensee;
- 27 (b) Is not employed by and does not have any managerial duties of the licensee
28 or person in control of a licensee;
- 29 (c) Does not have the power to exercise, directly or indirectly, a controlling
30 influence over the management or policies of a licensee or person in control
31 of a licensee; and
- 32 (d) Either attests to (a), (b), and (c) in a form and in a medium prescribed by
33 the director or commits to the passivity characteristics of (a), (b), and (c)
34 in a written document;

1 (23) "Payment instrument," a written or electronic check, draft, money order, traveler's
2 check, or other written or electronic instrument for the transmission or payment of
3 money or monetary value, whether or not negotiable. The term does not include
4 stored value or any instrument that is redeemable by the issuer only for goods or
5 services provided by the issuer or its affiliate or franchisees of the issuer or its
6 affiliate, except to the extent required by applicable law to be redeemable in cash
7 for its cash value, or is not sold to the public but issued and distributed as part of
8 a loyalty, rewards, or promotional program;

9 (24) "Payroll processing services," receiving money for transmission pursuant to a
10 contract with a person to deliver wages or salaries, make payment of payroll taxes
11 to state and federal agencies, make payments relating to employee benefit plans,
12 or make distributions of other authorized deductions from wages or salaries. The
13 term payroll processing services does not include an employer performing payroll
14 processing services on its own behalf or on behalf of its affiliate or a professional
15 employment organization subject to regulation under other applicable state law;

16 (25) "Person," any individual, general partnership, limited partnership, limited liability
17 company, corporation, trust, association, joint stock corporation, or other
18 corporate entity identified by the director;

19 (26) "Receiving money for transmission" or "money received for transmission,"
20 receiving money or monetary value in the United States for transmission within or
21 outside the United States by electronic or other means;

22 (27) "Stored value," monetary value representing a claim against the issuer evidenced
23 by an electronic or digital record and that is intended and accepted for use as a
24 means of redemption for money or monetary value or payment for goods or
25 services. The term includes, but is not limited to, "prepaid access" as defined by
26 31 C.F.R. § 1010.100 (January 1, 2024). Notwithstanding the foregoing, the term
27 "stored value" does not include a payment instrument, closed loop stored value,
28 or stored value not sold to the public but issued and distributed as part of a loyalty,
29 rewards, or promotional program; and

30 (28) "Tangible net worth," the aggregate assets of a licensee excluding all intangible
31 assets, less liabilities, as determined in accordance with United States generally
32 accepted accounting principles.

33 **Section 2. That chapter 51A-17 be amended with a NEW SECTION:**

34 This Act does not apply to:

- 1 (1) An operator of a payment system to the extent that it provides processing, clearing,
2 or settlement services, between or among persons exempted by this section or
3 licensees, in connection with wire transfers, credit card transactions, debit card
4 transactions, stored-value transactions, automated clearing house transfers, or
5 similar funds transfers;
- 6 (2) A person appointed as an agent of a payee to collect and process a payment from
7 a payor to the payee for goods or services, other than the money transmission
8 itself, provided to the payor by the payee, provided that:
- 9 (a) There exists a written agreement between the payee and the agent
10 directing the agent to collect and process payments from payors on the
11 payee's behalf;
- 12 (b) The payee holds the agent out to the public as accepting payments for
13 goods or services on the payee's behalf; and
- 14 (c) Payment for the goods and services is treated as received by the payee
15 upon receipt by the agent so that the payor's obligation is extinguished and
16 there is no risk of loss to the payor if the agent fails to remit the funds to
17 the payee;
- 18 (3) A person that acts as an intermediary by processing payments between an entity
19 that has directly incurred an outstanding money transmission obligation to a
20 sender, and the sender's designated recipient, provided that the entity:
- 21 (a) Is properly licensed or exempt from licensing requirements under this Act;
22 (b) Provides a receipt, electronic record, or other written confirmation to the
23 sender identifying the entity as the provider of money transmission in the
24 transaction; and
- 25 (c) Bears sole responsibility to satisfy the outstanding money transmission
26 obligation to the sender, including the obligation to make the sender whole
27 in connection with any failure to transmit the funds to the sender's
28 designated recipient;
- 29 (4) The United States, a department, agency, or instrumentality thereof, or its agent;
- 30 (5) Money transmission by the United States Postal Service or by an agent of the
31 United States Postal Service;
- 32 (6) A state, county, city, or any other governmental agency or governmental
33 subdivision or instrumentality of a state, or its agent;
- 34 (7) A federally insured depository financial institution, bank holding company, office of
35 an international banking corporation, foreign bank that establishes a federal branch

- 1 pursuant to the International Bank Act, 12 U.S.C. § 3102 (January 1, 2024),
2 corporation organized pursuant to the Bank Service Corporation Act, 12 U.S.C.
3 §§ 1861-1867 (January 1, 2024), or corporation organized under the Edge Act, 12
4 U.S.C. §§ 611-633 (January 1, 2024);
- 5 (8) Electronic funds transfer of governmental benefits for a federal, state, county, or
6 governmental agency by a contractor on behalf of the United States or a
7 department, agency, or instrumentality thereof, or on behalf of a state or
8 governmental subdivision, agency, or instrumentality thereof;
- 9 (9) A board of trade designated as a contract market under the federal Commodity
10 Exchange Act, 7 U.S.C. §§ 1-25 (January 1, 2024), or a person that, in the ordinary
11 course of business, provides clearance and settlement services for a board of trade
12 to the extent of its operation as or for the board;
- 13 (10) A registered futures commission merchant under the federal commodities laws to
14 the extent of its operation as a merchant;
- 15 (11) A person registered as a securities broker-dealer under federal or state securities
16 laws to the extent of its operation as a broker-dealer;
- 17 (12) An individual employed by a licensee, authorized delegate, or any person exempted
18 from the licensing requirements of this Act when acting within the scope of
19 employment and under the supervision of the licensee, authorized delegate, or
20 exempted person as an employee and not as an independent contractor;
- 21 (13) A person expressly appointed as a third-party service provider to or agent of an
22 entity exempt under subdivision (7) of this section, solely to the extent that:
- 23 (a) The service provider or agent is engaging in money transmission on behalf
24 of and pursuant to a written agreement with the exempt entity that sets
25 forth the specific functions that the service provider or agent is to perform;
26 and
- 27 (b) The exempt entity assumes all risk of loss and all legal responsibility for
28 satisfying the outstanding money transmission obligations owed to
29 purchasers and holders of the outstanding money transmission obligations
30 upon receipt of the purchaser's or holder's money or monetary value by the
31 service provider or agent;
- 32 (14) A person exempt by regulation or order if the director finds the exemption to be in
33 the public interest and that the regulation of the person is not necessary for the
34 purposes of this Act;
- 35 (15) A South Dakota chartered trust company; and

1 (16) A person appointed as an agent of a payor for purposes of providing payroll
2 processing services for which the agent would otherwise need to be licensed,
3 provided all of the following apply:

4 (a) There is a written agreement between the payor and the agent that directs
5 the agent to provide payroll processing services on the payor's behalf;

6 (b) The payor holds the agent out to employees and other payees as providing
7 payroll processing services on the payor's behalf; and

8 (c) The payor's obligation to a payee, including an employee or any other party
9 entitled to receive funds via the payroll processing services provided by the
10 agent, shall not be extinguished if the agent fails to remit the funds to the
11 payee.

12 The director may require that any person claiming to be exempt from licensing
13 pursuant to this section provide information and documentation to the director
14 demonstrating that it qualifies for any claimed exemption.

15 **Section 3. That chapter 51A-17 be amended with a NEW SECTION:**

16 (1) In order to carry out the purposes of this Act, the director may, subject to the
17 provisions of subdivisions (1) and (4) of section 4 of this Act:

18 (a) Enter into agreements or relationships with other government officials or
19 federal and state regulatory agencies and regulatory associations in order
20 to improve efficiencies and reduce regulatory burden by standardizing
21 methods or procedures, and sharing resources, records, or related
22 information obtained under this Act;

23 (b) Use, hire, contract, or employ analytical systems, methods, or software to
24 examine or investigate any person subject to this Act;

25 (c) Accept, from other state or federal government agencies or officials,
26 licensing, examination, or investigation reports made by the other state or
27 federal government agencies or officials; and

28 (d) Accept audit reports made by an independent certified public accountant or
29 other qualified third-party auditor for an applicant or licensee and
30 incorporate the audit report in any report of examination or investigation.

31 (2) The director has the broad administrative authority to administer, interpret, and
32 enforce this Act and to recover the cost of administering and enforcing this Act by
33 imposing and collecting proportionate and equitable fees and costs associated with

1 applications, examinations, investigations, and other actions required to achieve
2 the purpose of this Act.

3 **Section 4. That chapter 51A-17 be amended with a NEW SECTION:**

4 (1) Except as otherwise provided in this section, all information or reports obtained by
5 the director from an applicant, licensee, or authorized delegate and all information
6 contained in or related to an examination, investigation, operating report, or
7 condition report prepared by, on behalf of, or for the use of the director, or financial
8 statements, balance sheets, or authorized delegate information are confidential
9 and are not subject to disclosure under this state's open records law.

10 (2) The director may disclose information not otherwise subject to disclosure under
11 this section to representatives of state or federal agencies who promise in a record
12 that they will maintain the confidentiality of the information or where the director
13 finds that the release is reasonably necessary for the protection and interest of the
14 public in accordance with this state's open records law.

15 (3) This section does not prohibit the director from disclosing to the public a list of all
16 licensees or the aggregated financial or transactional data concerning those
17 licensees.

18 (4) Information contained in the records of the division that is not confidential and may
19 be made available to the public either on the division website, upon receipt by the
20 division of a written request, or in NMLS must include:

21 (a) The name, business address, telephone number, and unique identifier of a
22 licensee;

23 (b) The business address of a licensee's registered agent for service;

24 (c) The name, business address, and telephone number of all authorized
25 delegates;

26 (d) The terms of or a copy of any bond filed by a licensee, provided that
27 confidential information, including, but not limited to, prices and fees for
28 the bond is redacted; and

29 (e) Copies of any non-confidential final orders of the division relating to any
30 violation of this Act or regulations implementing this Act; and

31 (f) Imposition of a non-confidential administrative fine or penalty under this
32 Act.

33 **Section 5. That chapter 51A-17 be amended with a NEW SECTION:**

1 (1) The director may conduct an examination or investigation of a licensee or
2 authorized delegate or otherwise take independent action authorized by this Act or
3 by a rule adopted or order issued under this Act as reasonably necessary or
4 appropriate to administer and enforce this Act, regulations implementing this
5 chapter, and other applicable law, including the Bank Secrecy Act and other federal
6 and state laws pertaining to money laundering. The director may:

7 (a) Conduct an examination either on-site or off-site as the director may
8 reasonably require;

9 (b) Conduct an examination in conjunction with an examination conducted by
10 representatives of other state agencies or agencies of another state or the
11 federal government;

12 (c) Accept the examination report of another state agency or an agency of
13 another state or the federal government, or a report prepared by an
14 independent accounting firm, which on being accepted is considered for all
15 purposes as an official report of the director; and

16 (d) Summon and examine under oath a key individual or employee of a licensee
17 or authorized delegate and require the person to produce records regarding
18 any matter related to the condition and business of the licensee or
19 authorized delegate.

20 (2) A licensee or authorized delegate must provide, and the director must have full
21 and complete access to, all records the director may reasonably require to conduct
22 a complete examination. The records must be provided at the location and in the
23 format specified by the director, provided the director may utilize multistate record
24 production standards and examination procedures when such standards will
25 reasonably achieve the requirements of this section.

26 (3) Unless otherwise directed by the director, a licensee must pay all costs reasonably
27 incurred in connection with an examination of the licensee or the licensee's
28 authorized delegates.

29 **Section 6. That chapter 51A-17 be amended with a NEW SECTION:**

30 (1) To efficiently and effectively administer and enforce this Act and to minimize
31 regulatory burden, the director is authorized and encouraged to participate in
32 multistate supervisory processes established between states and coordinated
33 through the Conference of State Bank Supervisors, Money Transmitter Regulators
34 Association, and affiliates and successors thereof for all licensees that hold licenses

1 in this state and other states. As a participant in multistate supervision, the director
2 may:

3 (a) Cooperate, coordinate, and share information with other state and federal
4 regulators in accordance with section 4 of this Act;

5 (b) Enter into written cooperation, coordination, or information-sharing
6 contracts or agreements with organizations the membership of which is
7 made up of state or federal governmental agencies; and

8 (c) Cooperate, coordinate, and share information with organizations the
9 membership of which is made up of state or federal governmental agencies,
10 provided that the organizations agree in writing to maintain the
11 confidentiality and security of the shared information in accordance with
12 section 4 of this Act.

13 (2) The director may not waive, and nothing in this section constitutes a waiver of, the
14 director's authority to conduct an examination or investigation or otherwise take
15 independent action authorized by this Act or a rule adopted or order issued under
16 this Act to enforce compliance with applicable state or federal law.

17 (3) A joint examination or investigation, or acceptance of an examination or
18 investigation report, does not waive an examination assessment provided for in
19 this Act.

20 **Section 7. That chapter 51A-17 be amended with a NEW SECTION:**

21 (1) In the event state money transmission jurisdiction is conditioned on a federal law,
22 any inconsistencies between a provision of this Act and the federal law governing
23 money transmission shall be governed by the applicable federal law to the extent
24 of the inconsistency.

25 (2) In the event of any inconsistencies between this Act and a federal law that governs
26 pursuant to this section, the director may provide interpretive guidance that:

27 (a) Identifies the inconsistency; and

28 (b) Identifies the appropriate means of compliance with federal law.

29 **Section 8. That chapter 51A-17 be amended with a NEW SECTION:**

30 (1) A person may not engage in the business of money transmission or advertise,
31 solicit, or hold itself out as providing money transmission unless the person is
32 licensed under this Act.

33 (2) This section does not apply to:

- 1 (a) A person that is an authorized delegate of a person licensed under this Act
2 acting within the scope of authority conferred by a written contract with the
3 licensee; or
4 (b) A person that is exempt pursuant to section 2 of this Act and does not
5 engage in money transmission outside the scope of such exemption.
6 (3) A license issued under sections 13 through 18 of this Act, inclusive, is not
7 transferable or assignable.

8 **Section 9. That chapter 51A-17 be amended with a NEW SECTION:**

- 9 (1) To establish consistent licensing between this state and other states, the director
10 is authorized and encouraged to:
11 (a) Implement all licensing provisions of this Act in a manner that is consistent
12 with other states that have adopted this Act or multistate licensing
13 processes; and
14 (b) Participate in nationwide protocols for licensing cooperation and
15 coordination among state regulators provided that such protocols are
16 consistent with this Act.
17 (2) In order to fulfill the purposes of this Act, the director is authorized and encouraged
18 to establish relationships or contracts with NMLS or other entities designated by
19 NMLS to enable the director to:
20 (a) Collect and maintain records;
21 (b) Coordinate multistate licensing processes and supervision processes;
22 (c) Process fees; and
23 (d) Facilitate communication between the division and licensees or other
24 persons subject to this Act.
25 (3) The director is authorized and encouraged to utilize NMLS for all aspects of licensing
26 in accordance with this Act, including, but not limited to, license applications,
27 applications for acquisitions of control, surety bonds, reporting, criminal history
28 background checks, credit checks, fee processing, and examinations.
29 (4) The director is authorized and encouraged to utilize NMLS forms, processes, and
30 functionalities in accordance with this Act. In the event NMLS does not provide
31 functionality, forms, or processes for a provision of this Act, the director is
32 authorized and encouraged to strive to implement the requirements in a manner
33 that facilitates uniformity with respect to licensing, supervision, reporting, and
34 regulation of licensees which are licensed in multiple jurisdictions.

1 (5) For the purpose of participating in the Nationwide Multistate Licensing System and
2 Registry, the director is authorized to waive or modify, in whole or in part, by rule,
3 regulation or order, any or all of the requirements and to establish new
4 requirements as reasonably necessary to participate in the Nationwide Multistate
5 Licensing System and Registry.

6 **Section 10. That chapter 51A-17 be amended with a NEW SECTION:**

7 (1) Applicants for a license must apply in a form and in a medium as prescribed by the
8 director. Each form must contain content as set forth by rule, regulation,
9 instruction, or procedure of the director and may be changed or updated by the
10 director in accordance with applicable law in order to carry out the purposes of this
11 Act and maintain consistency with NMLS licensing standards and practices. The
12 application must state or contain, as applicable:

13 (a) The legal name and residential and business addresses of the applicant and
14 any fictitious or trade name used by the applicant in conducting its business;

15 (b) A list of any criminal convictions of the applicant and any material litigation
16 in which the applicant has been involved in the ten-year period next
17 preceding the submission of the application;

18 (c) A description of any money transmission previously provided by the
19 applicant and the money transmission that the applicant seeks to provide
20 in this state;

21 (d) A list of the applicant's proposed authorized delegates and the locations in
22 this state where the applicant and its authorized delegates propose to
23 engage in money transmission;

24 (e) A list of other states in which the applicant is licensed to engage in money
25 transmission and any license revocations, suspensions, or other disciplinary
26 action taken against the applicant in another state;

27 (f) Information concerning any bankruptcy or receivership proceedings
28 affecting the licensee or a person in control of a licensee;

29 (g) A sample form of contract for authorized delegates, if applicable;

30 (h) A sample form of payment instrument or stored value, as applicable;

31 (i) The name and address of any federally insured depository financial
32 institution through which the applicant plans to conduct money
33 transmission; and

- 1 (j) Any other information the director or NMLS reasonably requires with respect
2 to the applicant.
- 3 (2) If an applicant is a corporation, limited liability company, partnership, or other legal
4 entity, the applicant must also provide:
- 5 (a) The date of the applicant's incorporation or formation and state or country
6 of incorporation or formation;
- 7 (b) If applicable, a certificate of good standing from the state or country in
8 which the applicant is incorporated or formed;
- 9 (c) A brief description of the structure or organization of the applicant, including
10 any parents or subsidiaries of the applicant, and whether any parents or
11 subsidiaries are publicly traded;
- 12 (d) The legal name, any fictitious or trade name, all business and residential
13 addresses, and the employment, as applicable, in the ten-year period next
14 preceding the submission of the application of each key individual and
15 person in control of the applicant;
- 16 (e) A list of any criminal convictions and material litigation in which a person in
17 control of the applicant that is not an individual has been involved in the
18 ten-year period preceding the submission of the application;
- 19 (f) A copy of audited financial statements of the applicant for the most recent
20 fiscal year and for the two-year period next preceding the submission of the
21 application or, if determined to be acceptable to the director, certified
22 unaudited financial statements for the most recent fiscal year or other
23 period acceptable to the director;
- 24 (g) A certified copy of unaudited financial statements of the applicant for the
25 most recent fiscal quarter;
- 26 (h) If the applicant is a publicly traded corporation, a copy of the most recent
27 report filed with the United States Securities and Exchange Commission
28 under Section 13 of the federal Securities Exchange Act of 1934, 15 U.S.C.
29 § 78m (January 1, 2024);
- 30 (i) If the applicant is a wholly owned subsidiary of a corporation publicly traded
31 in the United States, a copy of audited financial statements for the parent
32 corporation for the most recent fiscal year or a copy of the parent
33 corporation's most recent report filed under Section 13 of the U.S. Securities
34 Exchange Act of 1934, 15 U.S.C. § 78m (January 1, 2024) or for a
35 corporation publicly traded outside the United States, a copy of similar

- 1 documentation filed with the regulator of the parent corporation's domicile
2 outside the United States;
3 (j) The name and address of the applicant's registered agent in this state; and
4 (k) Any other information the director reasonably requires with respect to the
5 applicant.
6 (3) Each application must be accompanied by a nonrefundable application fee not to
7 exceed five hundred dollars and a license fee not to exceed one thousand dollars.
8 The license fee must be refunded if the application is denied. The director shall
9 establish the application and license fees by rules promulgated pursuant to chapter
10 1-26.
11 (4) The director may waive one or more requirements of this section or permit an
12 applicant to submit other information in lieu of the required information.

13 **Section 11. That chapter 51A-17 be amended with a NEW SECTION:**

- 14 Any individual in control of a licensee or applicant or any individual that seeks to
15 acquire control of a licensee, or each key individual must furnish to the director through
16 NMLS the following items:
17 (1) The individual's fingerprints for submission to the Federal Bureau of Investigation
18 and the director for purposes of a national criminal history background check,
19 unless the person currently resides outside of the United States and has resided
20 outside of the United States for the last ten years; and
21 (2) Personal history and experience in a form and in a medium prescribed by the
22 director to obtain the following:
23 (a) An independent credit report from a consumer reporting agency unless the
24 individual does not have a Social Security number, in which case, this
25 requirement shall be waived;
26 (b) Information related to any criminal convictions or pending charges; and
27 (c) Information related to any regulatory or administrative action and any civil
28 litigation involving claims of fraud, misrepresentation, conversion,
29 mismanagement of funds, breach of fiduciary duty, or breach of contract.

30 **Section 12. That chapter 51A-17 be amended with a NEW SECTION:**

- 31 If any individual in control of a licensee or applicant or any individual that seeks to
32 acquire control of a licensee or each key individual has resided outside of the United States
33 at any time in the last ten years, the individual must also provide an investigative

1 background report prepared by an independent search firm that meets the following
2 requirements:

3 (1) At a minimum, the search firm shall:

4 (a) Demonstrate that the search firm has sufficient knowledge, resources, and
5 employs accepted and reasonable methodologies to conduct the research
6 of the background report; and

7 (b) Not be affiliated with or have an interest with the individual the search firm
8 is researching, and

9 (2) At a minimum, the investigative background report must be written in the English
10 language and must contain the following:

11 (a) If available in the individual's current jurisdiction of residency, a
12 comprehensive credit report or any equivalent information obtained or
13 generated by the independent search firm to accomplish the report,
14 including a search of the court data in the countries, provinces, states,
15 cities, towns, and contiguous areas where the individual resided and
16 worked;

17 (b) Criminal records information for the past ten years, including, but not
18 limited to, felonies, misdemeanors, or similar convictions for violations of
19 law in the countries, provinces, states, cities, towns, and contiguous areas
20 where the individual resided and worked;

21 (c) Employment history;

22 (d) Media history, including an electronic search of national and local
23 publications, wire services, and business applications; and

24 (e) Financial services-related regulatory history, including but not limited to,
25 money transmission, securities, banking, insurance, and mortgage-related
26 industries.

27 **Section 13. That chapter 51A-17 be amended with a NEW SECTION:**

28 When an application for an original license under this Act appears to include all the
29 items and addresses all of the matters that are required, the application is complete, and
30 the director must promptly notify the applicant in a record of the date on which the
31 application is determined to be complete.

32 (1) The director must approve or deny the application within one hundred twenty days
33 after the completion date; or

1 (2) If the application is not approved or denied within one hundred twenty days after
2 the completion date:

3 (a) The application is approved; and

4 (b) The license takes effect as of the first business day after expiration of the
5 one hundred twenty-day period.

6 (c) The director may for good cause extend the application period.

7 **Section 14. That chapter 51A-17 be amended with a NEW SECTION:**

8 A determination by the director that an application is complete and is accepted for
9 processing means only that the application, on its face, appears to include all of the items,
10 including the criminal background check response from the FBI, addresses all of the
11 matters that are required, and is not an assessment of the substance of the application or
12 of the sufficiency of the information provided.

13 **Section 15. That chapter 51A-17 be amended with a NEW SECTION:**

14 When an application is filed and considered complete under sections 13 and 14 of
15 this Act, the director must investigate the applicant's financial condition and responsibility,
16 financial and business experience, character, and general fitness. The director may
17 conduct an on-site investigation of the applicant, the reasonable cost of which the
18 applicant must pay. The director must issue a license to an applicant under sections 13 to
19 18, inclusive, of this Act, if the director finds that all of the following conditions have been
20 fulfilled:

21 (1) The applicant has complied with sections 10 to 12, inclusive, of this Act; and

22 (2) The financial condition and responsibility, financial and business experience,
23 competence, character, and general fitness of the applicant; and the competence,
24 experience, character, and general fitness of the key individuals and persons in
25 control of the applicant indicate that it is in the interest of the public to permit the
26 applicant to engage in money transmission.

27 **Section 16. That chapter 51A-17 be amended with a NEW SECTION:**

28 If an applicant avails itself or is otherwise subject to a multistate licensing process:

29 (1) The director is authorized and encouraged to accept the investigation results of a
30 lead investigative state for the purpose of section 15 of this Act if the lead
31 investigative state has sufficient staffing, expertise, and minimum standards; or

1 (2) If the division is a lead investigative state, the director is authorized and
2 encouraged to investigate the applicant pursuant to section 15 of this Act and the
3 timeframes established by agreement through the multistate licensing process,
4 provided, however, that in no case shall such a timeframe be noncompliant with
5 the application period in section 13 of this Act.

6 **Section 17. That chapter 51A-17 be amended with a NEW SECTION:**

7 The director shall issue a formal written notice of the denial of a license application
8 within thirty days of the decision to deny the application. The director shall set forth in the
9 notice of denial the specific reasons for the denial of the application. An applicant whose
10 application is denied by the director under this section may appeal within thirty days after
11 receipt of the written notice of the denial pursuant to chapter 1-26.

12 **Section 18. That chapter 51A-17 be amended with a NEW SECTION:**

13 The initial license term begins on the day the application is approved. The license
14 shall expire on December thirty-first of the year in which the license term began, unless
15 the initial license date is between November first and December thirty-first, in which
16 instance the initial license term runs through December thirty-first of the following year.

17 **Section 19. That chapter 51A-17 be amended with a NEW SECTION:**

18 (1) A license under this Act shall be renewed annually.
19 (a) The director shall establish an annual renewal fee, not to exceed one
20 thousand dollars, by rule promulgated pursuant to chapter 1-26.
21 (b) The annual renewal fee must be paid no more than sixty days before the
22 license expiration.
23 (c) The renewal term shall be for a period of one year and shall begin on
24 January first of each year after the initial license term and shall expire on
25 December thirty-first of the year the renewal term begins.
26 (2) A licensee shall submit a renewal report with the renewal fee in a form and in a
27 medium prescribed by the director. The renewal report must state or contain a
28 description of each material change in information submitted by the licensee in its
29 original license application which has not been reported to the director.
30 (3) The director for good cause may grant an extension of the renewal date.

- 1 (4) The director is authorized and encouraged to utilize NMLS to process license
2 renewals provided that such functionality is consistent with this section.

3 **Section 20. That chapter 51A-17 be amended with a NEW SECTION:**

4 Maintenance of License.

- 5 (1) If a licensee does not continue to meet the qualifications or satisfy the
6 requirements that apply to an applicant for a new money transmission license, the
7 director may suspend or revoke the licensee's license in accordance with the
8 procedures established by this Act or other applicable state law for the suspension
9 or revocation.
- 10 (2) An applicant for a money transmission license must demonstrate that it meets or
11 will meet, and a money transmission licensee must at all times meet, the
12 requirements in sections 48 to 50, inclusive, of this Act.

13 **Section 21. That chapter 51A-17 be amended with a NEW SECTION:**

- 14 (1) Any person, or group of persons acting in concert, seeking to acquire control of a
15 licensee must obtain the written approval of the director prior to acquiring control.
16 An individual is not deemed to acquire control of a licensee and is not subject to
17 these acquisition of control provisions when that individual becomes a key
18 individual in the ordinary course of business.
- 19 (2) A person, or group of persons acting in concert, seeking to acquire control of a
20 licensee must, in cooperation with the licensee:
- 21 (a) Submit an application in a form and in a medium prescribed by the director;
22 and
- 23 (b) Submit a nonrefundable fee not to exceed one thousand dollars. The
24 director shall establish the fee by rule promulgated pursuant to chapter 1-
25 26.
- 26 (3) Upon request, the director may permit a licensee or the person, or group of persons
27 acting in concert, to submit some or all information required by the director
28 pursuant to this section without using NMLS.
- 29 (4) The application required by this section shall include information required by
30 sections 11 and 12 of this Act for any new key individuals that have not previously
31 completed the requirements of sections 11 and 12 of this Act for a licensee.

32 **Section 22. That chapter 51A-17 be amended with a NEW SECTION:**

1 When an application for acquisition of control under section 21 of this Act appears
2 to include all the items and address all of the matters that are required, the application
3 shall be considered complete and the director shall promptly notify the applicant in a
4 record of the date on which the application was determined to be complete and:

5 (1) The director shall approve or deny the application within sixty days after the
6 completion date; or

7 (2) If the application is not approved or denied within sixty days after the completion
8 date:

9 (a) The application is approved; and

10 (b) The person, or group of persons acting in concert, are not prohibited from
11 acquiring control.

12 (3) The director may for good cause extend the application period.

13 **Section 23. That chapter 51A-17 be amended with a NEW SECTION:**

14 A determination by the director that an application for acquisition of control under
15 section 21 of this Act is complete and is accepted for processing means only that the
16 application, on its face, appears to include all of the items and address all of the matters
17 that are required, and is not an assessment of the substance of the application or of the
18 sufficiency of the information provided.

19 **Section 24. That chapter 51A-17 be amended with a NEW SECTION:**

20 When an application for acquisition of control under section 21 of this Act is filed
21 and considered complete under section 22 of this Act, the director must investigate the
22 financial condition and responsibility, financial and business experience, character, and
23 general fitness of the person, or group of persons acting in concert, seeking to acquire
24 control. The director shall approve an acquisition of control pursuant to this section 21 of
25 this Act if the director finds that all of the following conditions have been fulfilled:

26 (1) The requirements of subdivisions (2) and (4) of section 21 of this Act have been
27 met, as applicable; and

28 (2) The financial condition and responsibility, financial and business experience,
29 competence, character, and general fitness of the person, or group of persons
30 acting in concert, seeking to acquire control; and the competence, experience,
31 character, and general fitness of the key individuals and persons that would be in
32 control of the licensee after the acquisition of control indicate that it is in the

1 interest of the public to permit the person, or group of persons acting in concert,
2 to control the licensee.

3 **Section 25. That chapter 51A-17 be amended with a NEW SECTION:**

4 If an applicant for acquisition of control under this section 21 of this Act avails itself
5 or is otherwise subject to a multistate licensing process:

6 (1) The director is authorized and encouraged to accept the investigation results of a
7 lead investigative state for the purpose of section 22 of this Act if the lead
8 investigative state has sufficient staffing, expertise, and minimum standards; or

9 (2) If this state is a lead investigative state, the director is authorized and encouraged
10 to investigate the applicant pursuant to section 22 of this Act and the timeframes
11 established by agreement through the multistate licensing process.

12 **Section 26. That chapter 51A-17 be amended with a NEW SECTION:**

13 The director shall issue a formal written notice of the denial of an application to
14 acquire control within thirty days of the decision to deny the application. The director must
15 set forth in the notice of denial the specific reasons for the denial of the application. An
16 applicant whose application is denied by the director under this section may appeal within
17 thirty days after receipt of the written notice of the denial pursuant to chapter 1-26.

18 **Section 27. That chapter 51A-17 be amended with a NEW SECTION:**

19 The requirements of subdivisions (1) and (2) of section 21 of this Act do not apply
20 to any of the following:

21 (1) A person that acts as a proxy for the sole purpose of voting at a designated meeting
22 of the shareholders or holders of voting shares or voting interests of a licensee or
23 a person in control of a licensee;

24 (2) A person that acquires control of a licensee by devise or descent;

25 (3) A person that acquires control of a licensee as a personal representative, custodian,
26 guardian, conservator, or trustee, or as an officer appointed by a court of
27 competent jurisdiction or by operation of law;

28 (4) A person that is exempt under subdivision (7) of section 2 of this Act;

29 (5) A person that the director determines is not subject to subdivision (1) of section
30 21 of this Act based on the public interest;

31 (6) A public offering of securities of a licensee or a person in control of a licensee; or

1 (7) An internal reorganization of a person in control of the licensee where the ultimate
2 person in control of the licensee remains the same.

3 **Section 28. That chapter 51A-17 be amended with a NEW SECTION:**

4 Persons in section 27 of this Act in cooperation with the licensee shall notify the
5 director within fifteen days after the acquisition of control.

6 **Section 29. That chapter 51A-17 be amended with a NEW SECTION:**

7 (1) The requirements in subdivisions (1) and (2) of section 21 of this Act do not apply
8 to a person that has complied with and received approval to engage in money
9 transmission under this Act or was identified as a person in control in a prior
10 application filed with and approved by the director or by an MSB accredited state
11 pursuant to a multistate licensing process, provided that:

12 (a) The person has not had a license revoked or suspended or controlled a
13 licensee that has had a license revoked or suspended while the person was
14 in control of the licensee in the previous five years;

15 (b) If the person is a licensee, the person is well managed and has received at
16 least a satisfactory rating for compliance at its most recent examination by
17 an MSB accredited state if such rating was given;

18 (c) The licensee to be acquired is projected to meet the requirements of
19 sections 48 to 50, inclusive, of this Act after the acquisition of control is
20 completed, and if the person acquiring control is a licensee, that licensee is
21 also projected to meet the requirements of sections 49 to 51, inclusive, of
22 this Act after the acquisition of control is completed;

23 (d) The licensee to be acquired will not implement any material changes to its
24 business plan as a result of the acquisition of control, and if the person
25 acquiring control is a licensee, that licensee also will not implement any
26 material changes to its business plan as a result of the acquisition of control;
27 and

28 (e) The person provides notice of the acquisition in cooperation with the
29 licensee and attests to subsections (a) through (d) in this section in a form
30 and in a medium prescribed by the director.

31 (2) If the notice is not disapproved within thirty days after the date on which the notice
32 was determined to be complete, the notice is deemed approved.

1 **Section 30. That chapter 51A-17 be amended with a NEW SECTION:**

2 Before filing an application for approval to acquire control of a licensee a person
3 may request in writing a determination from the director as to whether the person would
4 be considered a person in control of a licensee upon consummation of a proposed
5 transaction. If the director determines that the person would not be a person in control of
6 a licensee, the proposed person and transaction is not subject to the requirements of
7 subdivisions (1) and (2) of section 21 of this Act.

8 **Section 31. That chapter 51A-17 be amended with a NEW SECTION:**

9 If a multistate licensing process includes a determination pursuant to section 30 of
10 this Act and an applicant avails itself or is otherwise subject to the multistate licensing
11 process:

12 (1) The director is authorized and encouraged to accept the control determination of a
13 lead investigative state with sufficient staffing, expertise, and minimum standards
14 for the purpose of section 30 of this Act; or

15 (2) If this state is a lead investigative state, the director is authorized and encouraged
16 to investigate the applicant pursuant to section 30 of this Act and the timeframes
17 established by agreement through the multistate licensing process.

18 **Section 32. That chapter 51A-17 be amended with a NEW SECTION:**

19 (1) A licensee adding or replacing any key individual must:

20 (a) Provide notice in a manner prescribed by the director within fifteen days
21 after the effective date of the key individual's appointment; and

22 (b) Provide information as required by sections 11 and 12 of this Act within
23 forty-five days of the effective date.

24 (2) Within ninety days of the date on which the notice provided pursuant to this section
25 was determined to be complete, the director may issue a notice of disapproval of
26 a key individual if the competence, experience, character, or integrity of the
27 individual would not be in the best interests of the public or the customers of the
28 licensee to permit the individual to be a key individual of such licensee.

29 (3) A notice of disapproval must contain a statement of the basis for disapproval and
30 shall be sent to the licensee and the disapproved individual. A licensee may appeal
31 a notice of disapproval pursuant chapter 1-26 within thirty days of receipt of such
32 notice of disapproval.

1 (4) If the notice provided pursuant to this section is not disapproved within ninety days
2 after the date on which the notice was determined to be complete, the key
3 individual is deemed approved.

4 (5) If a multistate licensing process includes a key individual notice review and
5 disapproval process pursuant to this section and the licensee avails itself or is
6 otherwise subject to the multistate licensing process:

7 (a) The director is authorized and encouraged to accept the determination of
8 another state if the investigating state has sufficient staffing, expertise, and
9 minimum standards for the purpose of this section; or

10 (b) If this state is a lead investigative state, the director is authorized and
11 encouraged to investigate the applicant pursuant to this section and the
12 timeframes established by agreement through the multistate licensing
13 process.

14 **Section 33. That chapter 51A-17 be amended with a NEW SECTION:**

15 (1) Each licensee must submit a report of condition within forty-five days of the end of
16 the calendar quarter, or within any extended time as the director may prescribe.

17 (2) The report of condition must include:

18 (a) Financial information at the licensee level;

19 (b) Nationwide and state-specific money transmission transaction information
20 in every jurisdiction in the United States where the licensee is licensed to
21 engage in money transmission;

22 (c) Permissible investments report;

23 (d) Transaction destination country reporting for money received for
24 transmission, if applicable; and

25 (e) Any other information the director reasonably requires with respect to the
26 licensee. The director is authorized and encouraged to utilize NMLS for the
27 submission of the report required by subdivision (1) of this section and is
28 authorized to change or update as necessary the requirements of this
29 section to carry out the purposes of this Act and maintain consistency with
30 NMLS reporting.

31 (3) The information required by subsection 2(d) of this section shall only be included
32 in a report of condition submitted within forty-five days of the end of the fourth
33 calendar quarter.

1 **Section 34. That chapter 51A-17 be amended with a NEW SECTION:**

2 (1) Each licensee shall, within ninety days after the end of each fiscal year, or within
3 any extended time as the director may prescribe, file with the director:

4 (a) An audited financial statement of the licensee for the fiscal year prepared
5 in accordance with United States generally accepted accounting principles;
6 and

7 (b) Any other information as the director may reasonably require.

8 (2) The audited financial statements shall be prepared by an independent certified
9 public accountant or independent public accountant who is satisfactory to the
10 director.

11 (3) The audited financial statements shall include or be accompanied by a certificate
12 of opinion of the independent certified public accountant or independent public
13 accountant that is satisfactory in form and content to the director. If the certificate
14 of opinion is qualified, the director may order the licensee to take any action as the
15 director may find necessary to enable the independent or certified public
16 accountant or independent public accountant to remove the qualification.

17 **Section 35. That chapter 51A-17 be amended with a NEW SECTION:**

18 (1) Each licensee must submit a report of authorized delegates within forty-five days
19 of the end of the calendar quarter. The director is authorized and encouraged to
20 utilize NMLS for the submission of the report required by this section provided that
21 such functionality is consistent with the requirements of this section.

22 (2) The authorized delegate report must include, at a minimum, each authorized
23 delegate's:

24 (a) Company legal name;

25 (b) Taxpayer employer identification number;

26 (c) Principal provider identifier;

27 (d) Physical address;

28 (e) Mailing address;

29 (f) Any business conducted in other states;

30 (g) Any fictitious or trade name;

31 (h) Contact person name, phone number, and email;

32 (i) Start date as licensee's authorized delegate;

33 (j) End date acting as licensee's authorized delegate, if applicable;

- 1 (k) Court orders pursuant to section 41 of this Act; and
2 (l) Any other information the director reasonably requires with respect to the
3 authorized delegate.

4 **Section 36. That chapter 51A-17 be amended with a NEW SECTION:**

- 5 (1) A licensee must file a report with the director within one business day after the
6 licensee has reason to know of the occurrence of any of the following events:
7 (a) The filing of a petition by or against the licensee under the United States
8 Bankruptcy Code, 11 U.S.C. § 101-110 (January 1, 2024) for bankruptcy or
9 reorganization;
10 (b) The filing of a petition by or against the licensee for receivership, the
11 commencement of any other judicial or administrative proceeding for its
12 dissolution or reorganization, or the making of a general assignment for the
13 benefit of its creditors; or
14 (c) The commencement of a proceeding to revoke or suspend its license in a
15 state or country in which the licensee engages in business or is licensed.
16 (2) A licensee must file a report with the director within three business day after the
17 licensee has reason to know of the occurrence of any of the following events:
18 (a) A charge or conviction of the licensee or of a key individual or person in
19 control of the licensee for a felony; or
20 (b) A charge or conviction of an authorized delegate for a felony.

21 **Section 37. That chapter 51A-17 be amended with a NEW SECTION:**

22 A licensee and its authorized delegates must file all reports required by federal
23 currency reporting, record keeping, and suspicious activity reporting requirements as set
24 forth in the Bank Secrecy Act and other federal and state laws pertaining to money
25 laundering. The timely filing of a complete and accurate report required under this section
26 with the appropriate federal agency is deemed compliant with the requirements of this
27 section.

28 **Section 38. That chapter 51A-17 be amended with a NEW SECTION:**

- 29 (1) Licensee shall maintain the following records, for determining its compliance with
30 this Act for at least three years:
31 (a) A record of each outstanding money transmission obligation sold;

- 1 (b) A general ledger posted at least monthly containing all asset, liability,
2 capital, income, and expense accounts;
3 (c) Bank statements and bank reconciliation records;
4 (d) Records of outstanding money transmission obligations;
5 (e) Records of each outstanding money transmission obligation paid within the
6 three-year period;
7 (f) A list of the last known names and addresses of all of the licensee's
8 authorized delegates; and
9 (g) Any other records the director reasonably requires by rule.
10 (2) The items specified in subdivision (1) of this section may be maintained in any form
11 of record.
12 (3) Records specified in subdivision (1) of this section may be maintained outside this
13 state if the records are made accessible to the director on seven business-days'
14 notice that is sent in a record.
15 (4) All records maintained by the licensee as required in this section are open to
16 inspection by the director pursuant to subdivision (1) of section 5 of this Act.

17 **Section 39. That chapter 51A-17 be amended with a NEW SECTION:**

- 18 (1) In this section, "remit" means to make direct payments of money to a licensee or
19 its representative authorized to receive money or to deposit money in a bank in an
20 account specified by the licensee.
21 (2) Before a licensee is authorized to conduct business through an authorized delegate
22 or allows a person to act as the licensee's authorized delegate, the licensee must:
23 (a) Adopt, and update as necessary, written policies and procedures reasonably
24 designed to ensure that the licensee's authorized delegates comply with
25 applicable state and federal law;
26 (b) Enter into a written contract that complies with subdivision (4) of this
27 section; and
28 (c) Conduct a reasonable risk-based background investigation sufficient for the
29 licensee to determine whether the authorized delegate has complied and
30 will likely comply with applicable state and federal law.
31 (3) An authorized delegate must operate in full compliance with this Act.
32 (4) The written contract required by subdivision (2) of this section must be signed by
33 the licensee and the authorized delegate and, at a minimum, must:

- 1 (a) Appoint the person signing the contract as the licensee's authorized
2 delegate with the authority to conduct money transmission on behalf of the
3 licensee;
- 4 (b) Set forth the nature and scope of the relationship between the licensee and
5 the authorized delegate and the respective rights and responsibilities of the
6 parties;
- 7 (c) Require the authorized delegate to agree to fully comply with all applicable
8 state and federal laws, rules, and regulations pertaining to money
9 transmission, including this Act and regulations implementing this Act,
10 relevant provisions of the Bank Secrecy Act and the other federal and state
11 laws pertaining to money laundering;
- 12 (d) Require the authorized delegate to remit and handle money and monetary
13 value in accordance with the terms of the contract between the licensee and
14 the authorized delegate;
- 15 (e) Impose a trust on money and monetary value net of fees received for
16 money transmission for the benefit of the licensee;
- 17 (f) Require the authorized delegate to prepare and maintain records as
18 required by this Act or regulations implementing this Act, or as reasonably
19 requested by the director;
- 20 (g) Acknowledge that the authorized delegate consents to examination or
21 investigation by the director;
- 22 (h) State that the licensee is subject to regulation by the director and that, as
23 part of that regulation, the director may suspend or revoke an authorized
24 delegate designation or require the licensee to terminate an authorized
25 delegate designation; and
- 26 (i) Acknowledge receipt of the written policies and procedures required under
27 subsection 2(a) of this section.
- 28 (5) If the licensee's license is suspended, revoked, surrendered, or expired, the
29 licensee must, within five business days, provide documentation to the director
30 that the licensee has notified all applicable authorized delegates of the licensee
31 whose names are in a record filed with the director of the suspension, revocation,
32 surrender, or expiration of a license. Upon suspension, revocation, surrender, or
33 expiration of a license, applicable authorized delegates shall immediately cease to
34 provide money transmission as an authorized delegate of the licensee.

- 1 (6) An authorized delegate of a licensee holds in trust for the benefit of the licensee
2 all money net of fees received from money transmission. If any authorized delegate
3 commingles any funds received from money transmission with any other funds or
4 property owned or controlled by the authorized delegate, all commingled funds and
5 other property shall be considered held in trust in favor of the licensee in an amount
6 equal to the amount of money net of fees received from money transmission.
7 (7) An authorized delegate may not use a subdelegate to conduct money transmission
8 on behalf of a licensee.

9 **Section 40. That chapter 51A-17 be amended with a NEW SECTION:**

10 A person shall not engage in the business of money transmission on behalf of a
11 person not licensed under this Act or not exempt pursuant to section 2 of this Act. A
12 person that engages in such activity, provides money transmission to the same extent as
13 if the person were a licensee, shall be jointly and severally liable with the unlicensed or
14 nonexempt person.

15 **Section 41. That chapter 51A-17 be amended with a NEW SECTION:**

- 16 (1) The circuit court in an action brought by a licensee shall have jurisdiction to grant
17 appropriate equitable or legal relief, including without limitation prohibiting the
18 authorized delegate from directly or indirectly acting as an authorized delegate for
19 any licensee in this state and the payment of restitution, damages, or other
20 monetary relief if the circuit court finds that an authorized delegate failed to remit
21 money in accordance with the written contract required by subdivision (2) of
22 section 39 of this Act or as otherwise directed by the licensee or required by law.
23 (2) If the circuit court issues an order prohibiting a person from acting as an authorized
24 delegate for any licensee pursuant to subdivision (1) of this section, the licensee
25 that brought the action must report the order to the director within thirty days and
26 must report the order through NMLS within ninety days.
27 (3) An authorized delegate who holds money in trust for the benefit of a licensee and
28 knowingly fails to remit more than two thousand, five hundred dollars of such
29 money is guilty of a Class 6 felony.
30 (4) An authorized delegate who holds money in trust for the benefit of a licensee and
31 knowingly fails to remit no more than two thousand, five hundred dollars of such
32 money is guilty of a Class 1 misdemeanor.

1 **Section 42. That chapter 51A-17 be amended with a NEW SECTION:**

2 (1) Every licensee shall forward all money received for transmission in accordance with
3 the terms of the agreement between the licensee and the sender unless the
4 licensee has a reasonable belief or a reasonable basis to believe that the sender
5 may be a victim of fraud or that a crime or violation of law, rule, or regulation has
6 occurred, is occurring, or may occur.

7 (2) If a licensee fails to forward money received for transmission in accordance with
8 this section, the licensee must respond to inquiries by the sender with the reason
9 for the failure unless providing a response would violate a state or federal law, rule,
10 or regulation.

11 **Section 43. That chapter 51A-17 be amended with a NEW SECTION:**

12 (1) This section does not apply to:

13 (a) Money received for transmission subject to the federal Remittance Rule, 12
14 C.F.R. § 1005.30 to § 1005.36, inclusive (January 1, 2024); or

15 (b) Money received for transmission pursuant to a written agreement between
16 the licensee and payee to process payments for goods or services provided
17 by the payee.

18 (2) Every licensee shall refund to the sender within ten days of receipt of the sender's
19 written request for a refund of any and all money received for transmission unless
20 any of the following occurs:

21 (a) The money has been forwarded within ten days of the date on which the
22 money was received for transmission;

23 (b) Instructions have been given committing an equivalent amount of money
24 to the person designated by the sender within ten days of the date on which
25 the money was received for transmission;

26 (c) The agreement between the licensee and the sender instructs the licensee
27 to forward the money at a time that is beyond ten days of the date on which
28 the money was received for transmission. If funds have not yet been
29 forwarded in accordance with the terms of the agreement between the
30 licensee and the sender, the licensee shall issue a refund in accordance with
31 the other provisions of this section; or

32 (d) The refund is requested for a transaction that the licensee has not
33 completed based on a reasonable belief or a reasonable basis to believe

1 that a crime or violation of law, rule, or regulation has occurred, is
2 occurring, or may occur.

3 (e) The refund request does not enable the licensee to identify the sender's
4 name and address or telephone number or identify the particular
5 transaction to be refunded in the event the sender has multiple transactions
6 outstanding.

7 **Section 44. That chapter 51A-17 be amended with a NEW SECTION:**

8 (1) Section 45 does not apply to:

9 (a) Money received for transmission subject to the federal Remittance Rule, 12
10 C.F.R. Part 1005 Subpart B (January 1, 2024);

11 (b) Money received for transmission that is not primarily for personal, family,
12 or household purposes;

13 (c) Money received for transmission pursuant to a written agreement between
14 the licensee and payee to process payments for goods or services provided
15 by the payee; or

16 (d) Payroll processing services.

17 (2) For purposes of this Act, the term "receipt" means a paper receipt, electronic
18 record, or other written confirmation. For a transaction conducted in person, the
19 receipt may be provided electronically if the sender requests or agrees to receive
20 an electronic receipt. For a transaction conducted electronically or by phone, a
21 receipt may be provided electronically. All electronic receipts shall be provided in
22 a retainable form.

23 **Section 45. That chapter 51A-17 be amended with a NEW SECTION:**

24 Every licensee or its authorized delegate shall provide the sender a receipt for
25 money received for transmission.

26 (1) The receipt shall contain the following information, as applicable:

27 (a) The name of the sender;

28 (b) The name of the designated recipient;

29 (c) The date of the transaction;

30 (d) The unique transaction or identification number;

31 (e) The name of the licensee, NMLS Unique ID, the licensee's business address,
32 and the licensee's customer service telephone number;

33 (f) The amount of the transaction in United States dollars;

- 1 (g) Any fee charged by the licensee to the sender for the transaction; and
 2 (h) Any taxes collected by the licensee from the sender for the transaction.
 3 (2) The receipt required by this section must be in English and in the language
 4 principally used by the licensee or authorized delegate to advertise, solicit, or
 5 negotiate, either orally or in writing, for a transaction conducted in person,
 6 electronically, or by phone, if other than English.

7 **Section 46. That chapter 51A-17 be amended with a NEW SECTION:**

- 8 In addition to the contact information required in subsection (1)(e) of section 45
 9 of this Act, every licensee or authorized delegate must include on a receipt or disclose on
 10 the licensee's website or mobile application the name and phone number of the division
 11 and a statement that the licensee's customers can contact the division with questions or
 12 complaints about the licensee's money transmission services.

13 **Section 47. That chapter 51A-17 be amended with a NEW SECTION:**

- 14 (1) A licensee that provides payroll processing services must:
 15 (a) Issue reports to clients detailing client payroll obligations in advance of the
 16 payroll funds being deducted from an account; and
 17 (b) Make available worker paystubs or an equivalent statement to workers.
 18 (2) Subdivision (1) of this section does not apply to a licensee providing payroll
 19 processing services where the licensee's client designates the intended recipients
 20 to the licensee and is responsible for providing the disclosures required by
 21 subsection 1(b) of this section.

22 **Section 48. That chapter 51A-17 be amended with a NEW SECTION:**

- 23 (1) A licensee under this chapter must maintain at all times a tangible net worth of the
 24 greater of one hundred thousand dollars or three percent of total assets for the
 25 first one hundred million dollars, two percent of additional assets for one hundred
 26 million dollars to one billion dollars, and one-half of one percent of additional assets
 27 over one billion dollars.
 28 (2) Tangible net worth must be demonstrated at initial application by the applicant's
 29 most recent audited or unaudited financial statements pursuant to subsection
 30 10(2)(f) of this Act.

1 (3) Notwithstanding the foregoing provisions of this section, the director shall have the
2 authority, for good cause shown, to exempt, in-part or in whole, from the
3 requirements of this section any applicant or licensee.

4 **Section 49. That chapter 51A-17 be amended with a NEW SECTION:**

5 (1) An applicant for a money transmission license must provide, and a licensee at all
6 times must maintain, security consisting of a surety bond in a form satisfactory to
7 the director or, with the director's approval, a deposit instead of a bond in
8 accordance with this section.

9 (2) The amount of the required security shall be:

10 (a) The greater of one hundred thousand dollars or an amount equal to one
11 hundred percent of the licensee's average daily money transmission liability
12 in this state calculated for the most recently completed three-month period,
13 up to a maximum of five hundred thousand dollars; or

14 (b) In the event that the licensee's tangible net worth exceeds ten percent of
15 total assets, the licensee shall maintain a surety bond of one hundred
16 thousand dollars.

17 (3) A licensee that maintains a bond in the maximum amount provided for in
18 subsection 2(a) or (b) of this section, as applicable, shall not be required to
19 calculate its average daily money transmission liability in this state for purposes of
20 this section.

21 (4) A licensee may exceed the maximum required bond amount pursuant to
22 subdivision (5) of section 51 of this Act.

23 **Section 50. That chapter 51A-17 be amended with a NEW SECTION:**

24 (1) A licensee shall maintain at all times permissible investments that have a market
25 value computed in accordance with United States generally accepted accounting
26 principles of not less than the aggregate amount of all of its outstanding money
27 transmission obligations.

28 (2) Except for permissible investments enumerated in section 51 of this Act, the
29 director, with respect to any licensee, may by rule or order limit the extent to which
30 a specific investment maintained by a licensee within a class of permissible
31 investments may be considered a permissible investment, if the specific investment
32 represents undue risk to customers, not reflected in the market value of
33 investments.

1 (3) Permissible investments, even if commingled with other assets of the licensee, are
2 held in trust for the benefit of the purchasers and holders of the licensee's
3 outstanding money transmission obligations in the event of insolvency, the filing
4 of a petition by or against the licensee under the United States Bankruptcy Code,
5 11 U.S.C. § 101 to 110 (January 1, 2024) for bankruptcy or reorganization, the
6 filing of a petition by or against the licensee for receivership, the commencement
7 of any other judicial or administrative proceeding for its dissolution or
8 reorganization, or in the event of an action by a creditor against the licensee who
9 is not a beneficiary of this statutory trust. No permissible investments impressed
10 with a trust pursuant to this section shall be subject to attachment, levy of
11 execution, or sequestration by order of any court, except for a beneficiary of this
12 statutory trust.

13 (4) Upon the establishment of a statutory trust in accordance with subdivision (3) of
14 this section or when any funds are drawn on a letter of credit pursuant to
15 subdivision (4) of section 51 of this Act, the director shall notify the applicable
16 regulator of each state in which the licensee is licensed to engage in money
17 transmission, if any, of the establishment of the trust or the funds drawn on the
18 letter of credit, as applicable. Notice shall be deemed satisfied if performed
19 pursuant to a multistate agreement or through NMLS. Funds drawn on a letter of
20 credit, and any other permissible investments held in trust for the benefit of the
21 purchasers and holders of the licensee's outstanding money transmission
22 obligations, are deemed held in trust for the benefit of such purchasers and holders
23 on a pro rata and equitable basis in accordance with statutes pursuant to which
24 permissible investments are required to be held in this state, and other states, as
25 applicable. Any statutory trust established hereunder shall be terminated upon
26 extinguishment of all of the licensee's outstanding money transmission obligations.

27 (5) The director, by rule or by order, may allow other types of investments that the
28 director determines are of sufficient liquidity and quality to be a permissible
29 investment. The director is authorized to participate in efforts with other state
30 regulators to determine that other types of investments are of sufficient liquidity
31 and quality to be a permissible investment.

32 **Section 51. That chapter 51A-17 be amended with a NEW SECTION:**

33 The following investments are permissible under section 50 of this Act:

- 1 (1) Cash, including demand deposits, savings deposits, and funds in such accounts
2 held for the benefit of the licensee's customers in a federally-insured depository
3 financial institution, and cash equivalents, including ACH items in transit to the
4 licensee and ACH items or international wires in transit to a payee, cash in transit
5 via armored car, cash in smart safes, cash in licensee-owned locations, debit card
6 or credit card-funded transmission receivables owed by any bank, or money market
7 mutual funds rated "AAA" by S&P, or the equivalent from any eligible rating
8 service;
- 9 (2) Certificates of deposit or senior debt obligations of an insured depository
10 institution, as defined in section 3 of the Federal Deposit Insurance Act, 12 U.S.C.
11 § 1813 (January 1, 2024) or as defined under the federal Credit Union Act, 12
12 U.S.C. § 1781 (January 1, 2024);
- 13 (3) An obligation of the United States or a commission, agency, or instrumentality
14 thereof; an obligation that is guaranteed fully as to principal and interest by the
15 United States; or an obligation of a state or a governmental subdivision, agency,
16 or instrumentality thereof;
- 17 (4) The full drawable amount of an irrevocable standby letter of credit for which the
18 stated beneficiary is the director that stipulates that the beneficiary need only draw
19 a sight draft under the letter of credit and present it to obtain funds up to the letter
20 of credit amount within seven days of presentation of the items required by section
21 54 of this Act; and
- 22 (5) One hundred percent of the surety bond or deposit provided for under section 49
23 of this Act that exceeds the average daily money transmission liability in this state.

24 **Section 52. That chapter 51A-17 be amended with a NEW SECTION:**

25 The letter of credit referenced in subdivision (4) of section 51 of this Act must:

- 26 (1) Be issued by a federally-insured depository financial institution, a foreign bank that
27 is authorized under federal law to maintain a federal agency or federal branch office
28 in a state or states, or a foreign bank that is authorized under state law to maintain
29 a branch in a state that bears an eligible rating or whose parent company bears an
30 eligible rating and is regulated, supervised, and examined by United States federal
31 or state authorities having regulatory authority over banks, credit unions, and trust
32 companies;
- 33 (2) Be irrevocable, unconditional, and indicate that it is not subject to any condition or
34 qualifications outside of the letter of credit;

- 1 (3) Not contain reference to any other agreements, documents or entities, or otherwise
2 provide for any security interest in the licensee; and
- 3 (4) Contain an issue date and expiration date, and expressly provide for automatic
4 extension, without a written amendment, for an additional period of one year from
5 the present or each future expiration date, unless the issuer of the letter of credit
6 notifies the director in writing by certified or registered mail or courier mail or other
7 receipted means, at least sixty days prior to any expiration date, that the
8 irrevocable letter of credit will not be extended.

9 **Section 53. That chapter 51A-17 be amended with a NEW SECTION:**

10 In the event of any notice of expiration or non-extension of a letter of credit issued
11 under subdivision (4) of section 51 of this Act, the licensee shall be required to
12 demonstrate to the satisfaction of the director, fifteen days prior to expiration, that the
13 licensee maintains and will maintain permissible investments in accordance with
14 subdivision (1) of section 50 of this Act upon the expiration of the letter of credit. If the
15 licensee is not able to do so, the director may draw on the letter of credit in an amount
16 up to the amount necessary to meet the licensee's requirements to maintain permissible
17 investments in accordance with subdivision (1) of section 50 of this Act. Any such draw
18 shall be offset against the licensee's outstanding money transmission obligations. The
19 drawn funds shall be held in trust by the director or the director's designated agent, to
20 the extent authorized by law, as agent for the benefit of the purchasers and holders of the
21 licensee's outstanding money transmission obligations.

22 **Section 54. That chapter 51A-17 be amended with a NEW SECTION:**

23 The letter of credit referenced in subdivision (4) of section 51 of this Act shall
24 provide that the issuer of the letter of credit will honor, at sight, a presentation made by
25 the beneficiary to the issuer of the following documents on or prior to the expiration date
26 of the letter of credit:

- 27 (1) The original letter of credit, including any amendments; and
- 28 (2) A written statement from the beneficiary stating that any of the following events
29 have occurred:
- 30 (a) The filing of a petition by or against the licensee under the United States
31 Bankruptcy Code, 11 U.S.C. § 101 to 110 (January 1, 2024) for bankruptcy
32 or reorganization;

- 1 (b) The filing of a petition by or against the licensee for receivership or the
2 commencement of any other judicial or administrative proceeding for its
3 dissolution or reorganization;
- 4 (c) The seizure of assets of a licensee by a director pursuant to an emergency
5 order issued in accordance with applicable law, on the basis of an action,
6 violation, or condition that has caused or is likely to cause the insolvency of
7 the licensee; or
- 8 (d) The beneficiary has received notice of expiration or non-extension of a letter
9 of credit and the licensee failed to demonstrate to the satisfaction of the
10 beneficiary that the licensee will maintain permissible investments in
11 accordance with subdivision (1) of section 50 of this Act upon the expiration
12 or non-extension of the letter of credit.

13 **Section 55. That chapter 51A-17 be amended with a NEW SECTION:**

14 The director may designate an agent to serve on the director's behalf as beneficiary
15 to a letter of credit so long as the agent and letter of credit meet requirements established
16 by the director. The director's agent may serve as agent for multiple licensing authorities
17 for a single irrevocable letter of credit if the proceeds of the drawable amount for the
18 purposes of this subdivision (4) of section 51 of this Act are assigned to the director.

19 **Section 56. That chapter 51A-17 be amended with a NEW SECTION:**

20 The director is authorized and encouraged to participate in multistate processes
21 designed to facilitate the issuance and administration of letters of credit, including, but
22 not limited to, services provided by the NMLS and State Regulatory Registry, LLC.

23 **Section 57. That chapter 51A-17 be amended with a NEW SECTION:**

24 Unless permitted by the director, by rule or by order, to exceed the limit as set
25 forth herein, the following investments are permissible under section 50 of this Act to the
26 extent specified:

- 27 (1) Receivables that are payable to a licensee from its authorized delegates in the
28 ordinary course of business that are less than seven days old, up to fifty percent
29 of the aggregate value of the licensee's total permissible investments;
- 30 (2) Of the receivables permissible under subdivision (1) of this section, receivables
31 that are payable to a licensee from a single authorized delegate in the ordinary

1 course of business may not exceed ten percent of the aggregate value of the
2 licensee's total permissible investments;

3 (3) The following investments are permissible up to twenty percent per category and
4 combined up to fifty percent of the aggregate value of the licensee's total
5 permissible investments:

6 (a) A short-term investment, an investment lasting up to six months, bearing
7 an eligible rating;

8 (b) Commercial paper bearing an eligible rating;

9 (c) A bill, note, bond, or debenture bearing an eligible rating;

10 (d) U.S. tri-party repurchase agreements collateralized at one hundred percent
11 or more with U.S. government or agency securities, municipal bonds, or
12 other securities bearing an eligible rating;

13 (e) Money market mutual funds rated less than "AAA" and equal to or higher
14 than "A-" by S&P or the equivalent from any other eligible rating service;
15 and

16 (f) A mutual fund or other investment fund composed solely and exclusively of
17 one or more permissible investments listed in subdivisions (1) to (3),
18 inclusive, of section 51 of this Act;

19 (4) Cash, including demand deposits, savings deposits, and funds in such accounts
20 held for the benefit of the licensee's customers, at foreign depository institutions
21 are permissible up to ten percent of the aggregate value of the licensee's total
22 permissible investments if the licensee has received a satisfactory rating in its most
23 recent examination and the foreign depository institution:

24 (a) Has an eligible rating;

25 (b) Is registered under the Foreign Account Tax Compliance Act;

26 (c) Is not located in any country subject to sanctions from the Office of Foreign
27 Asset Control; and

28 (d) Is not located in a high-risk or non-cooperative jurisdiction as designated
29 by the Financial Action Task Force.

30 **Section 58. That chapter 51A-17 be amended with a NEW SECTION:**

31 A licensee transmitting virtual currencies shall hold like-kind virtual currencies of
32 the same volume as that held by the licensee but that is obligated to consumers, in lieu
33 of the permissible investments otherwise required in this Act.

1 **Section 59. That chapter 51A-17 be amended with a NEW SECTION:**

2 (1) The director may suspend or revoke a license or order a licensee to revoke the
3 designation of an authorized delegate if:

4 (a) The licensee violates this Act or a rule adopted or an order issued under this
5 Act;

6 (b) The licensee does not cooperate with an examination or investigation by the
7 director;

8 (c) The licensee engages in fraud, intentional misrepresentation, or gross
9 negligence;

10 (d) An authorized delegate is convicted of a violation of a state or federal anti-
11 money laundering statute, or violates a rule adopted or an order issued
12 under this Act, as a result of the licensee's willful misconduct or willful
13 blindness;

14 (e) The competence, experience, character, or general fitness of the licensee,
15 authorized delegate, person in control of a licensee, key individual, or
16 responsible person of the authorized delegate indicates that it is not in the
17 public interest to permit the person to provide money transmission;

18 (f) The licensee engages in an unsafe or unsound practice;

19 (g) The licensee is insolvent, suspends payment of its obligations, or makes a
20 general assignment for the benefit of its creditors; or

21 (h) The licensee does not remove an authorized delegate after the director
22 issues and serves upon the licensee a final order including a finding that the
23 authorized delegate has violated this Act.

24 (2) In determining whether a licensee is engaging in an unsafe or unsound practice,
25 the director may consider the size and condition of the licensee's money
26 transmission, the magnitude of the loss, the gravity of the violation of this act, and
27 the previous conduct of the person involved.

28 **Section 60. That chapter 51A-17 be amended with a NEW SECTION:**

29 (1) The director may issue an order suspending or revoking the designation of an
30 authorized delegate, if the director finds that:

31 (a) The authorized delegate violated this Act or a rule adopted or an order
32 issued under this Act;

- 1 **(b) The authorized delegate did not cooperate with an examination or**
2 **investigation by the director;**
- 3 **(c) The authorized delegate engaged in fraud, intentional misrepresentation, or**
4 **gross negligence;**
- 5 **(d) The authorized delegate is convicted of a violation of a state or federal anti-**
6 **money laundering statute;**
- 7 **(e) The competence, experience, character, or general fitness of the authorized**
8 **delegate or a person in control of the authorized delegate indicates that it**
9 **is not in the public interest to permit the authorized delegate to provide**
10 **money transmission; or**
- 11 **(f) The authorized delegate is engaging in an unsafe or unsound practice.**
- 12 **(2) In determining whether an authorized delegate is engaging in an unsafe or unsound**
13 **practice, the director may consider the size and condition of the authorized**
14 **delegate's provision of money transmission, the magnitude of the loss, the gravity**
15 **of the violation of this Act or a rule adopted or order issued under this Act, and the**
16 **previous conduct of the authorized delegate.**
- 17 **(3) An authorized delegate may apply for relief from a suspension or revocation of**
18 **designation as an authorized delegate according to procedures prescribed by the**
19 **director.**

20 **Section 61. That chapter 51A-17 be amended with a NEW SECTION:**

- 21 **(1) If the director determines that a violation of this Act or of a rule adopted or an**
22 **order issued under this Act by a licensee or authorized delegate is likely to cause**
23 **immediate and irreparable harm to the licensee, its customers, or the public as a**
24 **result of the violation, or cause insolvency or significant dissipation of assets of the**
25 **licensee, the director may issue an order requiring the licensee or authorized**
26 **delegate to cease and desist from the violation. The order becomes effective upon**
27 **service of it upon the licensee or authorized delegate.**
