# Senate Bill 170

JOINT APPROPRIATIONS ENGROSSED

Introduced by: **Senator Hunhoff**

1 **An Act to repeal and replace an appropriation regarding the South Dakota women's**  
 2 **prison and to declare an emergency.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1.** There is hereby appropriated from the general fund the sum of \$5,750,000 to the  
 5 Department of Corrections, for purposes of designing, renovating, constructing, furnishing,  
 6 and equipping the expansion of the healthcare services areas in the South Dakota Women's  
 7 Prison, including heating, air conditioning, plumbing, water, sewer, electric facilities,  
 8 architectural and engineering services, and other services and improvements as may be  
 9 required.

10 **Section 2.** The Bureau of Administration, pursuant to chapter 5-14, shall supervise the  
 11 design, renovation, and construction of facilities approved by this Act.

12 **Section 3.** The commissioner of the Bureau of Administration and the secretary of the  
 13 Department of Corrections shall approve vouchers and the state auditor shall draw warrants  
 14 to pay expenditures authorized by this Act.

15 **Section 4.** Any amounts appropriated in this Act not lawfully expended or obligated shall  
 16 revert in accordance with the procedures prescribed in chapter 4-8.

17 **Section 5. That 2022 Session Laws, chapter 194 be REPEALED:**

2       ~~inflation as measured by the Building Cost Index, reported by the Engineering News~~

4       ~~effective date of this Act. However, any adjustments to construction cost estimates for the~~  
5       ~~project may not exceed one hundred and twenty five percent of the estimated project~~  
6       ~~construction cost stated in section 1 of this Act.~~

7       ~~Section 3. The Bureau of Administration, pursuant to chapter 5-14, shall supervise the~~  
8       ~~design, renovation, and construction of facilities approved by this Act.~~

9       ~~Section 4. The commissioner of the Bureau of Administration and the secretary of the~~
