CONSIDERATION OF REPORTS OF COMMITTEES (AMENDED BILLS)

SB 170, HB 1125

SECOND READING OF CONSENT CALENDAR ITEMS

- HB 1100 modify certain requirements for eligibility to receive a gift of a museum collection from a county or municipality. (Introduced)
- HB 1147 address discriminatory acts against entities participating in a 340B drug pricing program. (Introduced)
- HB 1182 revise provisions pertaining to the observation of the conduct of an election. (House Engrossed)
- HB 1194 clarify provisions pertaining to tax increment finance districts. (House Local Government Engrossed)
- HB 1196 streamline the process by which an on-sale retail license holder may acquire a special event license. (House Commerce and Energy Engrossed)
- HCR 6011 Urging the Bureau of Indian Affairs (BIA) law enforcement to establish a law enforcement training academy in South Dakota. (Introduced)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 50 make an appropriation for the site preparation and construction of a prison facility for offenders committed to the Department of Corrections in Rapid City, to transfer moneys to the incarceration construction fund, and to declare an emergency. (Introduced)
- SB 171 make and change an appropriation related to the construction of the new state public health laboratory and to declare an emergency. (Introduced)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1084 (Removed from Consent Calendar) repeal a provision related to habeas corpus proceedings. (Introduced)
- HB 1086 (Removed from Consent Calendar) establish an enhanced penalty for probationers intentionally causing contact with bodily fluids or human waste with a Unified Judicial System employee. (Introduced)
- HB 1099 establish educational standards for the expanded practice of optometry. (Introduced)
