# House Bill 1065

### JOINT APPROPRIATIONS ENGROSSED

*Introduced by: The Chair of the House Committee on Appropriations at the request of the Department of Agriculture and Natural Resources*

1 **An Act to make an appropriation for the design and construction of a multi-use**  
 2 **building on the grounds of the State Fair and to declare an emergency.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1.** The Department of Agriculture and Natural Resources may contract for the  
 5 planning, site preparation, construction, furnishing, and equipping of a multi-use building on  
 6 the grounds of the State Fair, together with any heating, air conditioning, plumbing, water,  
 7 sewer, electric facilities, sidewalks, parking, landscaping, architectural and engineering  
 8 services, and any other services or actions required to accomplish the project, for an  
 9 estimated cost of \$8,000,000.

10 **Section 2.** The Department of Agriculture and Natural Resources may relocate and repurpose  
 11 the structure known as the 4-H beef exhibits building on the grounds of the State Fair or  
 12 demolish and dispose of the structure. This project includes any action reasonably necessary  
 13 to prepare the lot for use by the State Fair.

14 **Section 3.** There is hereby appropriated the sum of \$4,000,000 in general funds and the sum  
 15 of \$4,000,000 in other fund expenditure authority to the Department of Agriculture and  
 16 Natural Resources, for purposes described in sections 1 and 2 of this Act.

17 **Section 4.** The Department of Agriculture and Natural Resources may accept, transfer, and  
 18 expend any funds obtained, for the projects authorized in this Act, from federal sources,  
 19 donations, or any other external sources, all of which comprise a special fund for the  
 20 benefitted projects. All moneys deposited into the fund are hereby appropriated to the  
 21 projects, subject to any limitations set forth in sections 1 and 3 of this Act.

22 **Section 5.** The administration of the projects authorized in this Act shall be under the general  
 23 charge and supervision of the Bureau of Administration, as provided in chapter 5-14.

1 **Section 6.** The secretary of the Department of Agriculture and Natural Resources shall  
2 approve vouchers and the state auditor shall draw warrants to pay expenditures authorized  
3 by this Act.

4 **Section 7.** Any amounts appropriated in this Act, not lawfully expended or obligated, shall  
5 revert in accordance with the procedures prescribed in chapter 4-8.

6 **Section 8.** Whereas, this Act is necessary for the support of the state government and its  
7 existing public institutions, an emergency is hereby declared to exist, and this Act shall be in  
8 full force and effect from and after its passage and approval.
