- SB 10 (Concur with House Amendment) require that a notification of medical cannabis certification be provided to a patient's primary or referring practitioner. (House Health and Human Services Engrossed)
- SB 172 (Concur with House Amendment) allow a person to temporarily take responsibility of a feral cat for the purpose of spaying or neutering the animal. (House Engrossed)

SECOND READING OF CONSENT CALENDAR ITEMS

- HB 1120 provide special motor vehicle license plates for advanced life support personnel and emergency medical technicians.
(House Transportation Engrossed)
- HB 1195 provide authority for a court to order offenders convicted of vehicular homicide to pay restitution to a victim's children until age eighteen.
(Senate Judiciary Engrossed)
- HB 1225 define a multi-passenger bicycle and to provide for the regulation of multi-passenger bicycles. (House Engrossed)
- HB 1229 add a county as able to be assigned responsibility for secondary highways on municipal boundaries. (House Engrossed)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 66 make an appropriation for eligible water, wastewater, and storm water projects throughout state government, and to declare an emergency. (Introduced)
- SB 67 provide for the sale of certain real estate located in Hughes County and to provide for the deposit of the proceeds into a continuously appropriated fund. (Introduced)
- SB 70 to make an appropriation for the replacement of the Richmond Lake dam and spillway, for the general maintenance and repair of other state-owned dams, and to declare an emergency. (Introduced)
- SB 209 make an appropriation for grants to assisted living centers and nursing facilities for costs related to telemedicine. (Introduced)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1057 (Removed from Consent Calendar) create the Commission on Indigent Legal Services and Office of Indigent Legal Services. (House Engrossed)
- HB 1071 (Deferred from 29th LD) revise a provision providing authority to the Governor to enter into agreements with the Nuclear Regulatory Commission. (Introduced)
- HB 1092 (Deferred from 25th LD) revise provisions regarding the 911 emergency surcharge. (House Taxation Engrossed) (Fiscal Note)
- HB 1119 create a habitat conservation specialty plate and emblem. (House Transportation Engrossed)
- HB 1125 (Deferred from 29th LD) prohibit the chemical modification or conversion of industrial hemp and the sale or distribution of chemically modified or converted industrial hemp and to provide a penalty therefor. (Senate Health and Human Services Engrossed)
- HB 1132 revise certain provisions pertaining to municipal government. (House Local Government Engrossed)
- HB 1187 (Removed from Consent Calendar) create a one-year career and technical education instructor educator permit. (House Education Engrossed)
- HB 1194 (Deferred from 29th LD) (Removed from Consent Calendar) clarify provisions pertaining to tax increment finance districts. (House Local Government Engrossed)
- HB 1220 (Deferred from 29th LD) allow an appeal of a decision of the Department of Education regarding special education or related services by a civil action against the department. (Introduced)
- HB 1228 (Removed from Consent Calendar) provide that required exterior hunting garments may be fluorescent pink. (Introduced)
- HB 1232 create the Indian Child Welfare Advisory Council. (House State Affairs Engrossed)
