1 An Act to expand certain privileges for individuals who hold an unrestricted 2 enhanced concealed carry permit.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 13-32-7 be AMENDED:

5 13-32-7. Any person, other than a law enforcement officer or school sentinel 6 under § 13-64-1, who intentionally carries, possesses, stores, keeps, leaves, places, or 7 puts into the possession of another person, any dangerous weapon, firearm, or air gun, whether or not the firearm or air gun is designed, adapted, used, or intended to be used 8 9 primarily for imitative or noisemaking purposes, on or in any public elementary or 10 secondary school premises, vehicle, or building, or on or in any premises, vehicle, or 11 building used or leased for public elementary or secondary school functions, whether or 12 not any person is endangered by any action under this section, is guilty of a Class 1 13 misdemeanor.
