MOTIONS AND RESOLUTIONS

- SB 43 (Concur with House Amendment) establish procedures for the imposition of fines and probation against medical cannabis establishments, increase the allowable fee for a medical cannabis establishment registration certificate, and direct the Department of Health to promulgate rules to increase the fee for a registration certificate. (House Engrossed)
- SB 58 (Concur with House Amendment) revise provisions regarding money transmission. (House Commerce and Energy Engrossed)
- SB 64 (Concur with House Amendment) revise provisions related to the regulation of emergency medical services and associated personnel. (House Health and Human Services Engrossed)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1022 make an appropriation to the Department of Education to provide professional development in literacy to teachers, and to declare an emergency. (House Engrossed)
- HB 1057 (Deferred from 31st LD) (Removed from Consent Calendar) create the Commission on Indigent Legal Services and Office of Indigent Legal Services. (House Engrossed)
- HB 1061 make an appropriation for costs related to emergencies and disasters impacting the state and to declare an emergency. (Joint Appropriations Engrossed)
- HB 1064 make an appropriation for increases in the construction costs of infrastructure at Lake Alvin and Newell Lake, and to declare an emergency. (Introduced)
- HB 1065 make an appropriation for the design and construction of a multi-use building on the grounds of the State Fair and to declare an emergency. (Joint Appropriations Engrossed)
- HB 1092 (Deferred from 31st LD) revise provisions regarding the 911 emergency surcharge. (House Taxation Engrossed) (Fiscal Note)

- HB 1202 establish procedures for the termination of services by a provider through the CHOICES waiver program. (Senate Health and Human Services Engrossed)
