SB 51

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

SB 51 revise property tax levies for school districts and to revise the state aid to general and special education formulas. (Joint Appropriations Engrossed)

SB 144A make an appropriation for grants to support airport terminal improvement, expansion, and infrastructure projects. (House Engrossed)
