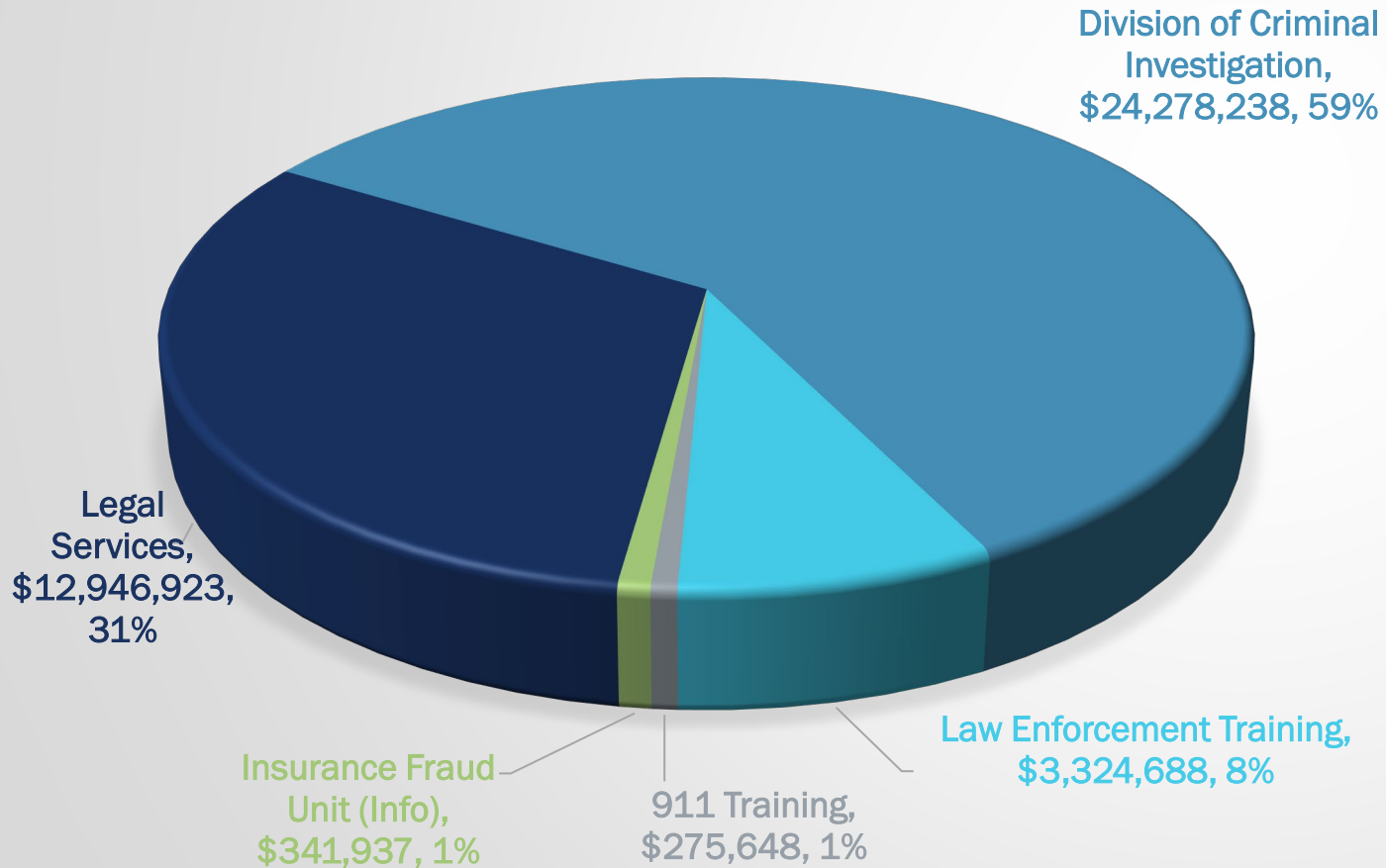

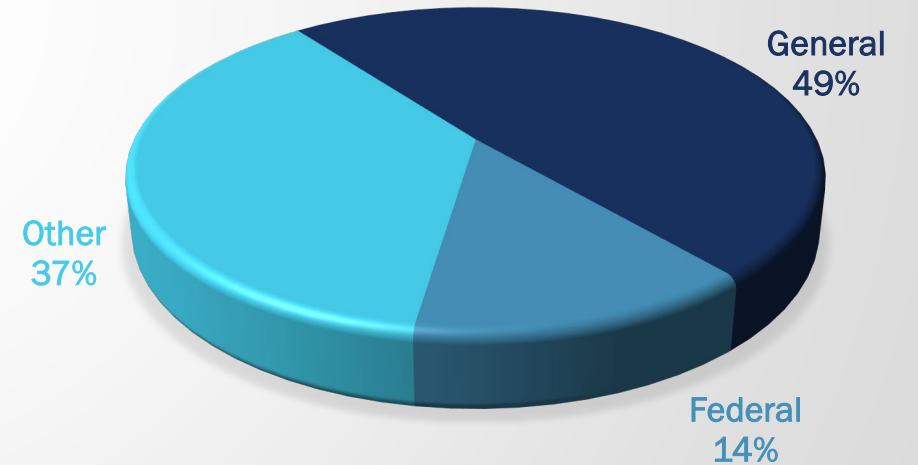

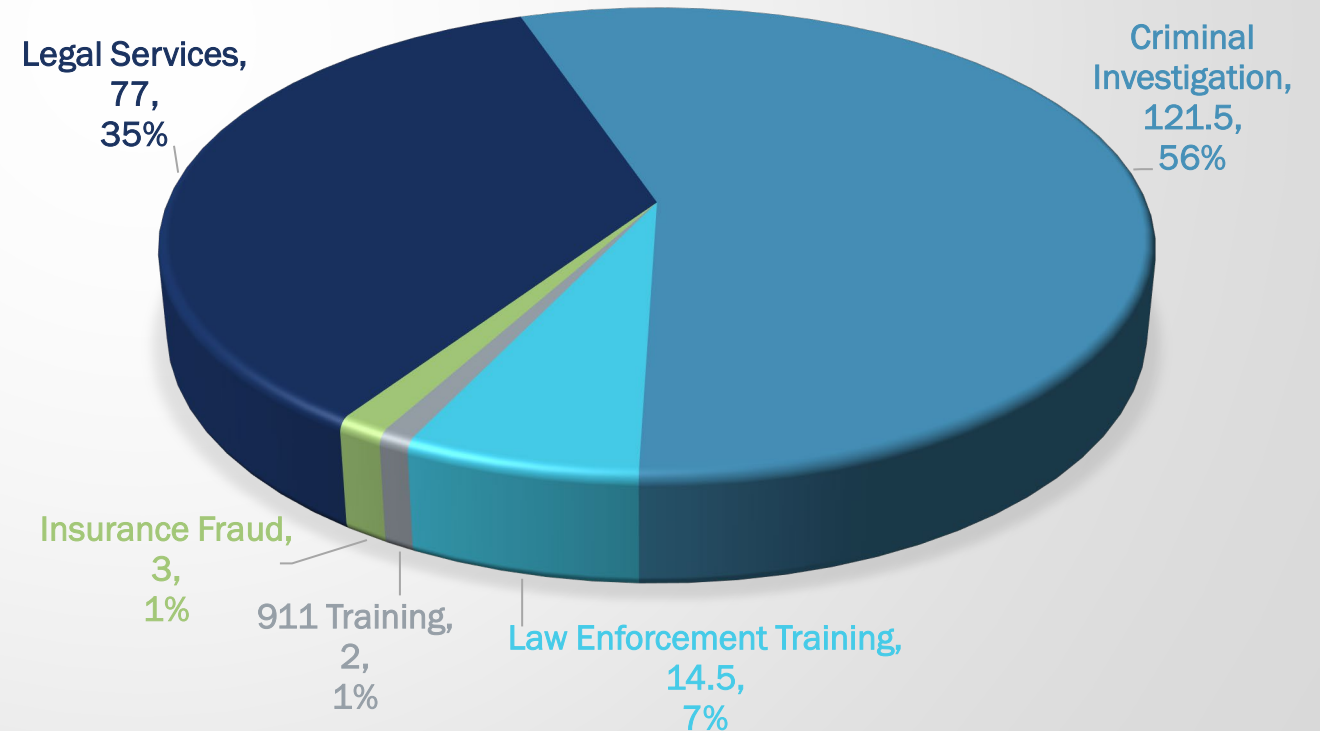

# CIVIL DIVISION

- Civil and Administrative Cases: 124
- Legal Advice to at least 16 State Agencies and 20 Boards and Commissions
  - For example, the Division provides legal work for the Board of Water and Natural Resources
  - Assisted with over 101 loans or grants for water projects, which totaled \$483.6 million

# CIVIL DIVISION

## Meta

- The federal complaint was filed in California in the Fall of 2023. Discovery is on-going.
- Alleges that Meta knew of the harmful impacts its platforms had on young people and that the company misled the public about the harms associated with the use of its platforms.

# CIVIL DIVISION

## Pharmaceuticals

- On March 14, 2018, first filed suit in South Dakota v. Purdue Pharma alleging several opioid manufacturers knowingly distributed false information to increase the sales of opioid drugs.
- Total anticipated settlements of approximately \$78.6 million
  - McKesson Corp, Cardinal Health, Inc, AmerisourceBergen Corp, and Janssen: \$50 million over 15 years
  - Walgreens, CVS, Walmart, Teva & Allergan with payments started in 2024: \$28.6 million over 17 years
- The settlement funds go into the opioid abatement and remediation fund under SDCL 34-20B-116.

South Dakota is receiving \$20-24 million annually

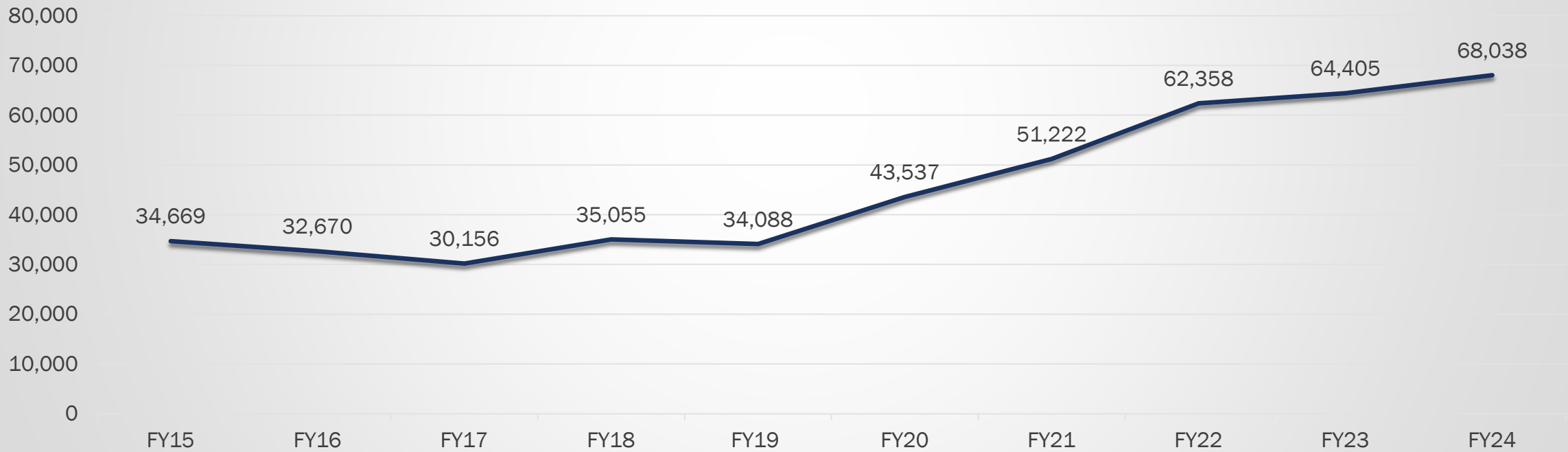


Arbitration for calendar year 2004 is on hold while at the same time, arbitration panels are being formed for calendar years 2005-2007

## ■ TOP COMPLAINT CATEGORIES FOR FY2024

- Foreign Fraud – grandparent, sweepstakes, romance, shipping scams, etc.
- Auto – repairs, warranty, repossession, titles, used & new purchase issues
- Landlord/Tenant - deposit, eviction, repair, lease
- Internet – retail, websites, phishing, streaming, fraud
- Home Construction/Improvements - New, contractor/sub-contractor issues, landscaping, mobile home, roofing, windows, plumbing
- Credit Card Companies – dispute issues, interest, payment history issues
- Consumer Protection consists of a Director, 5 Investigators, Complaint Intake Specialist, and 2 Assistant Attorney Generals

- Public outreach
- Received approximately \$1.7 million back for a business targeted in a business email compromise, which is one of the many recoveries Consumer Protection has made this year for consumers and businesses.

# CRIMINAL DIVISION

## State of South Dakota v. Lance L. Long

- In March of 2015, Long moved into the secluded Corson County ranch home of a woman with five young children between the ages of 6 and 15. Between March 2015 and July 2017, Long repeatedly raped the woman's 15-year-old daughter and beat and abused her with blunt objects, an electrified cattle prod (hotshot) and a taser. Long also tortured the other four children, between the ages of 6 and 13, by running over them with four-wheelers, shocking them with the hotshot, or placing electrified dog collars on their bodies and shocking them. Long gave many of the children alcohol and methamphetamine. He also used the cattle prod to shock the 15-year-old daughter and 12-year-old daughter on their genitalia. The case was not investigated until years later when the oldest male child left to become a U.S. Marine and told his recruiter what was going on in the household.
- Long was convicted on one count each of 2<sup>nd</sup> degree rape, 3<sup>rd</sup> degree rape, 4<sup>th</sup> degree rape, three counts of aggravated assault, and five counts of Abuse or Cruelty to a Minor, each with a two-level habitual offender enhancement.
- Long was sentenced to a total of 65 years in prison.

# CRIMINAL DIVISION

## State of South Dakota v. Joseph G. Hoek

- In February 2024, Joseph G. Hoek led officers on a high-speed chase through Lake and Moody counties. Officers observed Hoek traveling at times up to 115 MPH, forcing oncoming traffic to the shoulder, and passing vehicles on the right side of the highway. Moody County Chief Deputy Sheriff Kenneth Prorok was assisting the pursuing officers by deploying a tire deflation device ahead of Hoek's fleeing vehicle. A witness observed Hoek's vehicle swerve and strike Chief Deputy Prorok. Chief Deputy Prorok was declared deceased on scene.
- Hoek is charged with First-Degree Murder and Aggravated Eliding. The State of South Dakota has provided notice that it intends to seek the death penalty.
- Hoek is presumed innocent until such time as proven guilty.

# CRIMINAL DIVISION

## State of South Dakota v. Lonna Carroll

- Between 2010 and 2023, Lonna Carroll was employed by the Child Protective Services under the Department of Social Services. Carroll is alleged to have used her position at DSS to steal approximately \$1.8 million of state and federal funds through her ability to request state and federal funds on behalf of children in CPS custody or care.
- Carroll is charged with two counts of Aggravated Grand Theft. Count 1 is a Class 2 Felony which runs from July 2013 to March 2023. Count 2 is a Class 3 Felony which runs from January 2010 to June 2013 when the statute was legislatively amended.
- Carroll is presumed innocent until such time as proven guilty.

# CRIMINAL DIVISION

## State of South Dakota v. Charity Rose Taylor

- Taylor was a major fentanyl dealer in the Rapid City area. Taylor was part of a criminal conspiracy that brought an estimated 10,000 fentanyl pills into South Dakota. In October 2023 Taylor sold fentanyl pills that resulted in the death of 43-year-old man. Another sale of fentanyl was to a 17-year-old female.
- Taylor was convicted of one count of Enhanced Distribution Resulting in Death, Distribution of a Controlled Substance to a Minor, and Conspiracy to Bring Fentanyl into South Dakota.
- Taylor was sentenced to 23 years in prison.



## **MEDICAID FRAUD, ABUSE, & NEGLECT SERVICES (MFANS)**

---

Due to a close alignment in missions, the Medicaid Fraud Control Unit and Elder Abuse Unit merged in May 2024 to create MFANS

---

The merger created a substantial cost savings to the state by tapping federal funding for elder services that were previously provided with state funds

---

The merger also created synergized efforts by attorney general staff to combat both healthcare patient abuse/exploitation and elder abuse/exploitation – two populations that experience significant overlap

---

The newly formed MFANS Unit investigates Medicaid provider fraud; abuse, neglect, and exploitation of patients, elderly individuals, and individuals with disabilities; and drug diversion cases

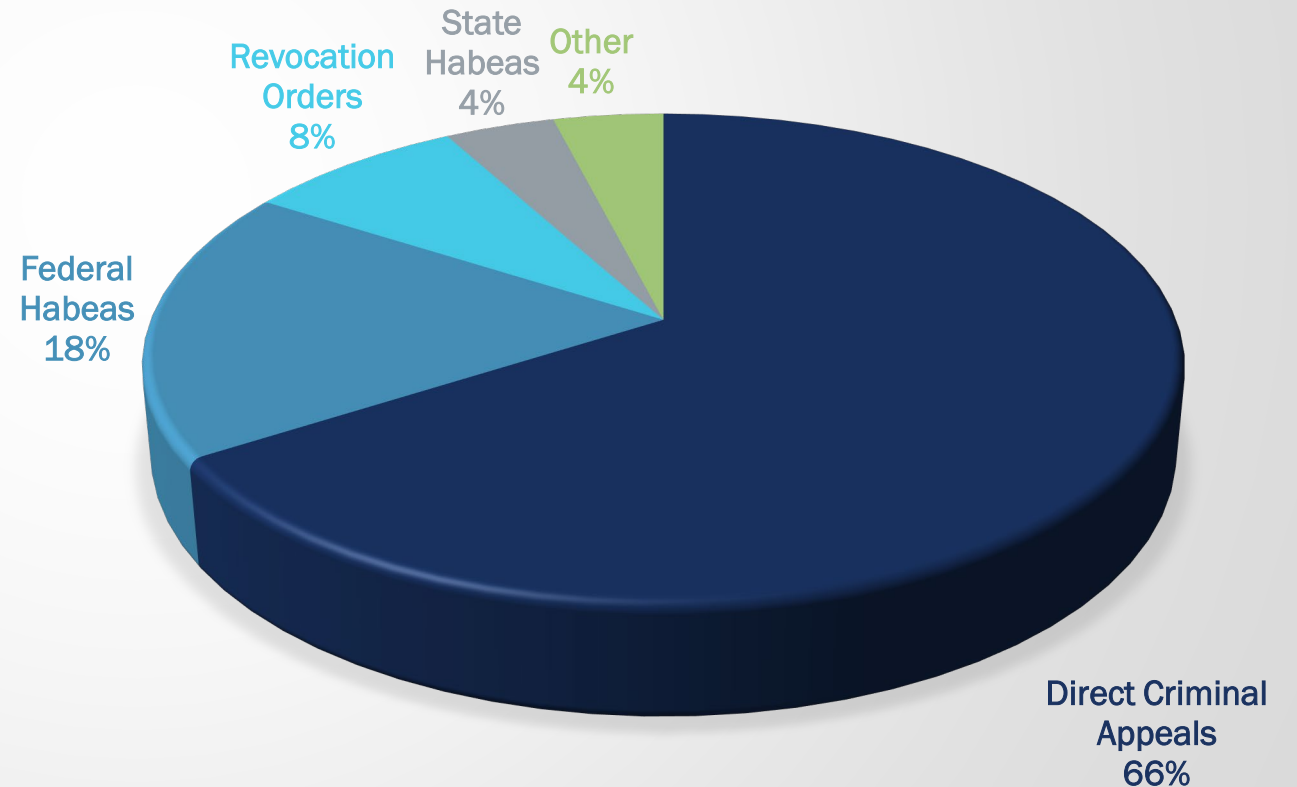
## State v. Eagle Hawk

- Eagle Hawk was employed as a direct care professional at a residential group home that provided twenty-four-hour care for individuals with developmental delays
- While engaged in his duties at the group home, Eagle Hawk raped a thirty-nine-year-old female patient with profound disabilities
- Eagle Hawk pleaded guilty to third-degree rape, which is the sexual penetration of an individual who lacks the capacity to give consent, and he was sentenced to twenty-five years in the state penitentiary, with ten of those years suspended
- Eagle Hawk has been excluded from future employment at healthcare facilities accepting federal funding

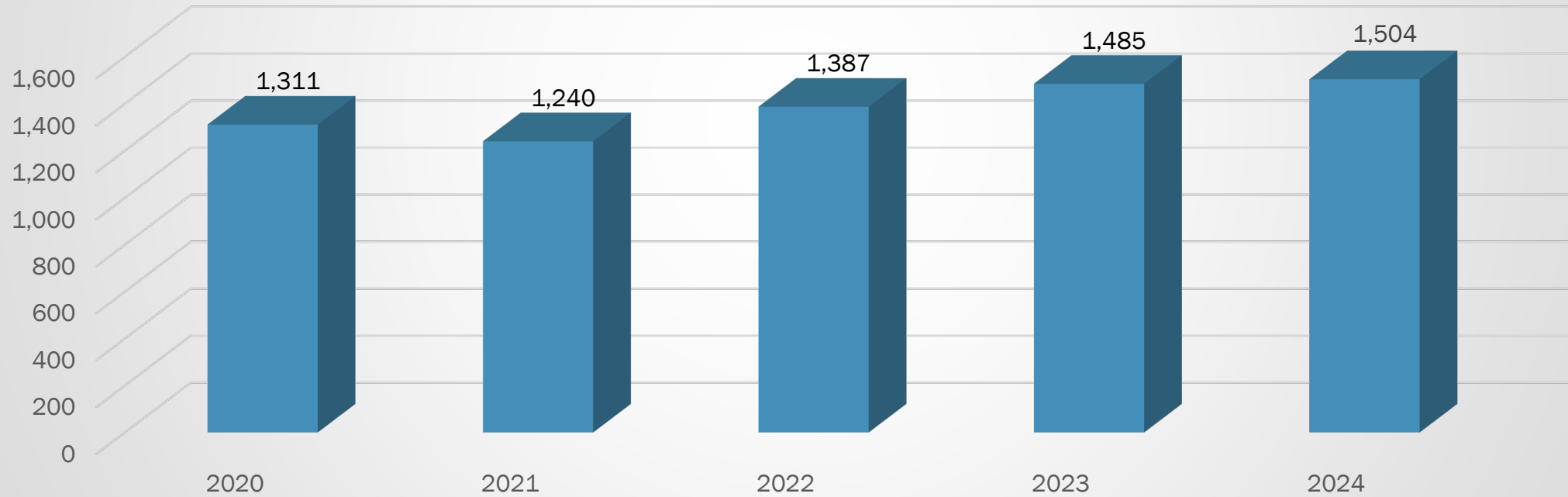
# APPELLATE DIVISION

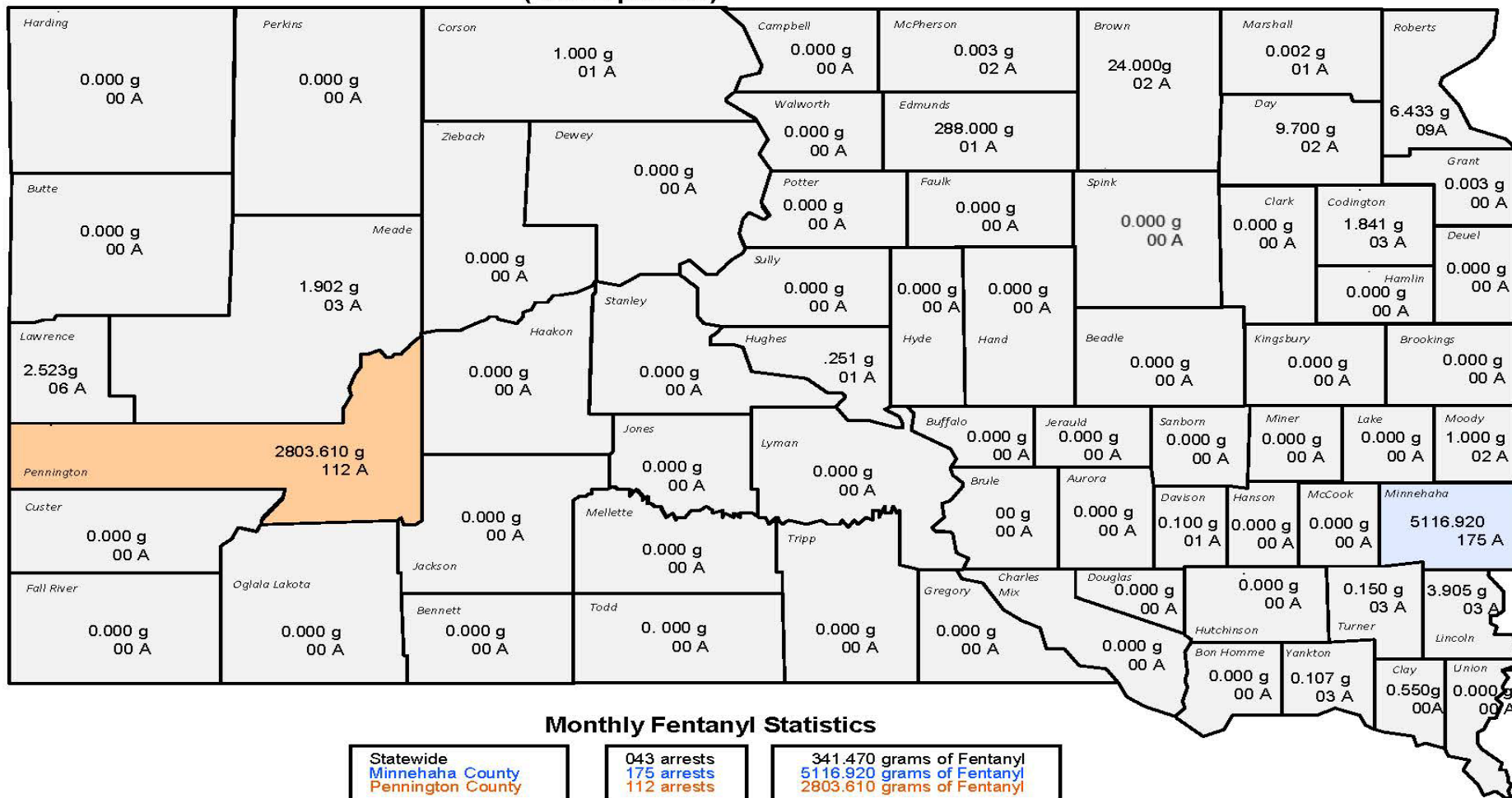

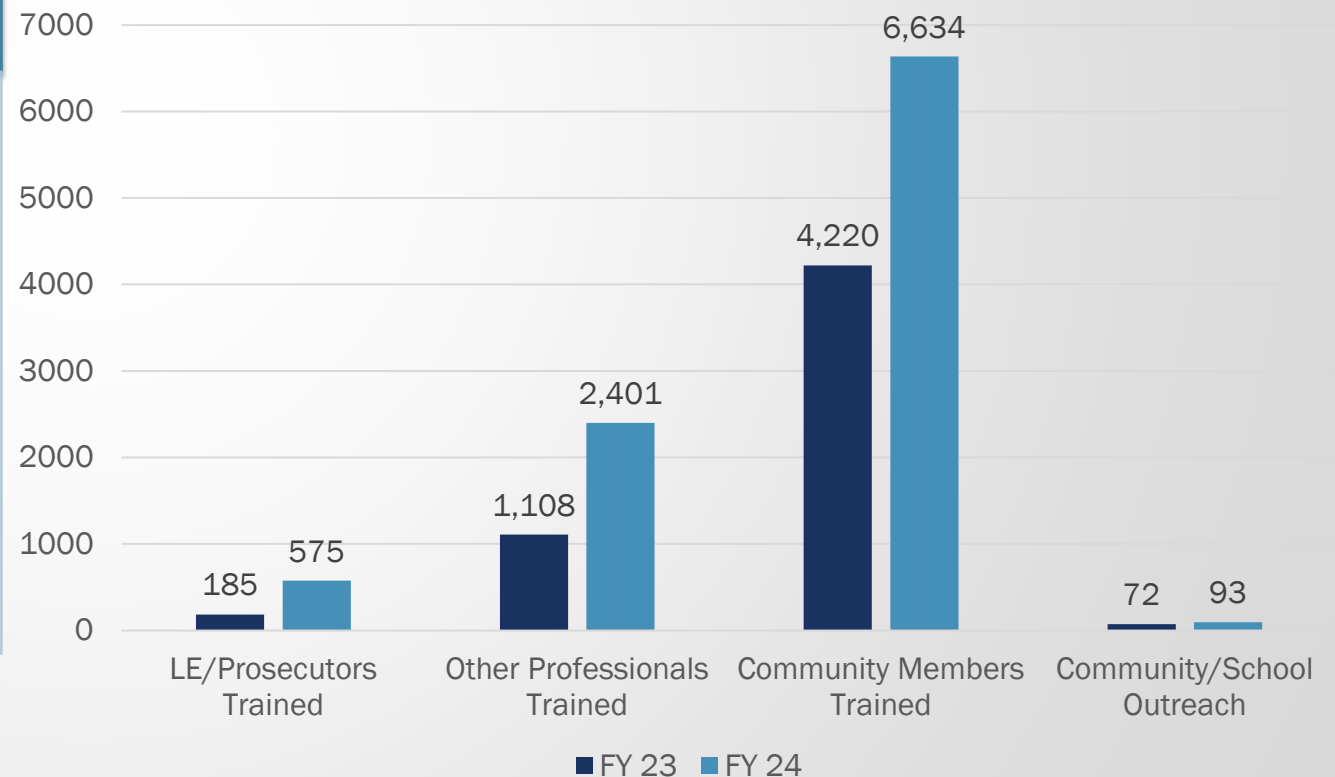

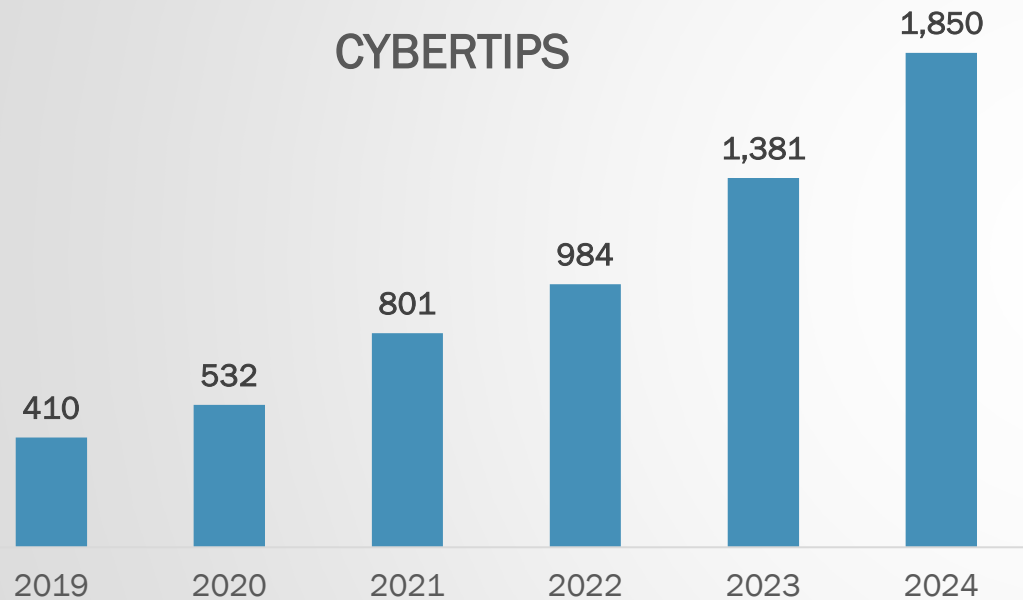

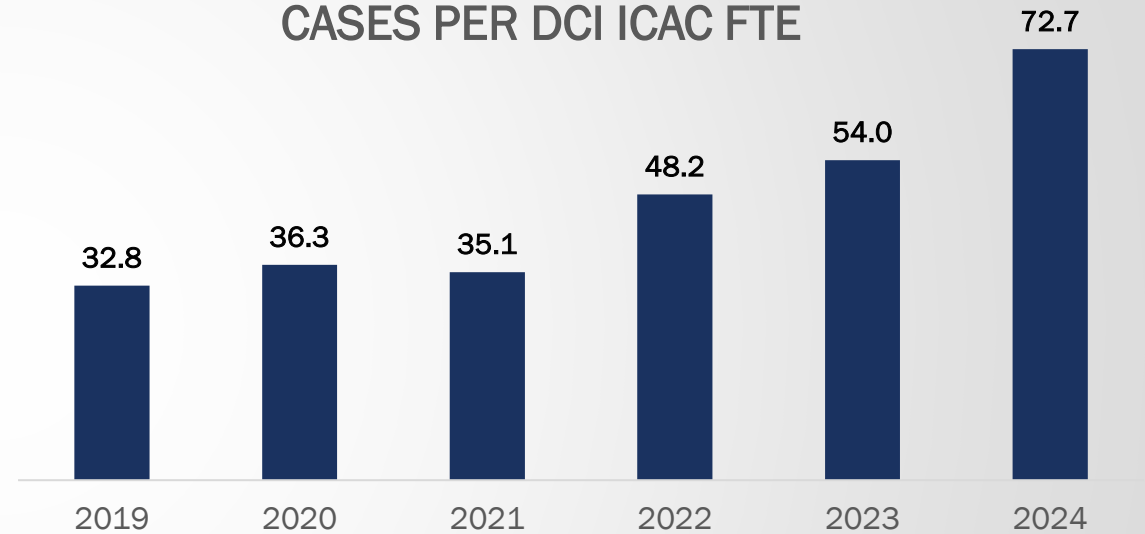

## CYBERTIPS

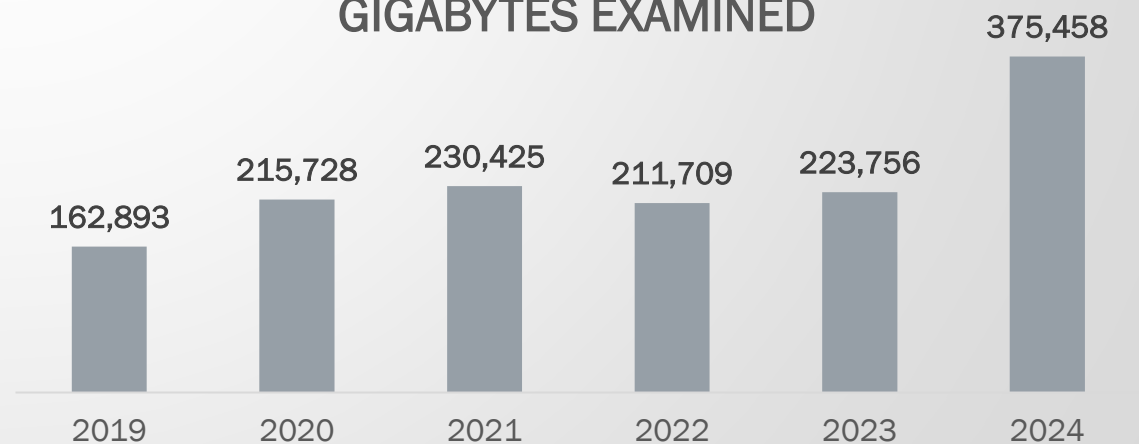


248% increase in the number of CyberTIPS over the past 5 years

## GIGABYTES EXAMINED

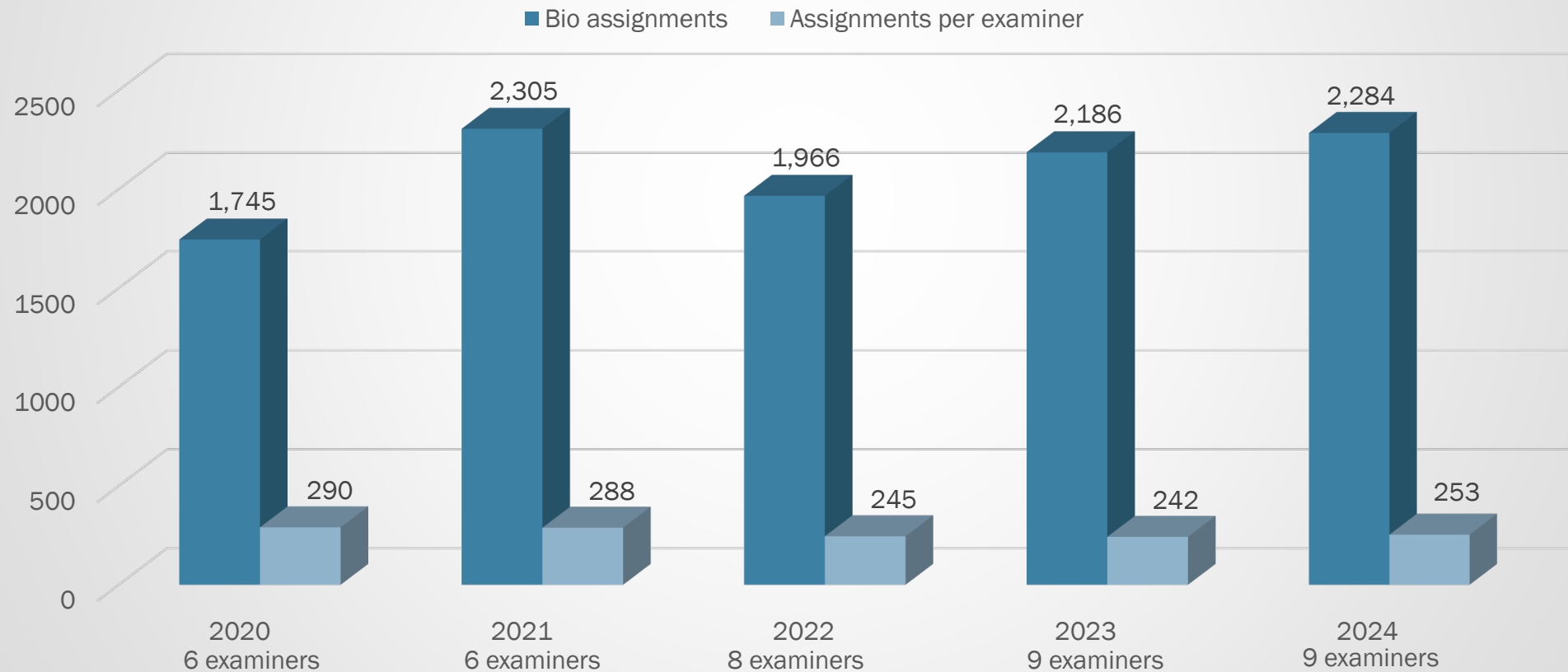


# OFFICER INVOLVED SHOOTINGS

- In 2024 there were 4 Officer Involved Shootings
  - Sioux Falls – 2
  - Rapid City – 2
- Injuries to the offender(s) by officers occurred in 4 of the shootings
  - 1 of the four offenders was on parole at the time of the incident
- The Attorney General’s Office has issued opinions in 4 of the incidents
- 4 incidents have been found to be justified shootings
- Since 2001 there have been 83 officer involved shooting incidents
  - 44 subject fatalities
  - 2 officer fatalities
  - 2 officers with life threatening injuries
  - Offenders have tested positive for drugs and/or alcohol in 72 of the Officer Involved Shooting incidents (7 tested negative, 4 unknown)
  - Offenders have made suicidal statements, attempts and/or had a reported mental illness in 59 incidents (3 shot themselves during incident)



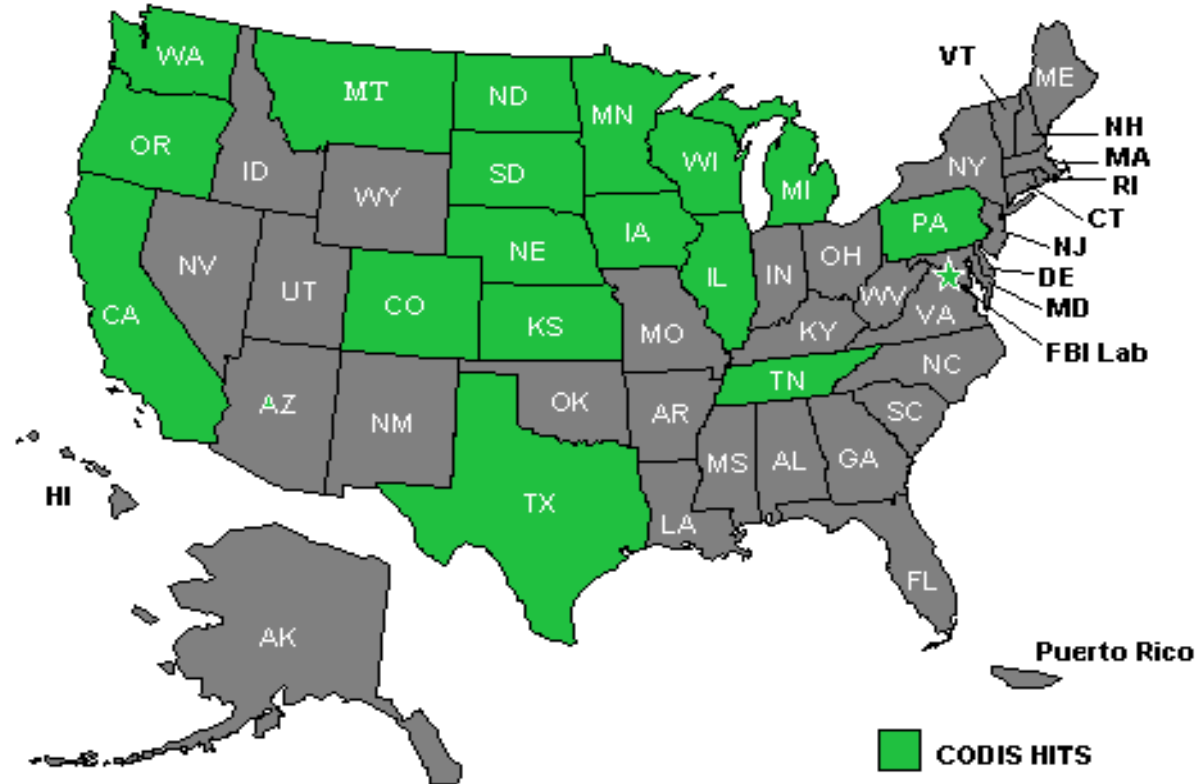
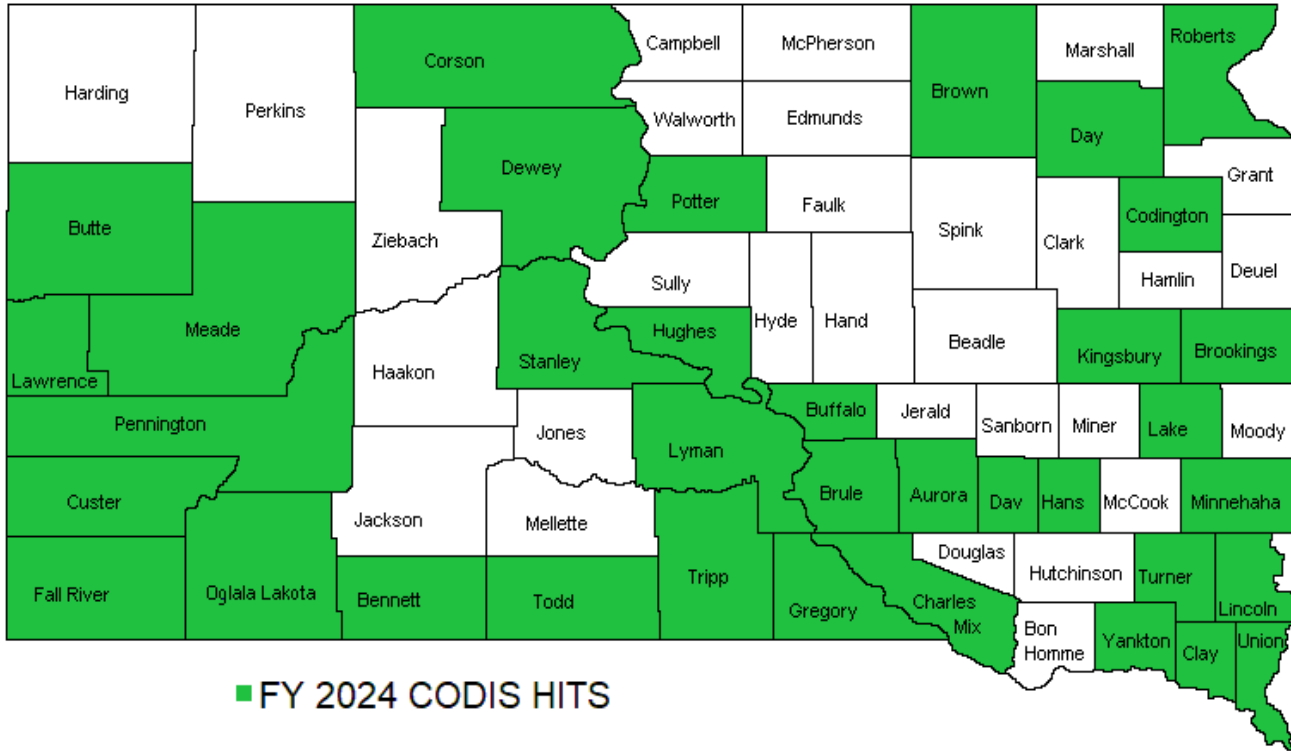

# COMBINED DNA INDEX SYSTEM (CODIS) HITS - CASE EXAMPLE

- In 2022, the SDFL received an attempted rape case. The victim was at home by herself when a masked man broke into her home, exposing himself to her. She was able to fight him off and the suspect had left the mask he was wearing behind.
- The mask was sent to the SDFL in 2022, and a male DNA profile was obtained from the mask.
- The DNA profile from the mask was entered into CODIS in 2022 and no hits were obtained. The DNA profile continued to search against new profiles as they were added into the database.
- The SDFL in conjunction with the law enforcement agency attempted other ways to identify the DNA profile such as state specific CODIS search requests and even genealogy testing, neither of which resulted in an identification.
- In July 2024, a CODIS hit occurred to the DNA profile from the mask left in the victim's home to a South Dakota arrestee sample that had just been entered into the database. The offender had been recently arrested for another offense and his DNA was collected and submitted to the SDFL for entry in the database.
- Law enforcement was able to re-open the case with this new information. It was determined that the suspect still lived close to the victim and was known to local law enforcement.

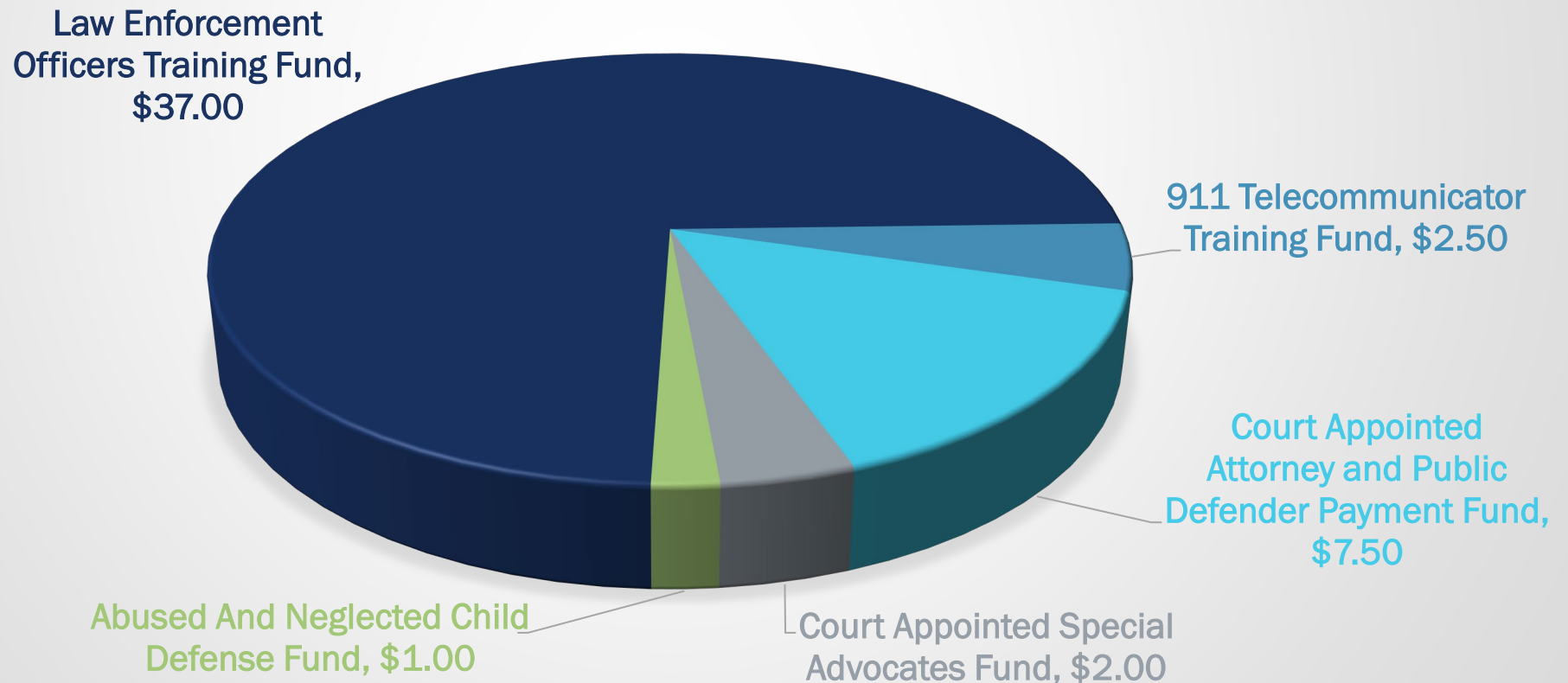
