My name is Joni Tschetter and I ran for District 15 State Representative. Due to such a tight race, District 15 qualified for a recount. Here is a brief summary of the 20024 election totals, the UOCAVA ballot totals per precinct, and the 2 day District 15 State Representative recount of the UOCAVA ballots.

The recount board chose to only verify the UOCAVA ballots from 2 of the 11 precincts in District 15's recount. They refused to verify any other precinct in District 15. The verification process included taking the 8.5" x 11" ballot that the voter printed off from the email they received from Minnehaha County. The voter then mailed his/her ballot to the county. On election day, the election workers took the mailed in ballot and had to recreate a new ballot with the same votes on a ballot that could be ran through the machine to be counted.

The process that the 3-member recount board used to double check the accuracy of the recreated ballots consisted of 1 member reading out loud the voter's markings from the mailed in ballots to the other 2 members

looking at the recreated ballot to verify no human error was made in duplicating the voter's intent. While listening to the recount board, I noticed that at least 9 out of 10 votes went to the democratic candidates. The other 1 out of 10 votes went about 50% of the time to the republican candidates and the other 50% of the time the voter did not vote in the District 15 House race. I recall only one time in which a voter voted for myself (R) and Kadyn Wittman (D). Otherwise, it was party line voting.
