AMENDMENT 75A FOR THE INTRODUCED BILL

An Act to require an indication of United States citizenship status on a motor vehicle operator's license or permit.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 32-12-17.10 be AMENDED:

- 32-12-17.10. An operator's license, motorcycle operator's license, restricted
 minor's permit, motorcycle restricted minor's permit, instruction permit, and motorcycle
 instruction permit-shall must bear-a:
- 8 (1) <u>A</u> distinguishing number assigned to the licensee, the;
- 9 (2) The full legal name or any name lawfully taken;
- 10 (3) The holder's date of birth₇;
- 11 (4) The holder's gender;
- 12 (5) The holder's principal residence address, an;
- 13 (6) An indication if the licensee is a donor pursuant to chapter 34-26, an;
- 14 <u>(7) An</u> indication if the licensee has a living will pursuant to chapter 34-12D or a 15 durable power of attorney for health care pursuant to chapter 59-7, an;
- <u>(8) An</u> indication if the licensee is a veteran pursuant to the provisions of § 32-12 17.15, a;
- 18 (9) <u>A</u> full facial digital photograph, a;
- 19 (10) A brief description of the licensee, the;
- 20 (<u>11) The</u> licensee's signature, security;
- 21 (12) Security features designed to deter forgery and counterfeiting, to promote an
 adequate level of confidence in the authenticity of the cards, and to facilitate
 detection of fraudulent cards, the;
- 24 (13) The issue date of the license, the;
- 25 (<u>14</u>) The expiration date of the license, an;

(15) An indication that the license is temporary or <u>for a limited term if the holder has</u> temporary lawful status in the United States, the; (16) An indication if the holder is a United States citizen, with a blue bar at the top of the card for a citizen, and a red bar at the top of the card for a non-citizen;

6 (18) <u>A</u> security marking approved by the United States Department of Homeland
 7 Security reflecting the level of compliance with 6 C.F.R. Part 37-as amended
 8 through (January 1, 2015. The department shall indicate upon each license); and

9 (19) An indication of the general class of vehicles that the licensee may drive.

10 The back of the license <u>shall must</u> contain a barcode. The department shall include 11 in the barcode the name of this state, the information printed on the license, the card 12 design revision date indicating the most recent change or modification to the visible format 13 of the card, and an indicator if the license is temporary or limited term. No barcode, or 14 other means by which information may be retrieved electronically, may contain the 15 licensee's social security number.
