1 **An Act to modify renewal fee requirements for an on-sale liquor licensee whose**
 2 **business premises have been annexed into a municipality of the first class.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1. That § 35-4-2 be AMENDED:**

5 **35-4-2.** The classes of licenses, with the fee of each class, are as follows:

6 (1) ~~Repealed by SL 2018, ch 223, § 13;~~

7 (2) Wholesalers of alcoholic beverages--five thousand dollars;

8 (3)(2) Off-sale--not less than three hundred dollars. The renewal fee for the license may
 9 not exceed five hundred dollars;

10 (4)(3) On-sale--not less than one dollar for each person residing within the municipality
 11 as measured by the last preceding federal census. The renewal fee for the license
 12 may not exceed fifteen hundred dollars, except as provided in § 35-4-13;

13 (5)(4) Off-sale licenses issued to municipalities under local option--not less than two
 14 hundred fifty dollars;

15 (6)(5) On-sale licenses issued outside municipalities--not less than the amount the
 16 nearest municipality to the applicant is charging for a like license. The renewal fee
 17 shall be the same as is charged for a like license in the nearest municipality. If the
 18 municipality to which the applicant is nearest holds an on-sale license, pursuant to
 19 § 35-3-13 and does not charge a specified fee, then the fee shall be the minimum
 20 amount that could be charged as if the municipality had not been authorized to
 21 obtain on-sale licenses pursuant to § 35-3-13. The renewal fee shall be the same
 22 as could be charged for a like license in the nearest municipality;

24 (8)(6) Transportation companies--twenty-five dollars;

25 (9)(7) Carrier--one hundred dollars. The fee licenses all conveyances the licensee
 26 operates in this state;

- 2 ~~(11)~~(8) On-sale dealers at publicly operated airports--two hundred fifty dollars;
- 3 ~~(12)~~(9) Wine and cider retailers, being both package dealers and on-sale dealers--five

- 5 ~~(13)~~(10) Convention facility on-sale--not less than one dollar for each person residing
6 within the municipality as measured by the last preceding federal census. The
7 renewal fee for the license may not exceed fifteen hundred dollars;

- 9 ~~(15)~~(11) Wholesalers of malt beverages--four hundred dollars;
- 10 ~~(16)~~(12) Malt beverage and wine produced by a farm winery licensee, being both
11 package dealers and on-sale dealers--three hundred dollars;

20 **Section 2. That § 35-4-13 be AMENDED:**

21 **35-4-13.** If, due to the annexation of territory by any municipality or county, the
22 premises of an on-sale licensee are transferred from one jurisdiction to another, the
23 licensee may continue to legally operate until the expiration of the license. After the
24 expiration of the license, the licensee may apply for renewal of the license to the governing
25 body that has jurisdiction over the licensed premises. The license application for renewal
26 may not be denied on the grounds that, by the issuance of the license, more on-sale
27 licenses are in existence than ~~is~~ are permitted by the limitations of this chapter.

28 If the licensee's premises have been annexed into a municipality of the first class
29 as described in § 9-2-1, the fee for the first renewal of the on-sale license after the
30 annexation may be equal to the fee for the most recent on-sale liquor license issued by
31 the municipality. In any subsequent renewal of the license, the renewal fee must not
32 exceed fifteen hundred dollars, as described in subdivision 35-4-2(4).
