MOTIONS AND RESOLUTIONS

- HB 1220 (Intent to Reconsider Vote by Which Lost) amend provisions pertaining to the verification of registered voters contained in the master registration file. (House State Affairs Engrossed)
- HB 1024 (Intent to Reconsider Vote by Which Lost) amend certain fees collected by the secretary of state. (Introduced)
- HB 1165 (Intent to Reconsider Vote by Which Lost) provide a means by which an agricultural producer can reject the imposition of an assessment on crops. (House Agriculture and Natural Resources Engrossed)
- SCR 604 Supporting the expansion of transportation services for veterans receiving medical care in this state. (Introduced)

CONSIDERATION OF REPORTS OF COMMITTEES (AMENDED BILLS)

HB 1132, HB 1223, HB 1256, HB 1259, HB 1260

SECOND READING AND CONSIDERATION OF CONSENT CALENDAR ITEMS

- HB 1141 provide an exception for employers to acquire and distribute opioid antagonists that are available over the counter. (Introduced)
- HB 1144 adopt the dietitian licensure compact. (Introduced)
- SB 25 clarify the adoption and use of the plumbing code. (House Commerce and Energy Engrossed)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1157 remove the maximum fee limit due when applying for a county drainage permit. (House Agriculture and Natural Resources Engrossed)
- HB 1152 prohibit the enforcement and implementation of directives from intergovernmental organizations, and to provide a penalty therefor. (House State Affairs Engrossed)
- HB 1222 expand the authorized carrying, possession, and storage of a concealed pistol. (House Judiciary Engrossed)

- HB 1193 prohibit the Board of Regents and institutions under its control from requiring students to reside in on-campus housing or purchase meal plans. (House Education Engrossed)
- HB 1042 make an appropriation for the construction of historical exhibits at the Cultural Heritage Center. (Joint Appropriations Engrossed)
- HB 1180 require that a candidate for election to the board of a school district disclose the candidate's party affiliation on a declaration of candidacy. (House Education Engrossed)
- HJR 5006 Proposing and submitting to the voters at the next general election amendments to the Constitution of the State of South Dakota, requiring an intervening general election before consideration of an initiated constitutional amendment or initiated measure having the same subject as a previously rejected initiated amendment or measure. (Introduced)
- HB 1194 authorize the cooperation of counties for purposes of operating an office of county director of equalization. (Introduced)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 33 (Deferred from 21st LD) make appropriations for water and environmental purposes and to declare an emergency. (Introduced)
