SB 52 authorize the expansion of the South Dakota State Veterans Cemetery, to make an appropriation therefor, and to declare an emergency. (Introduced)
SB 70 modify the maximum sparsity benefit a sparse school district is eligible to receive. (Senate Appropriations Engrossed)
SB 99 make an appropriation for purchasing, storing, and distributing sexual assault kits. (Introduced)
SB 136 make an appropriation to enhance the economic health of South Dakota.
(Introduced)
SB 137 make an appropriation for the economic development of South Dakota.
(Introduced)
SB 138 make an appropriation for developing the economic viability of South Dakota.
(Introduced)

- SB 144 require legislative approval for significant capital expenditures by the Department of Game, Fish and Parks. (Senate Appropriations Engrossed)
- SB 145 require legislative approval of real property leases that are necessary for the operation of state government and exceed specified durations or rental payments. (Senate Appropriations Engrossed)
- SB 146 revise provisions on interim transfers and appropriations. (Senate Appropriations Engrossed)
- SB 157 address labor trafficking in South Dakota. (Senate Commerce and Energy Engrossed)
- SB 163 require certain firefighting equipment purchased by a fire department contain particular labeling. (Introduced)
- SB 178 (Deferred from 25th LD) increase a tax on aviation gasoline and jet fuel. (Senate Taxation Engrossed)
- SB 201 prohibit contributions and loans from an authorized committee of a candidate for federal office. (Introduced)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1044 authorize the use of a newborn safety device for the voluntary surrender of a newborn and to make clarifying changes. (Introduced)
- HB 1057 transfer moneys from the South Dakota-bred racing fund to the special racing revolving fund. (Introduced)
- HB 1063 revise the provisions for preparing a fiscal note for ballot questions. (Introduced)
- HB 1068 allow a student to wear certain military decorations at a school graduation ceremony and to declare an emergency. (Senate Education Engrossed)
- HB 1093 require the board of a school district to hold a bond election at the primary or general election. (Senate Education Engrossed)
