SB 34 update the roles of the Department of Agriculture and Natural Resources and the Department of Public Safety regarding burning and burn permit issuing authority. (Introduced)

SB 170 authorize the South Dakota State Brand Board to enter a memorandum of understanding with any Indian tribe for the investigation of cattle theft. (Introduced)

SB 79 permit the operation of a Class I electric bicycle on the Mickelson Trail. (Introduced)

SB 129 modify renewal fee requirements for an on-sale liquor licensee whose business premises have been annexed into a municipality of the first class. (Senate Local Government Engrossed)

SB 167 revise certain provisions pertaining to municipal government. (Senate Local Government Engrossed)

SB 44 modify tax refunds for elderly persons and persons with a disability, to make an appropriation therefor, and to declare an emergency. (Introduced)

SB 99 make an appropriation for purchasing, storing, and distributing sexual assault kits. (Introduced)

SB 52 authorize the expansion of the South Dakota State Veterans Cemetery, to make an appropriation therefor, and to declare an emergency. (Introduced)

SB 46 specify the funds into which certain boat fees are deposited. (Introduced)
