**House Bill 1066****AMENDMENT 1066L  
FOR THE HOUSE STATE AFFAIRS ENGROSSED BILL**

1 **An Act to revise residency requirements for the purposes of voter registration.**

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 **Section 1. That § 12-1-4 be AMENDED:**

4 **12-1-4.** For the purposes of this title, ~~the term, residence,~~ "resident" means the  
5 place in which a person is domiciled as shown by an individual who maintains an actual  
6 fixed permanent dwelling, establishment, or any other abode where the individual lives  
7 and usually sleeps to which the person returns for at least thirty consecutive days. An  
8 individual who is a resident of this state remains a resident during an absence from this  
9 state, if the individual intends to return to this state after a period of absence. An individual  
10 may ~~have only~~ be a resident of one place ~~of residence.~~

11 ~~A person who leaves the residence and~~ If an individual who is a resident of a county  
12 of this state, goes into another county of this state or another state or territory for a  
13 temporary purpose ~~has not changed residence,~~ the individual remains a resident of the  
14 county.

15 ~~A person~~ An individual is considered to ~~have gained residence in any~~ be a resident  
16 of the county or municipality of this state in which the ~~person~~ individual actually lives, if  
17 the ~~person~~ individual has no present intention of leaving.

18 ~~A person~~ An individual ~~retains residence in~~ remains a resident of this state until  
19 another residence has been gained the individual becomes a resident of another state. If  
20 ~~a person~~ an individual moves from this state to another state or territory with the intention  
21 of making it the person's permanent home, the person ~~of~~ becoming a resident of that  
22 state or territory for any purpose, the individual loses residence in ~~is no longer a resident~~  
23 this state.

24 **Section 2. That § 12-4-1 be AMENDED:**

1           ~~12-4-1. A person~~An individual who maintains residence, as provided in is a  
2 resident of this state, as defined in § 12-1-4,~~within the state for at least thirty days prior~~  
3 ~~to submitting the registration form, and who has or will have~~ the qualifications of a voter  
4 prescribed by § 12-3-1 or 12-3-1.1,~~or who will have such qualifications~~ at the next  
5 ensuing municipal, primary, general, or school district election, is entitled to be registered  
6 as a voter in the election precinct in which the person maintains residence.

7           ~~A person~~An individual eligible to vote may vote only in the election precinct where  
8 the person maintains residence.

9           **Section 3. That § 12-4-1.2 be AMENDED:**

10           **12-4-1.2.** The voter registration form must include a certification of voter eligibility  
11 by which the applicant attests, under the penalty of perjury, that the applicant:

- 12           (1) Is a citizen of the United States;
- 13           (2) Will be eighteen years or older on or before the next election;
- 14           (3) ~~Has maintained residence in South Dakota for at least thirty days prior to~~  
15 ~~submitting the registration form~~ Is a resident of the state of South Dakota;
- 16           (4) Has not been judged mentally incompetent;
- 17           (5) Is not currently serving a sentence for a felony conviction; and
- 18           (6) Authorizes the cancellation of a previous registration, if applicable.
