On page 2, after line 27, of the Senate Engrossed bill, insert: "

Section 5. That a NEW SECTION be added to chapter 10-12:

Notwithstanding any other provision of law, if the limitation provided by § 10-13-35 constitutes a mill rate for a taxing district greater than a mill rate limitation provided by law for the district, the district may impose a tax levy resulting in a mill rate greater than the limits set forth in law, to the extent that the revenue payable from real property taxation in the district does not exceed the amount of revenue payable from real property taxation in the 2025 tax year, increased annually by:

- (1) The lesser of three percent or the index factor, as defined in § 10-13-38; and
- (2) The percentage of growth in value resulting from:

- (a) Improvements or changes in use of the real property within the district;
- (b) Annexation or minor boundary changes of the district; and
- (c) Adjustment in taxation or classification of property within the district."
