Goal to Eliminate Property Taxes

- We have a plan to replace <u>all</u> property tax revenue with a transaction tax.
- Our current sales tax will stay in place as is.
- We are proposing an initial \$1.50 tax on EVERY transaction generated in South Dakota.
- Small purchases will be assessed a 10% tax on purchases under \$15.00. Once \$15.00 is reached the full tax would be realized.
- This would **completely cover** the annual total of property tax revenue in the state.
- This becomes the funding source for <u>all</u> schools, counties, cities, volunteer fire departments, water districts, etc.
- Ultimate Goal: Remove the threat of government or others from taking our properties with a tax lien.

COMPARISONS

TWO RECEIPTS PER DAY @ \$1.50/RECEIPT = \$3.00/DAY X 365 DAYS = \$1095.00 IN TAXES

ASSUMING \$4000 IN ANNUAL PROPERTY TAXES PAID:

AT \$1.50/RECEIPT THIS WOULD TAKE 2,667 RECEIPTS ANNUALLY TO EQUAL THIS DOLLAR AMOUNT OR APPROXIMATELY 7.3 RECEIPTS PER DAY AVERAGE or 22 RECEIPTS EVERY THREE DAYS.

WE BELIEVE THIS IS HIGHLY UNLIKELY.

Economic Impacts

- Currently all property owners are technically renters via taxation
- Property improvements are penalized through higher assessments
- Removing property taxes opens the flood gates for improvements
- Improvements can be enjoyed without penalty of higher taxes
- Property owners can now invest that money into the economy
- Businesses will see increased sales and potential growth
- Growing businesses will hire more people and give raises
- Both fixed income folks and young people can afford homes

Transaction Tax to totally replace property taxes in SD

Estimates below will show the number of transactions from several groups per year in SD

Approx. 15,000,000 visitors X 50 transactions/visitor = 750,000,000 transactions Approx. 1,000,000 residents X 350 transactions/resident = 350,000,000 transactions Approx. 92,200 businesses X 750 transactions/business = 69,150,000 transactions TOTAL TRANSACTIONS = 1,169,150,000
```

Total Property Tax Revenue in 2020: \$1.439 Billion (1,169,150,000 X \$1.25 = \$1.461 B) in 2023: \$1.655 Billion (1,169,150,000 X \$1.50 = \$1.754 B)
