1 **An Act to update the official code of laws.**

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 **Section 1. That § 2-16-13 be AMENDED:**

4 **2-16-13.** The official code of laws of the State of South Dakota, which may be
5 referred to as the code, consists of all the statutes of a general and permanent nature

25 **Section 2. That § 2-16-15 be AMENDED:**

26 **2-16-15.** No provision of the code enacted by § 2-16-13, as to which any action
 27 or proceeding, civil or criminal, has been commenced prior to July 1, ~~2025~~ 2026, to
 28 determine whether or not the provision was constitutionally enacted, is validated by the
 29 enactment of the code.

30 The enactment of the code:

- 31 (1) Does not affect the validity of any transaction;
 32 (2) Does not impair the curative or legalizing effect of any statute; and
 33 (3) Does not release or extinguish any penalty, confiscation, forfeiture, or liability;
 34 which accrued, occurred, or took effect prior to the time the code took effect.

1 **Section 3. That § 2-16-16 be AMENDED:**

2 **2-16-16.** All statutes enacted at the ~~2025~~ 2026 session of the Legislature, other
3 than the code enacted by § 2-16-13, are deemed to have been enacted subsequent to the
4 enactment of the code. If any statute repeals, amends, contravenes, or is inconsistent
5 with the provisions of the code, the provisions of the statute prevail. Any enactment in
6 the ~~2025~~ 2026 session of the Legislature that cites South Dakota Codified Laws for the
7 purpose of amendment or repeal must be construed as having reference to the code
8 enacted by § 2-16-13.
