### MOTIONS AND RESOLUTIONS

HCR 6012 recognizing the YMCA for 175 years of service to youth, families, and communities in South Dakota and across the United States. (Introduced)

### SECOND READING AND CONSIDERATION OF CONSENT CALENDAR ITEMS

HB 1188 clarify the duties and limit the liability of law enforcement officers and others when removing a disabled vehicle from a highway, a right of way, or public waters. (House Transportation Engrossed)

HB 1189 establish a greater tire weight limit for a mobile crane moving on any highway in this state. (House Transportation Engrossed)

HB 1018 amend the reversion date for moneys appropriated to the Department of Education to improve and renovate the Cultural Heritage Center. (Introduced)

HB 1164 establish the crime of fraudulent assisted reproduction and provide a penalty and civil liability therefor. (Introduced)

SB 50 update the reference to the Internal Revenue Code to reflect current federal law for the administration of South Dakota Retirement System statutes. (Introduced) (Fiscal Note)

SB 51 revise certain requirements for contesting actions of the South Dakota Retirement System. (Introduced) (Fiscal Note)

SB 52 clarify statutes governing the administration of disability benefits by the South Dakota Retirement System. (Introduced) (Fiscal Note)

SB 53 ensure uniformity in member identification provisions governing the South Dakota Retirement System. (Introduced) (Fiscal Note)

SB 54 revise the conditions for in-service distributions from the South Dakota deferred compensation plan. (Introduced) (Fiscal Note)

SB 65 revise certain required minimum distribution provisions of the South Dakota Retirement System. (Introduced) (Fiscal Note)

### SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

HB 1066 (Deferred from 17<sup>th</sup> LD) (JR 5-17 with pending amendment)(Removed from Consent Calendar) revise a provision related to theft by a contractor, subcontractor, or supplier. (Introduced)

- HB 1001 provide for prescribed burning of state-owned land by a person owning adjoining land and to declare an emergency.  
(House Agriculture and Natural Resources Engrossed)
- HB 1233 modify provisions for a tax collection agreement with an Indian tribe.  
(House Taxation Engrossed)
- HB 1245 authorize municipalities to establish a local funding mechanism for capital improvement projects. (House Local Government Engrossed)
- HB 1116 prohibit a video streaming service from transmitting certain advertising during children's programming and provide a penalty therefor.  
(House State Affairs Engrossed)
- HB 1099 reschedule the pharmaceutical composition of crystalline polymorph psilocybin in a drug product approved by the Food and Drug Administration as a Schedule IV controlled substance. (Introduced)
- HB 1215 authorize counties and municipalities to issue a license for a cigar bar.  
(Introduced)
- HB 1180 ensure the validity of non-compete agreements in the context of jointly owned business entities. (Introduced)
- HB 1197 revise a provision related to the venue of adoption proceedings. (Introduced)
