CONSIDERATION OF REPORTS OF COMMITTEES (AMENDED BILLS)

HB 1017, HB 1045, HB 1275, HB 1292

SECOND READING AND CONSIDERATION OF CONSENT CALENDAR ITEMS

- HB 1199 address prior authorization and reporting requirements by utilization review organizations and health carriers.
(House Health and Human Services Engrossed)
- HB 1311 require the reporting of funding given by certain persons and governments to institutions under the control of the Board of Regents and the South Dakota Board of Technical Education. (Introduced)
- SB 73 revise provisions relating to state financial practices.
(Senate Appropriations Engrossed)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1254 (Removed from Consent Calendar) exempt any soil amendment used exclusively for agricultural purposes from sales tax, and to modify the definition of a soil amendment. (House Taxation Engrossed)
- HB 1138 require the licensure of non-medical home care agencies, and to provide a penalty therefor. (House Health and Human Services Engrossed)
- HB 1220 regulate the sale of nicotine products, and to provide a penalty therefor. (House Health and Human Services Engrossed)
- HB 1222 prohibit members of the Board of Economic Development from having any interest in moneys from or approved by the Board of Economic Development. (Introduced)
- HB 1089 modify the distributions of revenues collected from severance taxation on new permits. (Introduced)
- HB 1040 revise the child support obligation schedule. (Introduced)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 20 make an appropriation for tax refunds for elderly persons and persons with a disability, and to declare an emergency. (Introduced)
- SB 55 make an appropriation for the payment of extraordinary litigation expenses and to declare an emergency. (Introduced)

- SB 116 (Deferred from 23rd LD) make an appropriation for the design and construction of an indoor athletics facility at Dakota State University and to declare an emergency. (Joint Appropriations Engrossed)
- SB 129 (Deferred from 23rd LD) update references in certain statutes to the 2024 standard building codes. (Introduced)
- SB 3 (Deferred from 23rd LD) limit the types of residential improvements for which counties, municipalities, and townships may require a permit. (House Local Government Engrossed)
- SB 72 extend the time for reverting moneys appropriated for the modernization of the state's enterprise resource planning systems. (Introduced)
- SB 75 amend the type of entities eligible to participate in the cybersecurity services initiative. (Senate Appropriations Engrossed)
