- FOR AN ACT ENTITLED, An Act to permit car rental companies to include certain fees in a rental agreement.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That the code be amended by adding a NEW SECTION to read:
- 5 Terms used in this Act mean:
- 6 (1) "Car rental company," a business with a primary purpose of renting motor vehicles
 7 to consumers under rental agreements for periods of ninety days or less;
- 8 (2) "Vehicle license cost recovery fee," a charge that may be separately stated and
 9 charged on the rental contract in a vehicle rental transaction originating in this state
 10 to recover costs incurred by a car rental company to license, title, register, plate, and
 11 inspect rental vehicles.
- 12 Section 2. That the code be amended by adding a NEW SECTION to read:
- A car rental company may include separately stated surcharges, fees, or charges in a rental agreement, which may include vehicle license cost recovery fees, airport access fees, airport

- 1 concession fees, and all applicable taxes.
- 2 Section 3. That the code be amended by adding a NEW SECTION to read:
- 3 If a car rental company includes a vehicle license cost recovery fee as a separately stated
- 4 charge in a rental transaction, the amount of the fee shall represent the car rental company's
- 5 good-faith estimate of the car rental company's daily charge as calculated by the car rental
- 6 company to recover its actual total annual motor vehicle licensing, titling, registration, plating,
- 7 and inspection costs.
- 8 Section 4. That the code be amended by adding a NEW SECTION to read:
- 9 If the total amount of the vehicle license cost recovery fees collected by a car rental company
- under this Act in any calendar year exceeds the car rental company's actual costs to license, title,
- register, plate, and inspect the motor vehicles for that calendar year, the car rental company shall
- do both of the following:
- 13 (1) Retain the excess amount; and
- 14 (2) Adjust the estimated average per vehicle license cost recovery fee for the following
- calendar year by a corresponding amount.
- Nothing in this section prevents a rental car company from making adjustments to the
- vehicle license cost recovery fee during the calendar year.
