- 1 FOR AN ACT ENTITLED, An Act to require the Legislative Planning Committee to provide
- 2 oversight to the Board of Regents on issues relating to the university centers.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That § 13-51-1.4 be amended to read:
- 5 13-51-1.4. Commencing in 2016 and every ten years 2017 and every year thereafter, the
- 6 provisions of § 13-51-1.3 shall be reviewed by a special legislative task force consisting of the
- 7 speaker of the House of Representatives and four other members of the House of
- 8 Representatives appointed by the speaker of the House of Representatives and the president pro-
- 9 tempore of the Senate and four other members of the Senate appointed by the president pro-
- 10 tempore of the Senate. Not all of the members from the House of Representatives or the Senate
- 11 may be of the same party the Legislative Planning Committee. The special legislative task force
- 12 <u>Legislative Planning Committee</u> shall review the appropriateness of the provisions of § 13-51-
- 1.3 and make recommendations to the Legislature regarding any revisions, additions, or
- deletions to the various conditions contained in § 13-51-1.3. The committee shall, at the same
- time, conduct a review of each of the university centers, the off-campus sites in Pierre, Rapid

1 City, and Sioux Falls where courses are being offered, and report the committee findings and

- 2 recommendations to the Legislature.
- 3 Section 2. That § 13-48A-7 be amended to read:
- 4 13-48A-7. The Board of Regents and the Board of Education shall each provide to the
- 5 Legislative Planning Committee an annual accountability report as determined by the
- 6 committee. The annual accountability report provided by the Board of Regents shall include a
- 7 financial report on each of the university centers located in Pierre, Rapid City, and Sioux Falls
- 8 <u>as provided in section 3 of this Act.</u>
- 9 Section 3. That chapter 13-48A be amended by adding a NEW SECTION to read:
- The financial report on each of the university centers located in Pierre, Rapid City, and
- Sioux Falls required in section 2 of this Act shall contain a summary statement of the financial
- 12 condition of the university center that includes the following:
- 13 (1) The beginning and ending cash balances for each of the preceding two fiscal years;
- 14 (2) A detailed comparative statement of actual revenue for each of the two preceding
- fiscal years, and the estimated revenue of the current fiscal year and the next fiscal
- year. The statements of revenue and estimated revenue shall be classified by source.
- The existing sources of revenue shall be analyzed as to their sustainability, and
- explanations shall be provided for any new sources of revenue;
- 19 (3) A detailed comparative statement of expenditures for each of the preceding two fiscal
- years, the budget of the current fiscal year, and the budget for the next fiscal year.
- 21 The statements of expenditures shall be classified as personal services, capital outlay,
- state institution support, state institution services, and operating expenditures, and
- include the number of full-time equivalent employees; and
- 24 (4) Any other financial information as requested by the Legislative Planning Committee.
