- 1 FOR AN ACT ENTITLED, An Act to authorize certain insurance transactions and policies in
- 2 a language other than English.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That chapter 58-1 be amended by adding a NEW SECTION to read:
- 5 The controlling version of any insurance policy offered in South Dakota shall be the English
- 6 version. An authorized insurer, as defined in subdivision 58-1-2(2), may conduct transactions
- 7 in a language other than English through an employee or agent acting as interpreter or through
- 8 an interpreter provided by the customer.
- 9 Section 2. That chapter 58-1 be amended by adding a NEW SECTION to read:
- An authorized insurer, as defined in subdivision 58-1-2(2), may provide insurance policies,
- endorsements, riders, and any explanatory or advertising materials in a language other than
- 12 English. If there is a dispute or complaint regarding the insurance or advertising material, the
- 13 English language version of the insurance coverage shall control the resolution of the dispute

- 2 Section 3. That chapter 58-1 be amended by adding a NEW SECTION to read:
- An authorized insurer, as defined in subdivision 58-1-2(2), providing a policy as authorized
- 4 in section 2 of this Act may only offer that policy after the insurer has first filed a statement with
- 5 the Division of Insurance attesting that the policy in a language other than English is the
- 6 translation of a policy form already filed and approved by the division.
- 7 Section 4. That chapter 58-1 be amended by adding a NEW SECTION to read:
- A policy offered in a language other than English must clearly state in the language of that
- 9 policy being marketed, that if a dispute or complaint occurs regarding the meaning of the policy,
- the dispute shall be resolved by the English version interpretation.
- 11 Section 5. That chapter 58-1 be amended by adding a NEW SECTION to read:
- Nothing contained in this Act shall abrogate or supersede the provisions set forth in chapter
- 13 58-33 relating to unfair trade practices.
