- 1 FOR AN ACT ENTITLED, An Act to establish the South Dakota state seal of civics literacy
- 2 program.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That chapter 13-1 be amended by adding a NEW SECTION to read:
- 5 There is established in the Department of Education the South Dakota state seal of civics
- 6 literacy program. The purpose of the program is to recognize high school students who, upon
- 7 graduating from high school, have attained a high level of proficiency in civics. The program
- 8 is voluntary. Any school district, nonpublic school, or person providing alternative instruction
- 9 to a student pursuant to § 13-27-3 may participate in the program by notifying the secretary of
- education. The program shall be implemented in the 2020-2021 school year.
- 11 Section 2. That chapter 13-1 be amended by adding a NEW SECTION to read:
- 12 Each participating school district, nonpublic school, and person providing alternative
- instruction shall:

3	(2)	Affix a reproduction of the seal of the State of South Dakota to the diploma and note

6	Section 3. That chapter 13-1 be amended by adding a NEW SECTION to read:	
7	To implement the state seal of civics literacy program, the Department of Education shall	
8	deliver to each participating school district, nonpublic school, and person providing alternative	
9	instruction full color reproductions of the seal of the State of South Dakota in a size large	
10	enough for the state motto to be legible.	
11	Section 4. That chapter 13-1 be amended by adding a NEW SECTION to read:	
12	The 1	Board of Education Standards shall, in rules promulgated pursuant to chapter 1-26,
13	establish the requirements a student shall meet in order to be awarded a state seal of civics	
14	literacy.	The requirements shall exceed the social studies requirements for graduation
15	establish	ed by the board under § 13-1-12.1, and shall, at a minimum, include demonstrated
16	competencies in the following:	
17	(1)	An understanding of the basic principles of American democracy and how those

  - (2) An understanding of the Constitutions of the United States and of this state;
