- 1 FOR AN ACT ENTITLED, An Act to authorize the production and transport of saltwater
- 2 crustaceans.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That § 40-5-1.1 be amended to read:
- 5 40-5-1.1. Terms used in this chapter mean:
- 6 (1) "Animals," any mammal, bird, reptile, amphibian, crustacean, or fish, except humans;
- 7 (2) "Captive wild animals," any wild animal held in man-made confinement or
- 8 physically altered to limit movement and facilitate capture;
- 9 (3) "Domestic animals," any animal that through long association with man, has been
- bred to a degree which has resulted in genetic changes affecting the temperament,

- 1 color, conformation, or other attributes of the species to an extent that makes it 2 unique and different from wild individuals of its kind;
- 3 (4) "Exotic animals," any animal not occurring naturally in the United States either currently or historically;
- 5 (5) "Nondomestic animals," any animal that is not domestic;
- 6 (6) "Wild animals," any animal not in captivity, other than domestic animals;
- 7 (7) "Zoological animals," any animal in any zoo or intended to be used in a zoo.
