# House Bill 1022

*Introduced by: The Committee on Transportation at the request of the Department of Revenue*

1 **An Act to revise certain provisions regarding motor vehicle, snowmobile, and boat**  
 2 **dealer licenses.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1.** That § 32-6B-14 be AMENDED:

5 **32-6B-14. Dealer license--Annual review--Renewal notice--Suspension or**  
 6 **revocation--Promulgation of Rules.**

7 ~~Each license may be issued for a multiple year period.~~ The application for license  
 8 and all applicable fees are due prior to the issuance of the initial license. Each license  
 9 renewal shall be reviewed annually by the department. The department shall mail to the  
 10 licensee at the last known address a renewal notice. If the licensee is registered on the  
 11 electronic dealer system, the licensee shall receive the renewal notice by electronic means.  
 12 The department shall establish by rules promulgated pursuant to chapter 1-26 the review  
 13 date, if other than October first to December thirty-first, inclusive. If the licensee fails to  
 14 return the renewal notice or to pay the applicable fees the department shall suspend or  
 15 revoke the license pursuant to the provisions of §§ 32-6B-41.1 to 32-6B-41.6, inclusive.

16 **Section 2.** That § 32-6C-5 be AMENDED:

17 **32-6C-5. Dealer license--Fee--Renewal--Disposition of fees.**

18 Upon making initial application for a dealer's license, the applicant shall pay a fee  
 19 of one hundred fifty dollars to the department. ~~Each license shall be valid from July first~~  
 20 ~~through the following June thirtieth, unless suspended or revoked prior to the expiration~~  
 21 ~~date.~~ A renewal application shall be submitted to the department annually, unless the  
 22 license has been revoked prior to the expiration date, along with a renewal fee of one  
 23 hundred twenty-five dollars, prior to the expiration of the old license. The renewal  
 24 application shall contain the same information as is required in § 32-6C-3. Any application  
 25 for renewal made after the expiration date shall be accompanied by an initial license fee.

1 Any licensee who does not file ~~his~~an application and renewal fee with the department  
2 prior to the expiration date shall cease to engage in business as a dealer on the license  
3 expiration date. All money collected pursuant to this section shall be deposited in the state  
4 motor vehicle fund.

5 **Section 3.** That § 32-7B-8 be AMENDED:

6 **32-7B-8. Dealer license—Fee—Renewal—Disposition of fees--Promulgation**  
7 **of Rules.**

8 ~~Each license may be issued for a multiple year period. The application for license~~  
9 ~~and all applicable fees are due prior to the issuance of the initial license. The initial fee for~~  
10 ~~a license shall be two hundred fifty dollars, and a renewal license shall be one hundred~~  
11 ~~seventy-five dollars. All licenses shall be reviewed annually by the department. The~~  
12 ~~department shall mail to the licensee at the last known address a renewal notice. The~~  
13 ~~department shall establish by rules promulgated pursuant to chapter 1-26 the review date,~~  
14 ~~if other than October first to December thirty-first, inclusive. If the licensee fails to return~~  
15 ~~the renewal notice or to pay the applicable fees, the department shall cancel and revoke~~  
16 ~~the license pursuant to the provisions of § 32-7B-17. Any licensee who does not file the~~  
17 ~~licensee's renewal notice and fee with the department prior to the expiration date shall~~  
18 ~~cease to engage in business as a dealer on the license expiration date. All money collected~~  
19 ~~pursuant to this section shall be deposited in the state motor vehicle fund.~~
