AMENDMENT 58C FOR THE INTRODUCED BILL

1 **An Act to limit gifts to directors or employees of certain government districts.**

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 **Section 1.** That a NEW SECTION be added:

4 **34A-16-7.1. Limitation on gifts.**

5 During a calendar year a regional recycling and waste management district may
6 not give gifts using district funds having a cumulative value of one ~~hundred-thousand~~
7 dollars or more to any district commissioner or employee of the district.

8 **Section 2.** That a NEW SECTION be added:

9 **46A-3D-1.1. Limitation on gifts.**

10 During a calendar year a water development district may not give gifts using
11 district funds having a cumulative value of one ~~hundred-thousand~~ dollars or more to any
12 district director or employee of the district.

13 **Section 3.** That a NEW SECTION be added:

14 **46A-18-34.1. Limitation on gifts.**

15 During a calendar year a water project district may not give gifts using district
16 funds having a cumulative value of one ~~hundred-thousand~~ dollars or more to any district
17 director or employee of the district.

18 **Section 4.** That a NEW SECTION be added:

19 **46A-4-47.1. Limitation on gifts.**

20 During a calendar year an irrigation district may not give gifts using district funds
21 having a cumulative value of one ~~hundred-thousand~~ dollars or more to any district director
22 or employee of the district.

1 **Section 5.** That a NEW SECTION be added:

2 **46A-9-33.1. Limitation on gifts.**

3 During a calendar year a water user district may not give gifts using district funds
4 having a cumulative value of one ~~hundred-thousand~~ dollars or more to any district director
5 or employee of the district.

6 **Section 6.** That a NEW SECTION be added:

7 **46A-14-42.1. Limitation on gifts.**

8 During a calendar year a watershed district may not give gifts using district funds
9 having a cumulative value of one ~~hundred-thousand~~ dollars or more to any district
10 manager or employee of the district.

11 **Section 7.** That a NEW SECTION be added:

12 **34A-5-27.1. Limitation on gifts.**

13 During a calendar year a sanitary district may not give gifts using district funds
14 having a cumulative value of one ~~hundred-thousand~~ dollars or more to any district trustee
15 or employee of the district.

16 **Section 8.** That a NEW SECTION be added:

17 **38-8-47.1. Limitation on gifts.**

18 During a calendar year a conservation district may not give gifts using district funds
19 having a cumulative value of one ~~hundred-thousand~~ dollars or more to any conservation
20 district supervisor or employee of the district.

21 **Section 9.** That a NEW SECTION be added:

22 **40-37-9.1. Limitation on gifts.**

23 During a calendar year a predator control district may not give gifts using district
24 funds having a cumulative value of one ~~hundred-thousand~~ dollars or more to any district
25 director or employee of the district.

26 **Section 10.** That a NEW SECTION be added:

1 **34-11A-14.1. Limitation on gifts.**

2 During a calendar year an ambulance district may not give gifts using district funds
3 having a cumulative value of one ~~hundred-thousand~~ dollars or more to any district director
4 or employee of the district.

5 **Section 11.** That a NEW SECTION be added:

6 **34-31A-15.2. Limitation on gifts.**

7 During a calendar year a rural fire protection district may not give gifts using
8 district funds having a cumulative value of one ~~hundred-thousand~~ dollars or more to any
9 district director or employee of the district.

10 **Section 12.** That a NEW SECTION be added:

11 **34-10-33. Limitation on gifts.**

12 During a calendar year a public hospital district may not give gifts using district
13 trustee or employee of the district.

15 **Section 13.** That a NEW SECTION be added:

16 **49-17A-10.1. Limitation on gifts.**

17 During a calendar year a regional railroad authority may not give gifts using district
18 commissioner or employee of the district.

20 **Section 14.** That a NEW SECTION be added:

21 **49-36-16.1. Limitation on gifts.**

22 During a calendar year a consumer power district may not give gifts using district
23 director or employee of the district.

25 **Section 15.** That a NEW SECTION be added:

26 **31-12A-21.1. Limitation on gifts.**

27 During a calendar year a road district may not give gifts using district funds having
28 employee of the district.

2 **7-25A-20.1. Limitation on gifts.**

3 During a calendar year an improvement district may not give gifts using district
4 funds having a cumulative value of one ~~hundred-thousand~~ dollars or more to any district
5 supervisor or employee of the district.
