# House Bill 1197

Introduced by: **Representative Gosch**

1 **An Act to require testing of moisture meters and protein-measuring devices.**

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 **Section 1.** That a NEW SECTION be added:

4 **38-31A-1. Definitions.**

5 Terms used in this chapter mean:

6 (1) "Agricultural commodity," any grain or seed that is ordinarily tested for moisture  
7 content when offered for sale, processing, or storage;

8 (2) "Department," the Department of Public Safety;

9 (3) "Moisture-measuring devices," any electronic device or instrument used in  
10 ascertaining the moisture content of agricultural commodities;

11 (4) "Protein-measuring devices," any electronic device or instrument used in  
12 ascertaining the protein content of agricultural commodities;

13 (5) "Secretary," the secretary of the Department of Public Safety.

14 **Section 2.** That a NEW SECTION be added:

15 **38-31A-2. Inspection--Moisture Meters--Protein-Measuring Devices.**

16 The department shall inspect any moisture-measuring device or protein-measuring  
17 device used in commerce in this state, as authorized under chapter 37-21, except those  
18 belonging to the United States. The department shall inspect a device every year. If an  
19 inspection or comparative test reveals that the moisture-measuring device or protein-  
20 measuring device being inspected or tested conforms to the standards and specifications  
21 established by the department, the department shall mark it with an appropriate seal  
22 under § 37-21-13.

23 Any moisture-measuring device or protein-measuring device that upon inspection  
24 is found not to conform with the specifications and standards established by the  
25 department shall be marked with an appropriate seal showing the device to be defective.

1 The seal may not be altered or removed until the device is properly repaired and  
2 reinspected. The owner or user of such device shall be notified of the defective condition  
3 by the department on an inspection form prepared by the department.

4 **Section 3.** That a NEW SECTION be added:

5 **38-31A-3. Fees--Promulgation of rules.**

6 The department may charge a fee, not to exceed thirty dollars, for each device  
7 subject to inspection under the provisions of this chapter. The department shall establish  
8 the amount of the fee by rule promulgated in accordance with chapter 1-26. Fees collected  
9 under the provisions of this chapter shall be deposited in the general fund.

10 **Section 4.** That a NEW SECTION be added:

11 **38-31A-4. Location--Devices--Procedure.**

12 Any device used to ascertain the moisture or protein content of agricultural  
13 commodities offered for sale, processing, or storage shall be used in a location visible to  
14 the general public and the procedure for operating the moisture-measuring device or the  
15 protein-measuring device shall be displayed in a conspicuous place close to the device.

16 **Section 5.** That a NEW SECTION be added:

17 **38-31A-5. Use--Defective Device--Violation as misdemeanor.**

18 No person may use or cause to be used a moisture-measuring device or protein-  
19 measuring device in commerce that has been inspected by the department and was  
20 determined to be defective. If a conviction for a violation of this section is for a first  
21 offense, the person is guilty of a Class 2 misdemeanor. If conviction for a violation of this  
22 section is for a second or subsequent offense, the person is guilty of a Class 1  
23 misdemeanor.

24 **Section 6.** That a NEW SECTION be added:

25 **38-31A-6. Promulgation of rules--Inspection and Test Standards.**

26 The department shall promulgate rules pursuant to chapter 1-26 to establish any  
27 inspection and test standards in compliance with § 37-21-6.

28 **Section 7.** That a NEW SECTION be added:

1           **38-31A-7. Complaint--Investigation.**

2           If a person believes a device under this chapter is defective or inaccurate, the  
3           person may bring a complaint under § 37-21-10.
