MOTIONS AND RESOLUTIONS

- HCR 6006 Requesting the members of South Dakota's congressional delegation to annually appear before a joint session of the Legislature to provide information and answer questions. (Introduced)
- HCR 6007 Supporting students and other persons afflicted by epilepsy and raising awareness of epilepsy in South Dakota. (Introduced)
- HR 7002 To formally invite President Donald J. Trump and First Lady Melania Trump to the great state of South Dakota for the 4th of July fireworks celebration at Mount Rushmore. (Introduced)

SECOND READING OF CONSENT CALENDAR ITEMS

- HB 1106 authorize the state investment officer to include an indemnity provision in certain investment-related documents. (Introduced)
- SB 10 revise certain provisions regarding cosmetology licensees. (Introduced)
- SB 12 revise certain provisions regarding comity licensure in the technical professions. (Introduced)
- SB 13 revise certain educational requirements for the practice of barbering. (Introduced)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1096 (Deferred from 13th LD) (JR 5-17 with pending amendment) prohibit commercial surrogacy contracts and provide a penalty for facilitating a commercial surrogacy. (House Judiciary Engrossed)
- HB 1054 (Deferred from 14th LD) revise the documentation required for voter registration. (House Local Government Engrossed)

- HB 1048 revise certain requirements for certain advisory committees under the Board of Medical and Osteopathic Examiners, Board of Nursing, and Board of Social Work Examiners. (Introduced)
- HB 1047 revise certain provisions regarding human trafficking. (Introduced) (PJPCE)
