- HB 1082 revise the conditions under which a licensed vehicle dealer may display or sell certain vehicles. (House Transportation Engrossed)
- HB 1086 repeal certain fees charged by a clerk of courts. (Introduced)
- HB 1089 provide for the discharge of certain persons who received a suspended imposition of sentence for a misdemeanor. (Introduced)
- HB 1206 revise certain provisions regarding the commitment of a delinquent child to the Department of Corrections. (Introduced)
- HB 1207 extend the termination date for the Juvenile Justice Public Safety Oversight Council. (Introduced)

- HB 1048 (Deferred from 16th LD) revise certain requirements for certain advisory committees under the Board of Medical and Osteopathic Examiners, Board of Nursing, and Board of Social Work Examiners. (Introduced)
- HB 1013 (Deferred from 16th LD) correct technical errors in statutory cross-references. (House Judiciary Engrossed)
- HB 1065 (Deferred from 16th LD) revise drone surveillance protections. (House Judiciary Engrossed)
- HB 1092 (Deferred from 16th LD) establish immunity from liability for injuries to or the death of a person engaged in off-road vehicle activity under certain circumstances. (House Judiciary Engrossed)
- HB 1094 (Deferred from 16th LD) repeal certain provisions regarding permits for concealed pistols. (Introduced)
- HB 1008 legalize the growth, production, and transportation of industrial hemp in the state, and to declare an emergency. (House Agriculture and Natural Resources Engrossed) (PJPCE)
- HB 1099 authorize counties to impose a temporary voter-approved half-cent sales and use tax and to issue revenue bonds to fund certain county infrastructure construction. (House Taxation Engrossed)
- HB 1127 revise provisions regarding real estate appraisers. (Introduced)
- HB 1164 codify legislation enacted in 2019. (Introduced)
- HB 1024 make an appropriation for the payment of extraordinary litigation expenses and to declare an emergency. (Introduced)
- HB 1027 make an appropriation from the coordinated natural resources conservation fund to the State Conservation Commission and to declare an emergency. (Introduced)
- HB 1029 make an appropriation for costs related to suppression of wildfires in the state and to declare an emergency. (Introduced)
