SB 19 (Deferred from 17th LD) revise certain provisions regarding marriage and
family therapists. (Introduced)
SB 18 (Deferred from 18th LD) revise certain provisions regarding professional
counselors. (Senate Health and Human Services Engrossed)
SB 92 (Deferred from 18th LD) to provide for the repurposing of STAR Academy.
(Introduced)
SB 26 (Deferred from 18th LD) increase the assessment of liquidated court costs and
to revise the disposition of the funds collected. (Introduced)

- SB 90 (Deferred from 18th LD) revise the distribution of motor fuel tax revenue, create a small structure and large culvert fund, provide for the use and administration of the fund, and to make an appropriation thereof. (Senate Local Government Engrossed)
- SB 137 (Deferred from 18th LD) revise provisions for repair, replacement, and construction of sidewalks within a municipality. (Introduced)
- SB 103 (Deferred from 18th LD) limit the disclosure of presidential election results and to provide for a suspension of such disclosure. (Introduced)
- SB 113 revise certain provisions regarding instruction permits and restricted minor's driving permits. (Senate Transportation Engrossed)
- SB 119 revise certain provisions regarding private placement insurance. (Introduced)
- SB 33 authorize the Department of the Military to construct a storage building located in Brown County, to make an appropriation therefor, and to declare an emergency. (Introduced)
- SB 35 revise the appropriation for the State Veterans' Cemetery and to declare an emergency. (Introduced)
- SB 124 to revise provisions regarding group pheasant hunts for disabled veterans. (Senate Military and Veterans Affairs Engrossed)
