- HCR 6002 Supporting the repeal of the Sioux - Dakota Removal Act. (Introduced)
- HCR 6005 Commending the nation of Israel for its cordial and mutually beneficial relationship with the United States and with the State of South Dakota. (Introduced)
- HCR 6009 Strengthening the sister-state ties between the State of South Dakota and Taiwan; supporting the signing of a Bilateral Trade Agreement (BTA) between Taiwan and the United States; and reaffirming support for increasing Taiwan's international participation. (Introduced)
- HCR 6012 Supporting the right to pray in public schools. (Introduced)

SECOND READING OF CONSENT CALENDAR ITEMS

- HB 1138 establish shooting course requirements for current or former law enforcement officers seeking an enhanced permit to carry a concealed pistol. (House State Affairs Engrossed)
- HB 1077 establish certain requirements regarding funeral processions. (House Judiciary Engrossed)
- HB 1116 revise provisions regarding the use of perpetual care trust funds to maintain cemeteries. (Introduced)
- HB 1014 place certain substances on the controlled substances schedule and to declare an emergency. (Introduced)
- SB 14 revise registration requirements for motor vehicles, motorcycles, snowmobiles, trailers, and semitrailers. (Introduced)
- SB 15 revise certain provisions regarding the retention of motor vehicle title documents by the Department of Revenue. (Introduced)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1153 (Removed from Consent Calendar) authorize the limited possession of a knife in the state capitol. (Introduced)
- HJR 5001 (Deferred from 18th LD) To apply for a convention of states under Article V of the Constitution of the United States to impose fiscal restraints on the federal government, to limit the power and jurisdiction of the federal government, and to limit the terms of office for federal officials and members of Congress. (Introduced) (Fiscal Note)
- HB 1131 (Deferred from 18th LD) prohibit the use of misleading identification for telephonic communications. (Introduced)
- HB 1152 (Deferred from 18th LD) provide financial assistance for school sentinel training. (Introduced)
- HB 1173 (Deferred from 18th LD) prohibit a school board from denying an application for open enrollment from certain students with autism. (Introduced)
- HB 1129 authorize the provision of telecommunications device location information to law enforcement agencies. (House State Affairs Engrossed)
- HB 1107 define style and form and authorize the code counsel to make certain style and form edits to legislative acts. (House Judiciary Engrossed)
- HB 1157 provide for kindergarten enrollment options. (House Education Engrossed)
- HB 1159 revise provisions regarding the referral of opt outs made by school districts. (Introduced)
- HB 1036 revise provisions regarding the issuance of certain military specialty plates. (Introduced)
- HB 1069 authorize certain veterans to attend courses offered at postsecondary technical institutes without payment of tuition. (Introduced)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 50 revise certain provisions regarding the practice of a certified registered nurse anesthetist. (Senate Engrossed)
