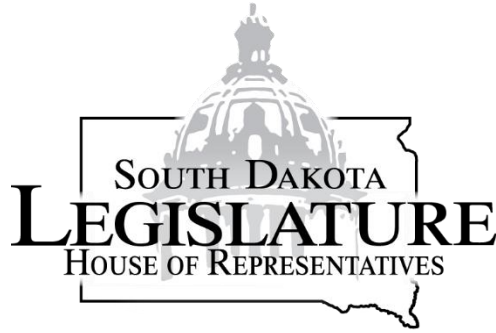

- HCR 6012 (Deferred from 19th LD) Supporting the right to pray in public schools.
(Introduced)
- SCR 604 Recognizing June as Move Over Awareness Month and urging drivers to slow down and move over for stopped vehicles. (Introduced)

SECOND READING OF CONSENT CALENDAR ITEMS

- HB 1165 revise provisions regarding the acceptance of gifts by municipalities.
(House Local Government Engrossed)
- HB 1009 revise provisions regarding failure to comply with outpatient commitment or treatment orders. (Introduced)
- HB 1011 require certain examinations of persons awaiting involuntary commitment hearings. (Introduced)
- SB 62 revise the membership and responsibilities of the South Dakota Board on Geographic Names. (Introduced)
- SB 8 revise certain provisions regarding insurance holding companies. (Introduced)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1014 (Removed from Consent Calendar) place certain substances on the controlled substances schedule and to declare an emergency. (Introduced)
- HB 1173 (Deferred from 19th LD) prohibit a school board from denying an application for open enrollment from certain students with autism.
(House Education Engrossed)
- HB 1036 (Deferred from 19th LD) revise provisions regarding the issuance of certain military specialty plates. (Introduced)
- HB 1159 (Deferred from 19th LD) revise provisions regarding the referral of opt outs made by school districts. (Introduced)

- HB 1069 (Deferred from 19th LD) authorize certain veterans to attend courses offered at postsecondary technical institutes without payment of tuition. (Introduced)
- HB 1079 authorize a county to assess an administration fee for the processing of certain title applications. (House Transportation Engrossed)
- HB 1112 authorize the hiring of law enforcement officers by the South Dakota State Brand Board and to declare an emergency.
(House Agriculture and Natural Resources Engrossed)
- HB 1117 repeal and revise certain provisions regarding riot, to establish the crime of incitement to riot, and to revise provisions regarding civil liability for riot and riot boosting. (Introduced) (PJPCE)
- HB 1104 limit the scope of medical information that may be required as a condition of participation in sanctioned activities. (Introduced)
- HB 1174 establish the date of kindergarten enrollment eligibility. (Introduced)
- HB 1103 authorize the forensic medical examination of certain minor victims without parental or guardian consent. (Introduced)
- HB 1109 revise the Uniform Limited Liability Company Act. (Introduced)
- HB 1205 revise provisions regarding a custodial parent relocating a minor child.
(Introduced)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 28 (Deferred from 18th LD) repeal provisions regarding the restricted real estate broker's license for auctioneers. (Introduced)
- SB 54 regulate the use of auxiliary containers.
(Senate Commerce and Energy Engrossed)
