- HCR 6012 (Deferred from 20th LD) Supporting the right to pray in public schools. (Introduced)
- SCR 604 (Deferred from 20th LD) Recognizing June as Move Over Awareness Month and urging drivers to slow down and move over for stopped vehicles. (Introduced)
- SB 54 (Intent to Reconsider Vote by Which Lost) regulate the use of auxiliary containers. (Senate Commerce and Energy Engrossed)

- HB 1181 revise certain provisions regarding bounties for coyotes. (Introduced)

- SB 32 revise certain provisions regarding the administration of certain family and surviving spouse benefits of the South Dakota Retirement System. (Introduced) (Fiscal Note)
- SB 34 establish a qualified benefit preservation arrangement for eligible members of the South Dakota Retirement System. (Introduced) (Fiscal Note)

- HB 1153 (Deferred from 19th LD) authorize the limited possession of a knife in the state capitol. (Introduced)
- HB 1152 (Deferred from 19th LD) provide financial assistance for school sentinel training. (Introduced)
- HB 1036 (Deferred from 20th LD) revise provisions regarding the issuance of certain military specialty plates. (Introduced)
- HB 1069 (Deferred from 20th LD) authorize certain veterans to attend courses offered at postsecondary technical institutes without payment of tuition. (Introduced)

- HB 1079 (Deferred from 20th LD) authorize a county to assess an administration fee for the processing of certain title applications. (House Transportation Engrossed)
- HB 1112 (Deferred from 20th LD) authorize the hiring of law enforcement officers by the South Dakota State Brand Board and to declare an emergency. (House Agriculture and Natural Resources Engrossed)
- HB 1117 (Deferred from 20th LD) repeal and revise certain provisions regarding riot, to establish the crime of incitement to riot, and to revise provisions regarding civil liability for riot and riot boosting. (Introduced) (PJPCE)
- HB 1174 (Deferred from 20th LD) establish the date of kindergarten enrollment eligibility. (Introduced)
- HB 1103 (Deferred from 20th LD) authorize the forensic medical examination of certain minor victims without parental or guardian consent. (Introduced)
- HB 1109 (Deferred from 20th LD) revise the Uniform Limited Liability Company Act. (Introduced)
- HB 1205 (Deferred from 20th LD) revise provisions regarding a custodial parent relocating a minor child. (Introduced)
- HB 1073 authorize special event alcohol licenses for full-service restaurant licensees. (House Commerce and Energy Engrossed)
- HB 1123 provide for the termination of a lease by a victim of alleged domestic abuse. (House Judiciary Engrossed)
- HB 1257 revise certain provisions regarding hunting, fishing, or trapping on private property without permission. (Introduced)
- HB 1090 make an appropriation to evaluate the feasibility of the use of telehealth services within the criminal justice system and to declare an emergency. (Introduced)
- HB 1170 revise provisions regarding the use of certain lights by tow truck vehicles. (Introduced)

- SB 28 (Deferred from 20th LD) repeal provisions regarding the restricted real estate broker's license for auctioneers. (Introduced)
- SB 9 repeal the Department of Labor and Regulation's retirement plan and to transfer plan members and funds to the South Dakota Retirement System. (Introduced) (Fiscal Note)
