20 receive up to ninety percent of the revenue she is entitled to receive under this section for a period
21 of up to one year through a contract otherwise permitted by law. A contract authorized by this
22 section may not be automatically renewed and may be unconditionally rescinded at any time within
23 ninety days of the creation of the obscene material that is the subject of the contract."

24 On page 1, line 16, of the House Education bill, after "writing." delete "Notwithstanding any
25 other provision in this section, a counselor, school psychologist, and social worker shall disclose to
26 a custodial parent or legal guardian of a student who is an unemancipated minor any information or
27 communication exchanged privately between the student and the counselor, school psychologist, or
28 social worker, unless the counselor, school psychologist, or social worker has reason to suspect the
29 student may have been subjected or exposed to child abuse, neglect, or other illegal conduct by
30 that parent or legal guardian. A custodial parent or legal guardian to whom a counselor, school
31 psychologist, or social worker must disclose under this section may opt-out of the disclosure in
32 writing on a form to be provided by the school."
